## H.B. 1444 RELATING TO MOTOR VEHICLE SAFETY INSPECTIONS

#### House Committee on Transportation

The Hawaii Department of Transportation (HDOT) **opposes** H.B. 1444, which lengthens the time period in which certain vehicles must have a safety inspection.

The HDOT opposes this bill as our Periodic Motor Vehicle Inspection for the number of vehicles that failed show that even newer vehicles, 2 years old, had a failure rate averaging 15 percent (see below table for additional years). This demonstrates the need to have safety inspections annually, they prevent equipment failure that may result in a crash, or stalled vehicles that may cause delays for roadway users. Every minute that a lane remains blocked during peak travel times results in 4 minutes of delay, during and even well after the lane is cleared.

Additionally, lengthening the duration between odometer readings and lengthening the time period when the first odometer reading is taken would create difficulties in implementing the per-mile Road Usage Charge (RUC) program in Hawaii which is now tied to the annual safety check.

ACT 222 established a RUC beginning with electric vehicles with the eventual inclusion of all passenger vehicles and light duty trucks. To calculate the RUC, the mileage traveled for this RUC program will be collected by the odometer readings taken under the existing annual safety inspection process. At the time of payment, the mileage accumulated, and the cost of the driver's RUC will be much greater on a 24 months or 3 year cycle rather than the existing annual payment cycle.

If time between inspections were extended, the public will be required to pay on estimated charges every other year, or we would need to adjust to either electronic tracking or self-reporting requirements. Both would increase the cost of collection for the program.

Therefore, we recommend that the inspection periods remain unchanged from the current time periods and durations.

SUBJECT: H.B. No. 1444 - Relating To Motor Vehicles HEARING: Thursday, February 13, 2025, 10:00 a.m.

The City and County of Honolulu, Department of Customer Services (CSD), Division of Motor Vehicle Registration (DMV), respectfully offers the following comments to H.B. No. 1444, which would require motor vehicle safety inspections to be conducted every two years rather than annually.

Hawai'i does not have a statewide Department of Motor Vehicles. Pursuant to Section 6-402 of the Revised Charter of the City and County of Honolulu, CSD DMV administers the motor vehicle registration program for the island of Oʻahu.

Under existing regulations, all vehicles in Hawai'i are required to have a valid Registration, Certificate of Title, and State of Hawai'i Safety Inspection Certificate. A valid safety inspection is mandatory for annual vehicle registration renewals. Vehicle owners must present a current safety inspection certificate to complete the registration renewal process.

CSD DMV appreciates the opportunity to express our concerns regarding the potential impacts of H.B. No. 1444 on our operations for your committee's consideration:

- Implementation Timeline: CSD DMV will require a reasonable and adequate amount of time to properly implement the proposed legislation. We have significant concerns regarding the proposed legislation taking effect upon its approval.
- Administrative and Technical Adjustments: Changes to the safety inspection requirements would necessitate updates to CSD DMV administrative processes, including modifications to forms, databases and pertinent information technology systems, staff training and public communication materials. CSD DMV requires additional time to research and assess implementation requirements.
- 3. **Public Communication**: Clear and timely communication to the public regarding any changes to the safety inspection requirements will be essential to ensure compliance and avoid confusion.
- 4. **Coordination with Inspection Stations**: CSD DMV will be required to collaborate closely with authorized inspection stations to align procedures and ensure proper implementation of any new requirements.
- 5. **Amending Existing Contracts**: The Department of Transportation would be required to review and potentially amend its contract with vendors that currently provide technology (e.g., hardware, software) and materials (e.g., emblems, forms) for the Safety Inspection program.

CSD DMV acknowledges the intent of H.B. No. 1444 and is prepared to adapt our processes and systems accordingly. CSD DMV emphasizes the importance of maintaining clear communication with the public and relevant stakeholders to ensure a seamless transition and continued compliance with vehicle registration requirements.

When establishing implementation requirements and setting an effective date, CSD DMV respectfully requests the Committee consider the operational impacts to CSD DMV outlined above.

Additionally, the proposed legislation may have unintended consequences on State and county road usage charge programs. The Hawaii Road Usage Charge (HiRUC) program begins on July 1, 2025 for all drivers of electric vehicles (EVs). On their first registration notice sent after July 1, 2025, EV drivers will be given a choice of paying a flat road usage charge (RUC) of \$50 or a per-mile RUC, calculated based on

the number of miles driven **between vehicle safety inspections**. This choice will be permitted until June 30, 2028, at which time all EVs will pay a per-mile state RUC. There is also proposed legislation (H.B. No. 1161 and S.B. No. 1480) which authorizes counties to establish a county mileage-based RUC for EVs beginning July 1, 2028. Therefore, requiring motor vehicle safety inspections to be conducted every two years rather than annually will impact the ability of the HiRUC program and any future county RUC programs to calculate a per-mile RUC based on the number of miles driven between vehicle safety inspections on an annual basis.
