HB 213, Relating to State Licensed Care Facilities

The Healthcare Association of Hawaii (HAH), established in 1939, serves as the leading voice of healthcare on behalf of 170 member organizations who represent almost every aspect of the healthcare continuum in Hawaii. Members include acute care hospitals, skilled nursing facilities, home health agencies, hospices, and assisted living facilities. In addition to providing access to appropriate, affordable, high-quality care to all of Hawaii's residents, our members contribute significantly to Hawaii's economy by employing more than 30,000 people statewide.

We would like to thank the committee for the opportunity to provide **comments** on this measure, which seeks to require the Office of Health Care Assurance (OHCA) to maintain a searchable, online list of all state-licensed care facilities to provide information on licensing details, inspection dates, and any other information deemed to be appropriate. Further, the measure would require these lists to be updated within five days of any changes made to any of the relevant information.

Ensuring that patients and their loved ones have information regarding services—especially for decisions as important as long-term care—is of utmost importance. Our member facilities take licensing surveys extremely seriously and understand that information regarding those surveys and any relevant quality metrics are made public on both state and federal sites. A concern with this measure, however, is the need to post this information within five days. Facilities are provided time to dispute any citations in a survey and may appeal any findings. Posting reports with findings that are eventually removed could create confusion for consumers and also add to OHCA's burden of constantly updating their website to reflect the most recent information available.

We appreciate the legislature's commitment to transparency and high-quality care for all residents, and for the opportunity to provide comments on this measure.
