SUBJECT: HB322 Relating to Voter Registration

The Hawai'i State Council on Developmental Disabilities **strongly supports HB322**, which requires the Department of Human Services to automatically transmit voter registration information for any Med-Quest applicant. Authorizes state agencies to implement automatic voter registration if designated by the Office of Elections. Requires eligible applicants for instruction permits, provisional licenses, driver's licenses, and identification cards to be automatically registered or preregistered to vote unless the applicant opts out.

This bill addresses critical barriers faced by many in our community, including individuals with developmental disabilities, in accessing voter registration. By expanding automatic registration, HB322 ensures eligible residents are automatically registered to vote through interactions with state agencies like the Department of Human Services (DHS) and the Department of Transportation (DOT). This approach provides a more inclusive, accessible, and efficient path to voter registration while preserving individuals' right to opt-out.

The Council specifically appreciates page 2 subsection (b), which requires DHS to automatically transmit voter registration information for eligible Med-QUEST applicants, ensuring that underserved populations are not overlooked. For people with developmental disabilities, administrative barriers and lack of accessible opportunities often hinder their participation in elections. HB322 takes significant strides to overcome these challenges by integrating voter registration with routine government services, providing a seamless experience that empowers marginalized communities.

#### SUBJECT: HB 322 – RELATING TO VOTER REGISTRATION.

**DEPARTMENT'S POSITION**: The Department of Human Services (DHS) appreciates the bill's intent and offers comments.

**PURPOSE:** Requires the Department of Human Services to automatically transmit voter registration information for any Med-QUEST applicant. Authorizes state agencies to implement automatic voter registration if designated by the Office of Elections. Requires eligible applicants for instruction permits, provisional licenses, driver's licenses, and identification cards to be automatically registered or preregistered to vote unless the applicant opts out.

Currently, the application for Med-QUEST's Medicaid health care coverage is accompanied by a voter registration form. If a Medicaid applicant chooses to complete the voter registration form, Med-QUEST transmits the voter registration form to the State Office of Elections. This bill proposes that DHS automatically electronically transmit voter registration information for any Med-QUEST applicant that is of voting age, is a Hawaii resident, and has verified being a US citizen per the Med-QUEST application process. Instead of transmitting the

TRISTA SPEER DEPUTY DIRECTOR KA HOPE LUNA HO'OKELE data to the State Office of Elections, the bill requires that the electronic transmission will go to the clerk of the county in which the applicant resides.

The data to be transmitted is set forth in section 11-15.7(b), Hawaii Revised Statutes (HRS), that directs the examiner of drivers to submit the following: 1) the applicant's name; 2) the applicant's date of birth; 3) the instruction permit, provisional license, driver's license, or state identification number of the applicant; 4) the applicant's residence address and mailing address, if different from the residence address; 5) the applicant's county of residence; 6) the applicant's citizenship status; 7) the applicant's signature as a digitized image; 8) the last four digits of the applicant's social security number, if available; 9) the applicant's telephone number, if available; and 10) the applicant's electronic mail address, if available.

DHS appreciates the intent to strengthen the state's automatic voter registration process, and there is some research that supports using such processes to boost enrollment. However, Med-QUEST's application for Medicaid health coverage does not collect all of the information the bill requires to transmit. We note that Med-QUEST is mandated to use available data sources to confirm eligibility, including citizenship. We do not collect IDs or other verification documents unless our initial matching with data sources reveals a mismatch of information provided. Thus, we would not collect driver's license or state identification numbers.

Further, we may not have the applicant's digitized signature if the applicant applies over the phone, instead we capture a voice signature. Additionally, even if Med-QUEST were able to transmit the information, DHS would need to make significant information system modifications in order to transmit the relevant information on applicants to the listed receiving entities (county clerks). DHS can provide estimated costs of those modifications should this bill move forward.

Chair Marten, Vice Chair Olds, and Committee Members:

**The League of Women Voters of Hawaii strongly supports the intent of HB 322** that would require the Department of Human Services to automatically transmit voter registration information to election officials for any Med-Quest applicant.

We agree with the basic premise of this bill - that it is important to expand our State's 2021 Automatic Voter Registration law, as indications are we still have many voter-eligible but unregistered people.<sup>1</sup>

Though MedQuest is a target agency in this measure, the bill proposes permitting the Office of Elections to designate and implement automatic voter registration in other state agencies. As an alternative to this provision, we suggest amending this bill to designate the Department of Human Services and the Hawaii State Department of Health as voter registration agencies. To avoid confusion, it is a good idea to specifically designate participating agencies by law.

Since 2021, we have observed that though the technology for automatic voter registration can be set in place by public officials, this must be done very carefully, attending to the individual's needs and those of the participating State agencies and four County Clerks. Adding only two key agencies would make coordination among the newly designated agencies, the State and County Elections officials, more feasible.

Our understanding is that under the Under the National Voter Registration Act (NVRA) of 1993, certain state agencies are already mandated to offer voter registration services, including agencies that offer public assistance or administer food assistance and

Medicaid (like our Department of Human Resources) as well as offices that provide state-funded programs engaged in services for people with disabilities (like our Department of Health).

The existing Hawaii Act 26, Automatic Voter Registration, is an "opt-in" arrangement that requires the Department of Transportation to affirmatively ask individuals whether they would like to register to vote. This explicitly gives the person the choice to opt into voter registration. We suggest HB 322 be amended to provide this process instead of an "opt out" process, thereby making it consistent with the Department of Transportation approach and what is generally mandated under the National Voter Registration Act.<sup>2</sup> More importantly, this should mitigate concerns expressed in testimony by the Department of Human Services that on "opt out" arrangement might delay the issuance of benefits

The State Department of Transportation has already successfully established an automatic voter registration program in its core operation. While the Department collects relevant voting data, this does not include a determination of citizenship eligibility, which we think should continue to be left to County clerks. We suggest amending this measure to make clear this clear.

We support a modest appropriation to implement an expanded automatic voter registration program and defer to State and County officials, particularly our County Clerks, for a recommended amount.

We are thankful other worthy measures about voter registration have been introduced in this session, (such SB 81 and SB 78), so some consolidation with HB 322 may be possible.

Dear Chair Martin, Vice Chair Olds, and Members of the Committee,

HAPA is submitting testimony in STRONG Support of HB322, which requires the Department of Human Services to automatically transmit voter registration information for any Med-Quest applicant. It would also authorize state agencies to implement automatic voter registration if designated by the Office of Elections. Additionally, it requires eligible applicants for instruction permits, provisional licenses, driver's licenses, and identification cards to be automatically registered or preregistered to vote unless the applicant opts out.

Recent data shows that turnout increases when voting and registering are more convenient. For example, in the 2020 general election, Hawai'i saw a dramatic increase in voter participation, with almost 70% of registered voters casting ballots. This jump could be largely attributed to the state's first all-mail election, which made voting more accessible and convenient for everyone.

Despite the significant increase in voter turnout during the 2020 general election, recent trends in the past few elections indicate a concerning decline in engagement. In the 2024 primary election, voter turnout plummeted to just about 32%. This sharp drop highlights a troubling inconsistency in civic participation, suggesting that even with improvements like the all-mail voting system that proved effective in 2020, many residents still struggle to register and engage in the electoral process since then. This tells us that we need to make a continuous effort to make registration and voting procedures as accessible and convenient as possible. States like Oregon saw a large increase in voter registration when they used a similar "opt-out" system, as highlighted in the bill.

Therefore, this bill makes voting more accessible by simplifying the registration process. Automatically registering eligible applicants removes obstacles that can prevent people from voting. Automatic voter registration also reduces mistakes in our voter rolls. Under a secure data system, officials share information directly with election clerks. This process can improve accuracy and save money on printing and mailing. It also lowers the risk of sending forms to the wrong addresses or allowing duplicates.

We urge you to support the passage of HB322 to improve voter participation in our state!

# HOUSE BILL 322, RELATING TO VOTER REGISTRATION

JANUARY 30, 2025 · HSH HEARING

**POSITION:** Support.

**RATIONALE:** The Democratic Party of Hawai'i Education Caucus <u>supports</u> HB 322, relating to voter registration, which requires the Department of Human Services to automatically transmit voter registration information for any Med-Quest applicant; authorizes state agencies to implement automatic voter registration if designated by the Office of Elections; and requires eligible applicants for instruction permits, provisional licenses, driver's licenses, and identification cards to be automatically registered or preregistered to vote unless the applicant opts out.

Our democracy belongs to we, the people. At a time when our nation is experiencing extreme political turmoil and basic civil liberties-including the right to vote-are under assault, we must take steps in Hawai'i to safeguard democratic participation. Every eligible person should be able to register to vote in a convenient and secure way that is beneficial to new voters and administrators alike. Key voter registration improvements can elevate electoral confidence, save public funds, and preserve the voice of our community in determining the course of our society's future.

In 2021, Hawai'i established automatic voter registration to increase the state's historically low voter participation rates. Yet, the automatic voter registration system established by the legislature was an opt-in system that places responsibility for registration on individual voters, thereby failing to fully include the total potential population of new voters. This undermines the full

impact of our automatic voter registration program, which is desperately needed to curb low voter participation rates. In the 2024 primary election, for example, our state experienced its lowest turnout in 65 years, with only 32.1 percent of registered voters filling out a ballot.

To improve those statistics, we must enact measures that strengthen the right to vote. HB 322 will make registration more efficient by empowering applications at public-facing state agencies– such as for Med-Quest licenses, permits, change of address forms, recertifications, or services offered by the state–to serve as "dual-purpose" voter registration applications, with the applicant being given the option to affirmatively declines (rather than being forced to affirmatively opt-in) to voter registration or preregistration.

This will change our automatic voter registration system from an "opt in" to an "opt out" model, which will guarantee that the intent of the program–to maximize democratic participation by making voter registration as "automatic" as possible–is fully effectuated, especially in light of other forward-thinking electoral programs that the state has undertaken, like mail-in voting.

Women, racial minorities, and members of the working class fought for years to obtain the right to vote. Sadly, we are seeing draconian efforts today to roll back those rights to entrench the power of autocratic regimes. We cannot allow these authoritarian actions to go unchallenged. We have a responsibility to fortify the voting franchise for generations to come.

### I STRONGLY OPPOSE HB-322.

Any department within the State is woefully incapable of determining the eligibility and required supporting documentation to register anyone to vote. Our voting rolls are already full of potentially ineligible voters and this action could put even more ineligible voters on our rolls.

Last year you approved the Office of Elections to enter into agreement with the non-profit third party organization Electronic Registration Information Center (Act 190), which is supposed to identify individuals who appear to be eligible to vote but who are not yet registered. The cost is \$125,000+ annually.

There is no legitimate reason for this bill. Our State and County Election Offices already have sufficient ways for registering voters, to include registering voters applying for or renewing driver's licenses.

Respectfully, I STRONGLY encourage you to vote NO on HB-322.
