Chair Tarnas and Members of the Committee:

The Department of the Attorney General offers the following comments.

This bill establishes the Office of Gun Violence Prevention (OGVP) within the Department of Law Enforcement to conduct community outreach on gun violence, develop and administer a grant program for gun violence prevention, and develop and administer a gun violence resource bank. The bill also makes an appropriation to establish the new office.

The bill requires the OGVP to award grants to organizations to conduct community-based gun violence intervention initiatives. However, the bill does not appear to contain legally sufficient standards for awarding gun violence prevention grants of public money as required by article VII, section 4, of the Hawai'i Constitution---"[n]o grant of public money . . . shall be made except pursuant to standards provided by law." Therefore, we recommend amending this bill to insert appropriate standards. Examples of existing statutes that provide standards for agencies to award grants are part II of chapter 9 and sections 10-17, 210D-11, and 383-128, HRS.

We have attached draft standards to this testimony as examples for the Committee's consideration. These or other appropriate standards could be inserted into the bill on page 4, line 11, as a new subsection -3(c).

Additionally, there appear to be overlapping responsibilities with the proposed OGVP and the existing Gun Violence and Violent Crimes Commission (GVVCC), codified under chapter 134C, HRS.

GVVCC is tasked with identifying criminal data that could be used to reduce gun violence and violent crimes and to maximize the sharing of that data between criminal justice agencies. GVVCC's membership includes individuals with expertise in research from different public sectors including the Judiciary. Examples of overlapping responsibilities are:

(1) Data Identification and Collection:

- **GVVCC:** Identify relevant data that may be used to reduce gun violence and violent crimes.
- **OGVP:** Collect relevant data to support efforts in reducing gun violence.

(2) Identification of Data Gaps:

GVVCC: Identify areas where relevant data is unavailable. **OGVP:** Identify gaps in available data.

(3) Data Sharing:

- **GVVCC:** Maximize data sharing among represented agencies and stakeholders.
- **OGVP:** Facilitate data sharing among law enforcement, researchers, and the public.

(4) Research:

GVVCC: Conduct research on gun violence and violent crimes.

OGVP: Support researchers in analyzing data and improving data collection methods.

To avoid overlapping responsibilities that may cause confusion and duplication of efforts, we recommend the Committee consider amending this bill to first consolidate GVVCC's responsibilities into the new office, and then repeal chapter 134C, HRS. Consolidating GVVCC's responsibilities into the new office will better accomplish the objectives of this bill by: (1) centralizing data collection to support efforts in reducing gun violence; (2) improving collection and facilitating data sharing among law enforcement, researchers, and the public; and (3) making government more efficient by reducing duplicative meetings that public servants attend.

We are available to work with the Committee on any potential amendments to the bill. Thank you for the opportunity to testify on this bill.

DRAFT GRANT STANDARDS

(c) Applications for grants shall be made to the office of gun violence prevention and contain the information required by rules. At a minimum, the applicant shall:

- (1) Agree to use state funds exclusively for the purposes of this program;
- Indicate capability to properly use the grant for the purpose of the gun violence prevention program;
- (3) Comply with all applicable federal and state laws prohibiting discrimination against any person on the basis of race, color, national origin, religion, creed, sex, age, sexual orientation, disability, or any other characteristic protected under applicable federal or state law;
- (4) Agree not to use state funds for entertainment or perquisites;
- (5) Comply with all applicable federal, state, and county statutes, rules, and ordinances;
- (6) Agree to indemnify and save harmless the State of Hawaii and its officers, agents, and employees from and against any and all claims arising out of or resulting from activities carried out or projects undertaken with grant funds and procure sufficient insurance to provide this indemnification if requested by the office;
- (7) Agree to make available to the office all records the applicant may have relating to the grant, to allow state agencies to monitor the applicant's compliance with this section; and
- (8) Comply with other requirements the office may prescribe.

RELATING TO GUN VIOLENCE PREVENTION

The Department of Budget and Finance (B&F) offers comments on this bill.

House Bill (H.B.) No. 664:

- Establishes the Office of Gun Violence Prevention (OGVP) within the Department of Law Enforcement, for administrative purposes only.
- Requires the OGVP to: 1) conduct public awareness campaigns in a culturally appropriate manner to educate Hawai'i residents about State and federal laws and existing resources relating to gun violence prevention (GVP); and 2) develop a plan to address gun violence in Hawai'i and coordinate, improve, and expand upon existing plans for GVP.
- Establishes a GVP grant program to be developed and administered by the OGVP to conduct community-based gun violence intervention initiatives.
- Establishes a GVP Special Fund (GVPSF) to be administered by the OGVP which will be funded by grants, donations, and appropriations made by the Legislature.

- Requires the OGVP to create and maintain a resource bank of regularly updated and accurate materials and resources as a repository for data, research, and statistical information regarding gun violence in the State.
- Requires the OGVP to submit a report to the Legislature containing a summary of its activities during the preceding year.
- Appropriates an unspecified amount of general funds in FY 26 and FY 27 to be deposited into the GVPSF.
- Appropriates an unspecified amount of special funds in FY 26 and FY 27 from the GVPSF for grants to organizations to conduct community-based gun violence initiatives.
- Appropriates an unspecified amount of general funds in FY 26 and FY 27 for the establishment of a gun violence resource bank, including the hiring of personnel.

As a matter of general policy, B&F does not support the creation of any special fund, which does not meet the requirements of Section 37-52.3, HRS. Special funds should: 1) serve a need as demonstrated by the purpose, scope of work, and an explanation why the program cannot be implemented successfully under the general fund appropriation process; 2) reflect a clear nexus between the benefits sought and charges made upon the users or beneficiaries or a clear link between the program and the sources of revenue; 3) provide an appropriate means of financing for the program or activity; and 4) demonstrate the capacity to be financially self-sustaining. Regarding H.B. No. 664, it is difficult to determine if the GVPSF would be self-sustaining.

Chair Tarnas, Vice Chair Poepoe, and members of the Committee:

The Department of Law Enforcement (DLE) strongly supports House Bill 664, which establishes the Office of Gun Violence Prevention within the DLE. This bill creates a dedicated office to develop and implement comprehensive strategies for reducing gun violence in Hawaii through evidence-based approaches, community outreach, and grant administration. The establishment of this office will significantly enhance the DLE's capacity to address gun violence through preventive measures and community-based solutions.

The Office of Gun Violence Prevention will serve as a central hub for coordinating prevention efforts, administering grants to community organizations, and maintaining a resource bank of evidence-based practices. This comprehensive approach aligns with modern law enforcement strategies that emphasize prevention and community partnership alongside traditional enforcement methods.

The creation of the Gun Violence Prevention Special Fund will provide sustained funding for these critical initiatives through various sources, including grants, donations, and legislative appropriations. This dedicated funding stream is essential for the longterm success of gun violence prevention efforts in Hawaii.

The DLE particularly supports the bill's emphasis on culturally appropriate awareness programs and evidence-informed intervention strategies. These elements are crucial for effective engagement with Hawaii's diverse communities and ensuring that prevention efforts are both culturally sensitive and scientifically sound.

DLE would like to recommend the following amendments:

1. On page 1, amending lines 11-13 to read:

(a) There is established within the department of law enforcement, for administrative purposes only, an office of gun violence prevention.

Instead of being administratively attached to DLE, this program would best be positioned under the Office of Homeland Security, who already does work in the grant and targeted violence fields.

Regarding the appropriation, DLE would like to recommend 8.0 FTEs and **\$1,044,926** in FY26 and FY27 to staff and operate the Office of Gun Violence Prevention.

Dear Chair Tarnas, Vice-Chair Poepoe and Distinguished Members of the House Committee Judiciary and Hawai'ian Affairs,

Founded in 1974, Brady works across Congress, courts, and communities, uniting gun owners and non-gun owners alike, to take action, not sides, and end America's gun violence epidemic. Brady today carries the name of Jim Brady, who was shot and severely injured in the assassination attempt on President Ronald Reagan. Jim and his wife, Sarah led the fight to pass federal legislation requiring background checks for gun sales. Brady continues to uphold Jim and Sarah's legacy by uniting Americans from coast to coast, red and blue, young and old, liberal and conservative, to combat the epidemic of gun violence. In furtherance of our goal to reduce firearm violence across Hawai'i, the Brady Campaign to Prevent Gun Violence is proud to support the passage of SB HB 664.

Hawai'i leaders have persisted in prioritizing the safety and well-being of the people of Hawai'i by enacting and implementing proactive, research-informed policy solutions that prevent gun violence, save lives, and spare entire communities from loss, trauma and cycles of violence. However, the latest data from the Centers for Disease Control and Prevention shows that 56 people in Hawai'i are killed by gun violence each year, over 50% of whom die by firearm suicide.¹ This number does not include those who are shot and survive with life-altering physical and mental injuries, nor does it account for survivors and families left with grief, expensive lifelong care, trauma, or many other consequences of gun violence.

One firearm death is too many, and these numbers demonstrate that there remains more work to be done to ensure the safety of Hawai'ian residents and visitors.

It is imperative that we start treating gun violence as a public health epidemic, because it is. By prioritizing research and programs that are tailored towards addressing the root causes of gun violence, this legislature has the chance to disrupt cycles of violence and create safer, healthier communities for all citizens of Hawai'i.

The proposed Office of Gun Violence Prevention would serve as a vital first step towards expanding access to funding for the state to address various forms of gun violence, including suicides, mass shootings, and surges in other forms of gun violence. The Office's focus on data collection will empower future State Legislatures to continue to lead in this space, by introducing and implementing violence reduction policies that are backed by data. HB 664 would enable the Office of Gun Violence Prevention to conduct public awareness campaigns on important subjects including, but not limited to, safe and responsible ownership, lost and stolen reporting requirements, and the safe storage of firearms. In addition, the office would administer a grant program for community-based gun violence intervention initiatives to interrupt the cycle of gun violence without additions to mass incarceration. Lastly, more resources would be provided to create a resource database on gun violence in Hawai'i and the formulation of a plan to address gun violence throughout the state. The resource bank would partner with organizations to identify gaps in available data, enhance gun violence prevention tools, and improve understanding of the barriers to safety.

Conclusion

This Office would be a vital resource for coordinating efforts between federal, state, and local agencies, facilitating data collection and research, and developing best practices for community violence intervention programs.

For these reasons, Brady urges the House Committee Judiciary and Hawai'ian Affairs to vote YES on HB 664.

My name is Agustin Cabrera and I am a State Legislative Manager with Giffords, the gun violence prevention organization founded by former Congresswoman Gabby Giffords. I write to you today in support of HB 664, a bill that would establish an office of gun violence prevention to conduct community outreach, develop a grant program for gun violence prevention efforts, and develop a resource bank on gun violence in the state.

Sixteen states have state offices of gun violence prevention. These offices are structured specifically to address gun violence and community violence and allow for a more direct approach to learning more about and addressing sources of gun violence in the state.

Creating an office of gun violence prevention allows for a fuller and more long term gun violence prevention strategy

HB644 not only creates an office of gun violence prevention, but tasks the new office with a series of responsibilities that would help the state craft community centered, data-driven responses to gun violence prevention in Hawaii. Community violence is increasingly understood as a multi-dimensional crisis that touches on many issue areas, including housing policy, education, employment, mental health, and healthcare. States that are having the most success in addressing this violence are building the infrastructure to direct the efforts of these diverse systems, both across government agencies and through public-private partnerships.

In supporting HB644, Hawaii would be acting in line with what other states have done in creating offices of gun violence prevention. In Colorado, for example, the OGVP is housed under the department of public health and is tasked with creating public information campaigns to educate on safe gun owning and storage practices as well as updates on new laws and requirements; maintains a database of gun violence prevention resources; and submits an annual report to the Colorado Department of Public Health on the status of their work and on gun violence in the state. In partnership with the University of Colorado, they recently published a study highlighting the importance of their ability to collaborate which has allowed them to enhance their gun violence data infrastructure and public-facing access to the data; translate research evidence to practical approaches to solutions; and evaluate state gun violence prevention strategies to inform on potential improvements.¹ Should Hawaii follow and create an

office of violence prevention, the state would only be strengthening its ability to respond and craft solutions for gun violence prevention.

Creating Offices of Gun Violence Prevention is a growing trend among states

Creating Offices of Gun Violence Prevention is a growing trend in the fight against gun violence across the country. In 2024, for example, Governor Wes Moore signed a bill creating the Maryland Center for Firearm Violence Prevention and Intervention within the Department of Health as a way to improve the state's coordinated response to gun violence. In 2023, North Carolina Governor Roy Cooper used an executive order to create the Office of Violence Prevention within the Department of Public Safety, with a mission to "promote local success in violence prevention by enhancing coordination across state agencies, improving data collection and sharing, offering technical assistance to local officials, promoting collaboration and sharing of best practices between localities, and managing grant programs to pursue and direct available federal funding to law enforcement and community-based organizations focused on reducing gun violence." At the beginning of 2025, Wisconsin created the Office of Violence Prevention through an executive action by Governor Tony Evers.

We urge the committee to support HB 684. The office of gun violence prevention that the bill would create will allow the state a greater range of gun violence prevention solutions and create a tool to help research, understand, and educate on the issue of gun violence in Hawaii.

In furtherance of Brady's goal to reduce firearm violence across Hawaii, the Hawaii Chapter of the Brady Campaign to Prevent Gun Violence is proud to offer its strong endorsement of HB 664.

For decades, Hawaii leaders have prioritized the safety and well-being of the people of Hawaii by enacting and implementing proactive, research-informed policy solutions that prevent gun violence, save lives, and spare entire communities from loss, trauma and cycles of violence. However, the data from the Centers for Disease Control and Prevention as of 2024 is disturbing:

- Every year, 34 people in Hawaii die by firearm suicide.
- Every year, 15 people in Hawaii are victims of firearm homicide.
- On average, 55 people in Hawaii are killed by gun violence each year and an average of 30 of those deaths occur in Honolulu County.
- Every 7 days, someone in Hawaii is shot and killed.

Since the US Supreme Court has eased the way for more firearms to be carried in our public places, there has been an increase of gun-related violence in Hawaii. A state office to conduct community outreach on gun violence prevention, develop and administer a grant program for gun violence prevention, and develop and administer a gun violence resource bank is simply one common sense approach to help ease the impact of the Court's decision. Brady Hawaii strongly supports HB 664 and urges the committee to pass this important bill.

Comments:

While I agree with the intent of the bill to help reduce gun violence in the state, I must stand in **OPPOSITION** to this bill as I have great concerns given the State's anti-gun bias that this office will be weaponized with the goal to tweak information to support anti-gun laws.

Recently there have been cases where anti-gun groups have submitted manipulated data to similar offices with the goal of promoting further infringements on the Second Amendment. One includes the often repeated false statement that guns are now the leading cause of death for children. Among other offenses, **the data was manipulated to include people up to the age of 25 as 'children',** included instances of gang on gang violence where the only victims were rival gang members, and included instances of justified police shootings. The mentioned study has been fact checked by several sources and found to be false despite it being touted by the former Presidential Administration. **Simply altering the study to only include persons under the age of 18 debunked the claim that firearms are the leading cause of death in children.**

Another instance resulted in the ending of a popular and successful program that was having positive effects on reducing gun violence. **Giffords Law Center**, who has the stated goal of wanting to reduce gun violence, did a study on a program known as '**Oakland Ceasefire**'. In their findings it was discovered that the program reduced gun violence in Oakland by 50%, and in 9 other cities that had similar programs reduced crime from 30% to 60%. The Oakland Ceasefire program relied upon Community Outreach and Mentorship programs for atrisk youth, as well as enforcement and prosecution of current laws.

Giffords is being accused of trying to hide the study from the public, and of using their influence to end the highly successful program because it undermined the message that the only way to reduce gun violence is to get rid of guns. Even if these accusations are false, the reality is inconsistent with their stated goal as there is little to no fanfare regarding such a successful program.
