The Hawaii Department of Transportation (HDOT) **Support H.B. 667 H.D. 1**, This bill requires the HDOT or appropriate county department when disposing of a deceased cat or dog found on a public roadway to scan the animal for a microchip, record certain information, and report that information to the appropriate county animal control services or animal contractors.

The HDOT recognizes the importance of notifying pet owners and is committed to enhancing our approach to this issue while maintaining our core mission of roadway safety and maintenance. We are currently in the process of obtaining microchip scanners and will collaborate with local humane societies to facilitate pet owner notifications. On behalf of the Hawaiian Humane Society, thank you for considering our strong support for House Bill 667, HD2, which requires the Department of Transportation or appropriate county department when disposing of a deceased cat or dog from a public roadway to scan the animal for a microchip, record certain information, and report that information to the appropriate county animal services or animal service contractors; and requires certain county agencies to collaborate with the Department of Transportation in utilizing the Department's microchip scanners.

This measure codifies the will expressed in the last legislative session by HCR171 / HR150, which was approved by this body. The appropriate agencies have struggled to fulfill the requests made in that resolution and Hawaiian Humane is grateful to the bill sponsor for working with the state Department of Transportation on this measure

Pets are an integral part of many people's lives and not knowing how a pet died or if a lost pet is still alive can be traumatic. State and county agencies responsible for clearing dead animals from roadways do not routinely scan deceased animals for an identifying microchip or take other steps to determine ownership, such as inspecting a tag worn on the animal's collar for a contact phone number or address. With an increase in the number of microchipped dogs and cats, resulting from a state law that required them as of January 1, 2022, scanning for chips would be an effective way to provide closure to worried pet owners. We urge the committee to pass HB 667, HD2, with a good effective date. Mahalo for your consideration.

Every week, we receive calls from heartbroken families searching for their lost pets, hoping for any sign—good or bad—of what happened to them. Many bring deceased animals to us, hoping we can scan for microchip confirmation. This is emotionally devastating— and it is unsafe for ordinary residents to stop on busy roads in order to scoop up an animal's body, and transport it in their vehicle in a desperate search for closure. Most people are not equipped for this, nor should they have to be.

If road crews were required to take just a moment to scan for a microchip and report their findings, more families would receive the closure they need, and fewer people would put themselves in dangerous situations on highways and busy streets. Road crews have the proper warning lights, safety equipment, and training to handle these situations far more safely than the general public. Additionally, knowing that scanning will be done would encourage more residents to report deceased animals for proper identification and disposal.

For many pet owners, not knowing is the most painful part of losing a pet. As one grieving pet owner once said:

"The hardest part of losing them is not knowing if they're gone forever or still out there somewhere, waiting to come home."

Passing HB667 would bring comfort to grieving families, improve public safety, and uphold the humane treatment of animals, even in death. Lucky Paws Animal Foundation urges this committee to pass HB667 without hesitation.

Pets are members of our family. In January 2025, our beloved Chihuahua wandered from home. My family and I immediately began a community search online, and physically searching for our beloved pet. We spent hours searching for her at all hours of the day, desperate to find any sighting of her.

Multiple attempts were made to find closure on whether Kealoha was dead or alive. Calls were placed to the Honolulu Police Department, Department of Transportation, and City and County of Honolulu, hoping she did not match the description of any deceased pet found on our local roads. A week later, additional calls were made to the HPD, and I spoke to HPD officers who identified a close match to Kealoha.

While we cannot know for sure whether the deceased Chihuahua found near our home was Kealoha, I can only conclude this is the case. The question of not knowing is agony, and completely avoidable.

In memory of Kealoha, my family and I humbly ask your support for HB 667. Every family is deserving of closure, and the scanner is a minimal expense in comparison to the emotional toll, and additional efforts to agencies calling for closure.
