Chair Kahaloa and Members of the Committee:

The Department of the Attorney General provides the following comments.

The purpose of this bill is to authorize the issuance of general obligation bonds to the Agribusiness Development Corporation for the purchase of a land parcel in Kaʻū for agricultural development.

This bill does not indicate the owner of the land to be acquired. Accordingly, the authorization to acquire land in this bill does not appear to satisfy section 163D-31(b)(3), Hawaii Revised Statutes (HRS). Therefore, the bill may not provide adequate authority for the Agribusiness Development Corporation to complete the acquisition.

Regarding acquisitions of land by the Agribusiness Development Corporation, section 163D-31(b), HRS, states (emphasis added):

- (b) The acquisition shall be authorized by a bill enacted into law and shall contain:
 - (1) A statement of the value of the interest in land as a resource to the State:
 - (2) A description of the specific parcel of land or agricultural easement proposed to be acquired;
 - (3) The name of the owner of the property; and
 - (4) The estimated costs of acquiring the interest in the land.

To validly authorize the acquisition of this property, we recommend that this bill be amended to name the owner of the land to be acquired.

We respectfully ask the Committee to consider our comments.

HOUSE BILL NO. 685 RELATING TO AGRICULTURAL DEVELOPMENT

Prioritize Diversified Agriculture:

Encourage a mix of crops and farming techniques to enhance resilience, reduce risk, and support Hawai'i's food sovereignty goals.

• Incorporate Value-Added Opportunities:

Promote infrastructure and resources that support value-added agricultural products, such as processing facilities and direct-to-market opportunities.

Provide Support for Small Farmers:

Ensure that small-scale and beginning farmers have access to resources and opportunities associated with this development, fostering inclusivity and equity.

Conclusion

The issuance of general obligation bonds to enable the ADC to acquire land in Ka'ū represents a strategic and forward-thinking investment in Hawai'i's agricultural future. Ka'ū's unique attributes make it an unparalleled asset for agricultural production, and its potential must be harnessed to benefit farmers, communities, and the state as a whole.

I urge you to support this initiative to secure Ka'ū's role as a cornerstone of Hawai'i's agricultural sustainability and food security efforts. We support this bill provided that its passage does not replace or adversely impact priorities indicated in our Executive Budget. Thank you for your consideration and commitment to advancing Hawai'i's agricultural sector.

Aloha Chair Kahaloa, Vice-Chair Kusch, and Members of the Committee:

I am Brian Miyamoto, Executive Director of the Hawai'i Farm Bureau (HFB). Organized since 1948, the HFB is comprised of 1,800 farm family members statewide and serves as Hawai'i's voice of agriculture to protect, advocate, and advance the social, economic, and educational interests of our diverse agricultural community.

The Hawai Farm Bureau supports HB 685, which authorizes the issuance of general obligation bonds to the Agribusiness Development Corporation (ADC) to purchase a land parcel in Ka'ū for agricultural development. While we support the intent of this measure to expand agricultural opportunities for ADC, we encourage ADC to broaden its scope to consider potential land acquisitions in both Maui County and Hawaii Island and to ensure that adequate water resources are available before purchasing any land for agricultural development.

The agricultural industry established the Agribusiness Development Corporation as sugar and pineapple downsized. It was created to help transition Hawaii's agricultural industry from plantation agriculture to smaller, diversified agricultural operations. Over the past decade, ADC has made significant progress in transitioning Hawaii's agricultural sector by managing key state agricultural lands, developing irrigation systems, and supporting diversified agriculture on Oahu and Kauai. Expanding ADC's role to additional lands is a logical next step, but due diligence must be done to ensure successful outcomes.

While Ka'ū offers potential for agricultural development, Maui County and other areas of Hawaii Island also have significant agricultural potential. Purchasing land in Ka'ū is step in the right direction for expanding agricultural opportunities in Hawaii. However, ensuring water access, considering multiple locations, and prioritizing infrastructure development are essential to the success of ADC's expansion.

Thank you for this opportunity to testify in support of this measure.

Aloha to Committee Chair Mrs. Kahaloa, Vice Chair Mr. Kusch, and to all members of the committee.

My name is Ralph Gaston, and I submit this testimony today in support of House bill 685 I want to use a bit of my story here in Hawaii to explain why this bill is important for our community - and for all of Hawai'i.

Growing up in Baltimore, I never imagined I would visit Hawai'i, let alone make a home here. But in 2011, my wife Joan and I made the move to help our mother, Lorie, with the family coffee company.

Rusty's Hawaiian is named for our late father, Rusty Obra, who founded the company in 1999 - and the Ka'u Coffee Growers cooperative in 2003. Papa Rusty's dream was to see Ka'u become well known for its coffee, similar to the status that Kona coffees had achieved.

I think that was a success. But it's what I learned after living in Ka'u that brings me here today.

See, it's one thing to settle in, get into a company, and get to the business of sales - roasting coffee, finding buyers, setting up packaging, distribution, and so on. But that means nothing if we are not truly part of the community.

So for a guy who grew up on the east coast in a big city, that meant joining the Farm Bureau for a few years. Volunteering time to help the Ka'u Coffee Festival, and Hawaii Coffee Association, and also the Synergistic Hawaii Agriculture Council.

Most importantly, it meant meeting my fellow farmers, and coffee growers, and those who have made Pahala home for many decades. It's the community that lives and shares the magic of Ka'u together, all the ups and downs. When we had a big windstorm years ago, and Albizia trees blocked the road up to Cloud's Rest...we all got our gloves and chainsaws, and cleared that road together.

All through the year, we share our bounty together. Maybe its smoked pork from a weekend hunt. Or fresh lilikoi and mango from a backyard tree. Or avocados, or the holiday season when I make pies for all my neighbors. But every interaction, every graduation party or holiday party or just a community gathering, show more and more how special Ka'u is - and how important the saying of the locals really is:

We have to keep Ka'u....Ka'u.

I've been here for almost 14 years now, and I can't imagine leaving Ka'u. I truly enjoy living in one of this state's most beautiful and bountiful areas. And I want to do my part so that those who grew up here, and raised their kids here...I want to help those kids keep their ties to Hawai'i. To have their chance to remain connected to this special land. That is the least I can do for a community that has welcomed my wife and I with open arms.

This is why I think projects like this one, with the ADC, are so important. the Ka'u District is home to very productive farmland, ideal for growing the foods that we need to be more self sustainable as a state here in Hawaii. As we have seen with recent events, disruptions to the food supply can happen suddenly and leave Hawai'i in a tough position. The less Hawai'i has to rely on those container ships to feed our people, the safer we all are.

This is land that produced high quality fruits and vegetables when run by Ellis Hester for over a generation. And it would be ideal again for farmers - local farmers - to have access to these lands to plant the crops that can feed Hawaii for generations to come.

That is why I support House Bill 685.
