### Testimony on H.B. 692 – RELATING TO THE PRESCHOOL OPEN DOORS PROGRAM

Chair San Buenaventura, Vice Chair Aquino, and Members of the Committee:

Thank you for the opportunity to provide testimony in **support of H.B. 692, H.D. 1** which expands the preschool open door program's eligibility criteria to allow more keiki and their ohana to be served by this program.

Access to preschool is a social justice issue in our state and we know that children who attend high-quality preschool are much better prepared for success. H.B. 692, H.D. 1 aligns with our *Ready Keiki* initiative, the Administration's multi-faceted plan to expand access to high-quality childcare and preschool. Our focus is on ensuring that our keiki are ready for Kindergarten and creating economic stability for families returning to the workforce. The success of *Ready Keiki* depends on a multi-pronged approach which includes building and refurbishing classrooms, creating teaching pathways for educators, and expanding the Preschool Open Doors program for local families. The amendments proposed in H.B. 692, H.D. 1 are critical to ensuring we have enough classrooms for all keiki.

**DEPARTMENT'S POSITION**: The Department of Human Services (DHS) supports the bill

and provides comments.

**<u>PURPOSE</u>**: The purpose of this bill is to expand the Preschool Open Doors Program's

eligibility criteria. Repeals the requirement that Preschool Open Doors Program providers be

accredited. Effective 7/1/3000. (HD1).

DHS appreciates the amendments of the Committee on Human Services &

Homelessness as follows:

- 1) Clarifying that the Preschool Open Doors Program shall continuously serve children who are in the three years prior to kindergarten entry until they enter kindergarten;
- 2) Clarifying the types of child care programs that are eligible to participate in the Preschool Open Doors Program;
- Specifying that a parent or guardian of a child enrolled in the Preschool Open Doors Program may share in the costs of the Program through a copayment based on need, rather than an amount of up to one dollar;
- 4) Changing the effective date to July 1, 3000, to encourage further discussion; and
- 5) Making technical, nonsubstantive amendments for the purposes of clarity, consistency, and style.

The Department and the proponents of this bill have discussed to gain a better understanding of the need for inclusion of family child care homes for the Preschool Open Doors program and the Department's concerns with ensuring the child care setting is suitable in preparing children for their eventual entry into kindergarten. The conversations also addressed ensuring that children participating in one Preschool Open Doors program year are given consideration to continue their participation in the subsequent Preschool Open Doors program year, provided they are still eligible. As a result of these discussions, the Department has reviewed the proponent's suggested amendments and agrees with the suggestions.

Executive Office on Early Learning's Position: SUPPORT

The Executive Office on Early Learning (EOEL) offers the following comments in support of H.B. No. 692, H.D. 1 and defers to the Department of Human Services (DHS) regarding implementation and funding.

The Preschool Open Doors program plays a crucial role in helping families afford quality child care. This legislation will expand access to early learning opportunities for Hawai'i's families by expanding eligibility for the Preschool Open Doors program to include 2-year-olds (children three years prior to kindergarten entry) and by repealing the accreditation requirement for program providers.

Community-based early learning providers are vital to a strong, mixed-delivery early learning system, offering families flexibility in choosing care that best meets their needs. Many of these providers also have the capacity to offer full-day and year-round care, which is not offered by most free public prekindergarten programs but is essential for many working families.

Reducing financial barriers to community-based early learning programs also enables more parents and caregivers to participate in the workforce while ensuring their children receive the early childhood development and learning experiences critical to lifelong well-being.

We appreciate the Legislature's continued investment in our youngest keiki and their families. Thank you for the opportunity to share these comments in support of H.B. No. 692, H.D. 1.

Aloha, Honorable Chair San Buenaventura,, Vice-chair Aquino, and members of the Senate Health and Human Services Committee:

The Early Learning Board (ELB) formulates statewide policy relating to early learning, as well as directing the Executive Office on Early Learning (EOEL).

The ELB supports HB 692 HD1, which would allow families with children ages two up to kindergarten entry to apply for Preschool Open Doors (POD) subsidies. This expansion of state subsidies will greatly benefit Hawai'i's working families.

POD subsidies to families support families who need care and education for their child beyond the school day and school year. Consistency and routine help optimize each child's development, and being able to stay in the same program year round, with caring teachers, provides that.

While the Dept. of Human Services will still provide accreditation support, allowing all licensed early learning programs to receive POD funding regardless of accreditation status will help more families access the subsidy.

The Early Learning Board oversees the EOEL, and both ELB and EOEL have a responsibility to coordinate the many systems that make up early learning opportunities in our state. Support of the expansion of POD funding is one of the ways the board can support all children in Hawai'i.

As it stands, the Preschool Open Doors Program (POD) is a vital resource for families with 3- and 4-year old children, offering much-needed financial assistance to make child care more affordable and accessible. By expanding eligibility to include 2-year olds, this bill acknowledges the importance of early childhood development during these formative years and addresses a substantial gap in child care support for families with younger children.

Child care expenses are one of the largest financial burdens for families on O'ahu, with some households paying upwards of 48 percent of their income on child care tuition. Expanding the POD program to include 2-year olds will help alleviate these pressures, allowing families to remain in the workforce, achieve greater economic stability, and provide a strong foundation for their keiki to grow and thrive.

We also strongly support efforts to enhance quality in early learning programs. The Department of Human Services recently established an accreditation program to promote accreditation and other quality improvement measures. Since the POD program is vital in expanding family access to early learning opportunities, we support removing the accreditation requirement in this bill. Other complementary programs are already in place to support quality improvement efforts, ensuring that expanded access is not done at the expense of quality.

Kamehameha Schools <u>supports</u> HB 692, HD1, which expands the eligibility for the Preschool Open Doors (POD) Program making it easier for Hawai'i's families to access early learning opportunities.

The expansion to 2-year-olds will allow all families, including Native Hawaiian families, to access early learning opportunities earlier, essentially giving keiki three years of preschool preparation. Thank you for hearing this bill and for this opportunity to testify in **support** of House Bill 692, HD1.

The International Union of Painters and Allied trades, District Council 50, is an organization that consists of five (5) local unions: the Painters, Local 1971; the Glaziers Architectural and Glass Metal Workers, Local 1889; the Carpet Linoleum and Soft Tile, Local 1926; the Drywall, Tapers Finishers, Local 1944; and the Pearl Harbor Metal Trades Specialty Workers, Local 1941 – in all, approximately two thousand (2000) members statewide.

Our members start work very early in the day and continue to face serious challenges with finding affordable childcare and education. We have members who dropped out of work simply because they had no childcare options available to them.

This bill expands the number of children who will be eligible for the Preschool Open Doors program by lowering the minimum age limit for the program, removing economic restrictions and increasing the number of community-based child-care providers.

The expanded child-care opportunity created by this measure will be a great aid to our members, allowing them to continue their careers in the construction workforce without interruption as well as preparing their children for future success.

# **Re:** Testimony in Strong Support of H.B. No. 692 H.D. 1 – Preschool Open Doors Program Expansion

Aloha e Chair San Buenaventura, Vice Chair Aquino, and esteemed members of the committee,

My name is Johnnetta Jordan-Piper and I am submitting testimony in strong support of H.B. No. 692 H.D. 1. As a family child care provider and early childhood advocate, I have witnessed firsthand the financial struggles that families face in securing early education.

#### The Cost of Childcare is Unsustainable for Many Families

Hawai'i families are being priced out of early childhood education. When I sought care for my then three-year-old granddaughter, I faced a staggering cost of nearly \$2,500 per month—an amount that exceeded what our household could realistically sustain. That equates to **\$30,000 per year**, far surpassing the reported statewide average of **\$14,500 annually for infant care**. The disparity between reported averages and actual costs raises concerns about the accuracy of available data and highlights the severe financial strain families face when seeking high-quality childcare. Had we needed care from birth to age three, the financial burden would have been even greater.

For many families, these costs are simply not feasible, forcing parents to leave the workforce or rely on inconsistent and potentially lower-quality care. Expanding POD to include more families will not only provide relief but also allow more parents to remain in their jobs, strengthening Hawai'i's economy.

#### Hawai'i Must Keep Pace with Other States Investing in Early Childhood Education

Many states have recognized that early investment in childhood education yields long-term benefits. **Washington, D.C.** provides free, full-day preschool for all three- and four-year-olds, leading to one of the highest preschool enrollment rates in the country. **Vermont** ensures universal pre-K access by offering state-funded, part-time preschool to all three- and four-year-

olds. **New York** has expanded access by providing free pre-K statewide for four-year-olds and increasing opportunities for three-year-olds in New York City. **Colorado** recently introduced a universal preschool program that provides 15 hours of free pre-K per week to all children in the year before kindergarten. **New Mexico, Illinois, and Oregon** offer subsidized care for two-year-olds through state-funded initiatives, ensuring that children receive early educational experiences essential for their cognitive and social development.

Hawai'i has the opportunity to take a similar step forward. While the current POD program successfully supports three- and four-year-olds in childcare center settings, expanding eligibility to include two-year-olds and raising income thresholds will provide more children with the developmental foundations they need to succeed. Investing in early education at this critical stage will help reduce disparities in kindergarten readiness and allow families to better balance financial stability with quality care options.

#### Why Families Need Family Child Care Homes

I became a family child care provider because I believe that children thrive in environments where they feel safe, nurtured, and understood. My background includes a **Master's degree in Elementary Education (PreK-8)** and a **second Master's in Infant and Early Childhood Mental Health**, equipping me with the expertise to support early development comprehensively. My passion has always been to provide high-quality, individualized care, especially for children with exceptional needs.

Not every family can, or wants to, place their child in a large center-based program. Some children require smaller settings where they receive consistent, individualized attention. Family child care homes offer a level of flexibility and familiarity that larger programs simply cannot. Parents working nontraditional hours, families who want a caregiver with a deep understanding of child development, and children who need a calmer, lower-stimulation environment all benefit from the unique qualities of family child care. I have always limited the number of children in my care because I believe **caregiver attunement** is critical to children's emotional and cognitive development. When children are seen, heard, and valued in their early years, they are more confident, resilient, and prepared to learn.

Despite the importance of family child care, the current POD program does not fully recognize our contributions. To ensure equitable access to early learning, family child care providers should be included in the POD program and meet one of the following criteria:

- 1. Accreditation through the National Association for Family Child Care (NAFCC) or National Early Childhood Accreditation (NECPA).
- 2. Participation in a partnership program aligned with federal Head Start or state prekindergarten program standards.
- 3. Achievement of a satisfactory score on a nationally recognized quality rating or assessment tool approved by the department.

By expanding provider eligibility, Hawai'i can increase access to high-quality early learning opportunities while supporting the sustainability of family child care businesses that are essential for many communities.

#### The Time for Action is Now

Hawai'i cannot afford to delay this investment in its youngest residents. States that have prioritized early childhood education have seen measurable improvements in student outcomes and workforce stability. Expanding POD will enable more families to afford quality child care, ensure providers receive adequate support, and give Hawai'i's children a strong foundation for future success.

For these reasons, I respectfully urge the committee to pass H.B. No. 692 H.D. 1. This bill is a necessary step toward making early learning more accessible and affordable for Hawai'i's families.

We listen to and work with families, community members, and policymakers to enhance communication, raise awareness of educational policies, support family engagement, and involve communities in decision-making processes that improve schools and student outcomes.

We write in strong support of HB 692. The expansion of preschool open door programs eligibility criteria can increase the families and children participating in this vital service. The expansion of state subsidies and adjustment of policies will greatly benefit Hawai'i's working families. Moreover, early childhood education sets up students for success for the rest of their lives, rewards families with healthy productive participation in our commonwea, and supports school harmony and success.

Early Childhood Action Strategy (ECAS) is a statewide cross-sector collaborative designed to improve the system of care for Hawai'i's youngest children and their families. ECAS partners work to align priorities for children prenatal to age eight, streamline services, maximize resources, and improve programs to support our youngest keiki.

**ECAS supports, with amendments, HB692 HD1**, which would expand the Preschool Open Doors program's eligibility criteria and significantly increase access to early learning programs for young children and their families. *No appropriation is requested as part of this measure.* 

High-quality early learning programs provide children with the experiences and environments that are pivotal to school readiness and lead to improved educational, economic, health and well-being outcomes for children, lasting into adulthood. The Preschool Open Doors (POD) program currently provides key financial assistance to families to facilitate access for 3 and 4-year-old children to these child care and early learning programs. The POD program changes proposed in this measure would expand eligibility to 2-year old children and decrease some of the additional barriers that have restricted and/or are projected to limit full uptake of the assistance available to, and critically needed by families.

By expanding POD eligibility to include 2-year-olds, this bill acknowledges the importance of early childhood development during these formative years and addresses a substantial gap in child care support for families with younger children. Hawai'i has some of the highest child care tuition rates in the nation, with expenses for families comparable to, and at times even exceeding, housing costs. Assistance for 2-year olds, as well as the proposed adjustment to continuous services will significantly reduce the financial burden of child care expenses for our youngest, enabling families to remain in the workforce and achieve greater economic stability, while simultaneously laying a strong foundation necessary for our keiki to grow and thrive.

Expansion of the child care settings in which POD assistance may be applied, will also be instrumental to increasing children's access to early learning opportunities. Inclusion of family child care homes, and removal of the accreditation requirement for child care centers will significantly increase the availability of child care seats for children in the current landscape where capacity and vacancies are highly limited. We strongly encourage the continued promotion of program quality through the accreditation support programs recently established by the Department of Human Services, and the rate incentives embedded in the POD payment structure, without the limitations to choice and access posed by an accreditation *requirement*.

We would like to especially highlight the inclusion of family child care providers as a much-needed option for local families to access early learning opportunities for their children. Family child care providers can often better meet the

needs of families with non-traditional parental work hours, match the cultural and linguistic preferences of families, and are often found in rural communities in which larger child care centers cannot be sustained. Enacting policy that recognizes family child care providers as eligible for POD funding would result in immediate growth in the number of available early learning slots for local keiki.

Related to quality practices that promote school readiness, we would also like to note that high quality early learning experiences that prepare children for kindergarten can be made available to children as much in family child care settings as in formal child care center classroom settings.

To address inclusion of family child care homes as eligible POD providers, with quality safeguards, we respectfully recommend the following amendments to Section 2, subsection (c), page 4, lines 1-2:

```
(3) An exempt center-based provider that meets the 2 requirements of section 346-152.5-; or
(4) A family child care home that is registered by the department in accordance with section 346-171, provided that they meet at least one of the following quality standards:

On behalf of Hawai'i Children's Action Network (HCAN) Speaks!, mahalo for the opportunity to testify in **STRONG SUPPORT of H.B. No. 692 H.D. 1**, which expands the eligibility criteria for the Preschool Open Doors (POD) program and removes the requirement that POD providers be accredited. This measure is essential in increasing access to early learning opportunities for families across Hawai'i, particularly those with young children who face financial barriers to participation. *The proposed expansion of the POD program requires no additional funding, as existing funds have already been allocated within the base budget; as such, this bill requests no appropriation*.

 The Need for Subsidies for Families with Two-Year-Olds – The early years of a child's life are crucial for cognitive, social, and emotional growth. However, the cost of early learning remains a significant burden for many families. Expanding POD eligibility to include twoyear-olds ensures that more children receive the early learning experiences necessary for future success, reducing long-term disparities in opportunities.

Research consistently shows that early intervention and structured environments significantly impact a child's future achievements and overall well-being. Providing subsidies for families with younger children would allow more parents/guardians to enter or remain in the workforce, ultimately strengthening Hawai'i's economy while ensuring children receive the foundational experiences they need.

 Removing Accreditation Requirement to Increase Accessibility – Currently, a limited number of group child care centers and infant-toddler centers in Hawai'i hold accreditation from organizations such as the National Association for the Education of Young Children (NAEYC) and the National Early Childhood Program Accreditation (NECPA). While accreditation is one indicator of standards, it is costly and time-consuming for providers. The high costs associated with accreditation, which can exceed \$4,000 for initial fees alone, often create barriers for smaller, community-based child care centers.

Since the number of child care centers in Hawai'i has been declining, removing the accreditation requirement will allow more providers to participate in the POD program, expanding options for families. Many non-accredited centers still maintain strong care and development programs but cannot afford the financial and administrative burden of accreditation. This change will ensure families have a broader selection of preschools without limiting access due to accreditation requirements.

3. Including Family Child Care Homes – In addition to expanding eligibility, it is crucial that family child care homes be included as providers under the POD program. Family child care homes offer a nurturing and flexible environment that many working families rely on. These providers often serve smaller groups, allowing for individualized attention and care that supports early development. By ensuring family child care homes are eligible for participation in the POD program, the state can broaden the options available to parents and caregivers, making early learning more accessible to families in urban and rural communities.

To address the inclusion of family child care homes as eligible POD providers, with quality safeguards, we respectfully recommend the following amendments to Section 2, subsection (c), page 4, lines 1-2:

(3) An exempt center-based provider that meets the 2

requirements of section 346-152.5; or

(4) A family child care home that is registered by the

Department, in accordance with sections 346-171, provided

that they meet at least one of the following quality

standards:

Parents and Children Together (PACT) <u>supports HB 692 HD1</u> Relating to the Preschool Open Doors **Program**, which expands the program's eligibility criteria, resulting in more local keiki being able to access early learning services at a younger age.

Research continues to show that—despite the expansion of state-funded early learning services and programs—less than 40% of 4-year-olds and less than 15% of 3-year-olds are enrolled in state-funded programs—clearly demonstrating a continued lack of access for many children and families. The bill will reduce the significant financial burden many families face regarding child care expenses. The cost of child care is one of the largest expenses for many families on Oahu and across the State, often exceeding housing or other essential needs.

While family child care providers are generally limited in their inclusion in state-funded early learning offerings and programs, research indicates that they can play an outsized role in a community's overall early learning framework. Studies have also found that family child care providers are an important option. Low-income families, those with non-regular work hours, and ethnic or racial minorities are likely to utilize family child care providers. Making family child care providers eligible for POD funding would result in immediate growth in the number of available early learning slots for local keiki.

Founded in 1968, PACT is a statewide community-based organization providing a wide array of innovative and educational social services to families in need. Assisting more than 15,000 people across the state annually, we help identify, address, and successfully resolve challenges through our 20 programs. Among our services are early education programs, domestic violence prevention and intervention programs, child abuse prevention and intervention programs, child hood sexual abuse supportive group services, child and adolescent behavioral health programs, sex trafficking intervention, poverty prevention and community building programs.

Dear Chair Yamashita, Vice Chair Takenouchi, and the Members of the Committee,

Members of AAUW of Hawaii thank you for this opportunity to testify in **strong support of HB 692, HD1, Relating to the Preschool Open Doors Program** which will expand eligibility criteria and remove the accreditation mandate, but will continue to require licensure. This measure has no appropriation and requires no additional funding.

Hawai'i is experiencing a child care crisis. The demand for available, quality, and affordable child care far exceeds the current capacity in Hawaii. There is only one opening for every four children ages six and below. The situation is even worse for those seeking a child care space for infants and toddlers with only one opening for every 37 children. This leaves families, and single parent households in particular in a bind. Without available child care services, many parents end up in a no-win position. They can either stay home with their young children and face increasing economic hardship or be stuck scrambling to find someone to "watch" their children. These informal child care settings often do not provide the necessary early childhood educational and developmentally appropriate activities which lead to a child being ready to enter kindergarten.

In Hawai'i, family members, especially grand parents have often stepped in to provide child care. Unfortunately, kupuna are finding it financially necessary to remain in, or return to, the workforce in order to make ends meet in our ever increasing expensive state.

In addition, having children actually penalizes women in the workforce. The Institute for Women's Policy Research reports 50.5% of households with children in Hawai'i have mothers who are the main source of family income. However, women working full time experience what's known as the "Motherhood Penalty". Working mothers make only \$.74 for every dollar working fathers make in Hawaii while the overall gender wage gap in Hawai'i where working women make \$.84 for every dollar a working man make. The cost of licensed child care ranges from approximately \$13,000 to \$23,000 per year depending on the age of the child. The median income for a single parent family is

\$43,050, which means that child care for an infant would use up over 50% of the salary; leaving little left over to pay for transportation, parking, food, housing and taxes.

One of the major obstacles preventing mothers from securing a well-paid, stable job is finding and retaining available, affordable, quality childcare.

In order for this measure to be the most impactful to families in Hawaii, we request that:

1) Family Child Care centers be included as an option to families. This alternative child care setting is especially important to families in rural areas where center-based services are few and far between and provide quality care.

2) In addition, we would like to see this measure to allow for continuous eligibility for children from three years prior to kindergarten entry and until they begin kindergarten. It has been shown that continuity of child care provides children with the best preparation to succeed in future schooling.

This measure increases the availability and access to the quality and affordable early child care which is so important for early childhood development and also allows parents the stability to continue in the workforce to provide for their family.

Support for HB 692 – Relating to Preschool Open Doors Programs

As a mother, and an early childhood educator, I strongly support HB 692, relating to Preschool Open Doors Programs, expanding eligibility for more families to qualify for financial support. I have been in the early childhood field for 15 years as a teacher and a school director. This bill is crucial so our children can have meaningful and quality experiences at a young age, while parents and extended family members are able to go to work or contribute to their communities in other ways. I feel this bill can positively affect families and strengthen our early learning system.

The expansion of state funded pre-k programs are servicing a great need for many communities. However, according to the First Five Years Fund only 2% of Hawai'i's three and four year olds are enrolled in public pre-k programs. This leaves an astonishing number of keiki in this age group, as well as ALL children under the age of two, who need other opportunities for early care and education. For those who do not receive a spot into public pre-k schools, children who aren't age eligible, or families who do not live close enough and have access to such programs, the Preschool Open Doors subsidy allows many more families the opportunity and choice to place their child(ren) in care that most suits their needs and lifestyle, while at the same time contributing to shore up financially fragile

community based early childhood programs. A mixed delivery system where many types of care are accessible to families is the only way to successfully meet our families' needs and contribute to Hawai'i's economic growth.

When my children were preschool aged my family did not qualify for a spot in the state funded pre-k programs. And even if they did, the hours of operation for those sites would not have worked in relation to my job. I needed care past the hours PreK provides. My daughters are only two years apart, so our family's finances were greatly impacted by having two preschoolers in school simultaneously for multiple years from the age of two all the way through five, with an additional year of preschool for both because they are late born. In 2023 the average cost for a four year old to attend a full-time center in Hawai'i was over \$13,000 annually, excluding additional costs such as after hours or summer care. Most up-to-date data reported by Child Care Aware of America also shows that in 2023 Hawai'i was ranked to have the least affordable center-based toddler care, consuming at least 15% of a married couple's annual salary, and at least 40% for single parent households. In my family, it was extremely difficult to recover from the financial burden, even after children have moved on. It is no wonder families are fleeing to other parts of the nation where they are able to find better financial balance and a sense of peace. We must do better!

I know first hand this bill will not only impact families, but can uplift the early childhood workforce as well. The widening of the Preschool Open Doors Program eligibility would provide support to the many dedicated early childhood educators and programs that currently exist in our communities. Many have not fully recovered after COVID-19. Based on statistics shared by the First Five Years Fund, In 2023 alone 25 licensed child care centers and family child care homes closed. An extremely disheartening number that has displaced and negatively impacted many dedicated members of the early childhood workforce. Centers continue to struggle through teacher shortages as well as maintaining enrollment while tuition costs for their families rise in response to inflation. Expanding eligibility to POD for more families and amending the accreditation criteria relieves the providers of additional pressures and burdens. Providers can allocate their time to focus on the children and the families they serve.

In order to provide our keiki with quality education, to build a strong foundation for positive developmental outcomes, we all need to come together. The wellness of all our keiki is a collective effort and the outcome of this bill will impact us all. The health of our future depends on the wellness of keiki and their 'ohana today.

I urge the committee to pass HB 692.

It is estimated that Hawaii loses upwards of \$476 million dollars per year due to the impacts of a lack of childcare.

Many rural areas in Hawaii are considered child care deserts, where there is little or no access to childcare, this is especially true for families with younger children. Expanding the program to include 2-year-olds and utilizing family child care homes will significantly expand access to childcare and help to alleviate financial pressures for families with young children, helping families across the state achieve greater economic stability.

We believe accreditation is a valuable marker of quality. However, requiring accreditation reduces the number of available seats due to the lower ratios required for accreditation than what is required by the Department of Human Services. The Department of Human Services recently established an accreditation program to support the pursuit of accreditation and other quality improvement measures. Removing the accreditation requirement in this bill broadens family access to early learning opportunities while allowing providers to enhance quality through other complementary programs.

The POD program provides a cost-efficient strategy while still meeting the need through supplemental funding. It's a public-private partnership that grows government's reach in a cost-effective and meaningful way. By removing barriers, this bill will open doors for more families to access affordable and reliable care and better economic opportunities.
