Honorable Chair Marten, Vice-chair Olds, and members of the House Human Services and Homelessness Committee:

The Early Learning Board (ELB) formulates statewide policy relating to early learning, as well as directing the Executive Office on Early Learning (EOEL).

The ELB supports HB 692, which would allow families with children ages two up to kindergarten entry to apply for Preschool Open Doors (POD) subsidies. This expansion of state subsidies will greatly benefit Hawai'i's working families.

While EOEL classrooms are expanding to more schools, these free school-day programs may have a negative impact on the local community based provider(s), who must charge tuition from families to stay open. POD subsidies to families support families who need care and education for their child beyond the school day and school year. Consistency and routine help optimize each child's development, and being able to stay in the same program year round, with caring teachers, provides that.

The Early Learning Board oversees the EOEL, and both ELB and EOEL have a responsibility to coordinate the many systems that make up early learning opportunities in our state. Support of the expansion of POD funding is one of the ways the board can support all children in Hawai'i.

<u>**DEPARTMENT'S POSITION**</u>: The Department of Human Services (DHS) supports the bill's intent, provides comments, and requests amendments.

<u>PURPOSE</u>: The purpose of this bill is to expand the Preschool Open Doors Program's eligibility criteria. Repeals the requirements that Preschool Open Door program providers be accredited.

The Department recommends maintaining group child care centers as the type of care for the Preschool Open Doors program. The Preschool Open Doors program is an investment in early learning that provides children the opportunity to experience a structured preschool environment so that they are better prepared for kindergarten. Group child care centers offer the most comparable experience for the child prior to their kindergarten entry as care services are provided in a classroom setting led by a qualified teacher, and enrollment consists of children of the same age. If this measure is passed to add accredited family child care, the Department recommends amending the term "accredited family child care center" on page 4, line 1, to "accredited family child care home," which exists in current law.

The department respectfully recommends the following amendments:

- Section 2, paragraph (b), on page 2, lines 11 and 12, to read: Subject to the availability of funds, the program shall continuously serve [three-and-four year old] children who are in the [two] three years prior to kindergarten entry until they enter kindergarten pursuant to section 302A-411...
- Section 2, paragraph (c) (3), on page 4, lines 1 to 3, deleting the entire paragraph,
- Section 2, paragraph (c) (4), on page 4, lines 4 to 5, to read: An exempt center-based provider that meets the requirements of section 346-152.5.
- Section 2, paragraph (d), on page 4, line 6, to read: Participation in the program shall not require group child care centers or group child care homes to be accredited by an approved accredited body.
- Section 2, paragraph (e), on page 4, line 10, to read: Enrollment in the program shall be voluntary. A parent or guardian of a child enrolled in the program [shall] may share in the costs of the program through a copayment according to a sliding fee scale that is based on need pursuant to rules adopted by the department.

Regarding accreditation addressed in Section 4, currently, there are 144 out of 455 group child care centers and infant and toddler centers that are accredited by the National Association for the Education of Young Children (NAEYC) and the National Early Childhood Program Accreditation (NECPA). Though the Department recognizes and supports the added quality that accreditation adds to the care a child receives at a group child care center, the Department also recognizes that accreditation is a costly and lengthy endeavor for group child care center operators. As the number of child care centers has been declining since prior to the COVID-19 pandemic, at this time, the mandatory accreditation requirement for the centers for families to receive Preschool Open Doors subsidies will likely have a negative impact on the available inventory of preschools that families could select from.

The average cost for the initial fees to obtain NAEYC accredited status is \$4,155, and fees for initial NECPA accredited status are \$2,331. These costs may vary depending on the licensed capacity of the group child care center. These fees are the accrediting organization's fees for processing and assessing an applying group child care center's request for accreditation.

Notably, these accreditation fees do not include additional costs that a group child care center may incur to meet the accrediting organization's standards. Once accredited, both organizations have annual fees to maintain their accreditation.

The Executive Office on Early Learning (EOEL) offers the following comments in support of H.B. No. 692 and defers to the Department of Human Services (DHS) regarding implementation and funding.

The Preschool Open Doors program plays a crucial role in helping families afford quality child care. This legislation will expand access to early learning opportunities for Hawai'i's families by expanding eligibility for the Preschool Open Doors program to include 2-year-olds (children three years prior to kindergarten entry) and extending the program to cover a broader range of community-based providers licensed by DHS.

Community-based early learning providers are vital to a strong, mixed-delivery early learning system, offering families flexibility in choosing care that best meets their needs. Many of these providers also have the capacity to offer full-day and year-round care, which is not offered by most free public prekindergarten programs but is essential for many working families.

Reducing financial barriers to early learning programs also enables more parents and caregivers to participate in the workforce while ensuring their children receive the early childhood development and learning experiences critical to lifelong well-being. Expanding access to these opportunities will yield long-term benefits for children, families, and the broader community.

Other complementary programs are already in place to support quality improvement efforts, ensuring that expanded access is not done at the expense of quality.

Dear Chair, Marten Vice Chair Olds, and the Members of the Committee,

Members of AAUW of Hawaii thank you for this opportunity to testify in **strong support of HB 692**, **Relating to the Preschool Open Doors Program** which will:

- Expand eligibility to include children ages 2-5 years old.
- Expand eligibility to include Family Child Care Centers.
- Allow for continuous eligibility until kindergarten entry.
- Remove the accreditation mandate (but does continue to require licensure).

Hawai'i is experiencing a child care crisis. The demand for available, quality, and affordable child care far exceeds the current capacity in Hawaii. There is only one opening for every four children ages six and below. The situation is even worse for those seeking a child care space for infants and toddlers with only one opening for every 37 children. This leaves families, and single parent households in particular in a bind. Without available child care services, many parents end up in a no-win position. They can either stay home with their young children and face increasing economic hardship or be stuck scrambling to find someone to "watch" their children. These informal child care settings often do not provide the necessary early childhood educational and developmentally appropriate activities which lead to a child being ready to enter kindergarten.

In Hawai'i, family members, especially grand parents have often stepped in to provide child care. Unfortunately, kupuna are finding it financially necessary to remain in, or return to, the workforce in order to make ends meet in our ever increasing expensive state.

In addition, having children actually penalizes women in the workforce. The Institute for Women's Policy Research reports 50.5% of households with children in Hawai'i have mothers who are the main source of family income. However, women working full time experience what's known as the "Motherhood Penalty". Working mothers make only \$.74 for every dollar working fathers make in Hawaii while the overall gender wage gap in Hawai'i where working women make \$.84 for every dollar a working man make.

The cost of licensed child care ranges from approximately \$13,000 to \$23,000 per year depending on the age of the child. The median income for a single parent family is \$43,050, which means that child care for an infant would use up over 50% of the salary; leaving little left over to pay for transportation, parking, food, housing and taxes.

One of the major obstacles preventing mothers from securing a well-paid, stable job is finding and retaining available, affordable, quality childcare.

Also, be aware that Federal funds support large portions of Hawaii's child care programs. The new administration has promised spending cuts. Hawaii must prepare for such cuts by funding these important programs with State funds.

This measure increases the availability and access to the quality and affordable early child care which is so important for early childhood development and also allows parents the stability to continue in the workforce to provide for their family.

Early Childhood Action Strategy (ECAS) is a statewide cross-sector collaborative designed to improve the system of care for Hawai'i's youngest children and their families. ECAS partners work to align priorities for children prenatal to age eight, streamline services, maximize resources, and improve programs to support our youngest keiki.

**ECAS strongly supports passage of HB692**, which would expand the Preschool Open Doors program's eligibility criteria and significantly increase access to early learning programs for young children and their families.

High-quality early learning programs provide children with the experiences and environments that are pivotal to school readiness and lead to improved educational, economic, health and well-being outcomes for children, lasting into adulthood. The Preschool Open Doors (POD) program currently provides key financial assistance to families to facilitate access for 3 and 4-year-old children to these child care and early learning programs. The POD program changes proposed in this measure would expand eligibility to 2-year old children and decrease some of the additional barriers that have restricted and/or are projected to limit full uptake of the assistance available to, and critically needed by families.

Approximately 16% of Hawai'i's licensed, preschool center enrollment is composed of 2-year old children. By expanding POD eligibility to include 2-year-olds, this bill acknowledges the importance of early childhood development during these formative years and addresses a substantial gap in child care support for families with younger children. The bill will also reduce the significant financial burden many families face regarding child care expenses. Hawai'i has some of the highest child care tuition rates in the nation, with expenses for families comparable to, and at times even exceeding, housing costs. Assistance for 2-year olds, as well as the proposed adjustment to continuous services, and reduction to the parent copayment share in the costs of the program, will all alleviate financial pressures, enabling families to remain in the workforce and achieve greater economic stability, while simultaneously laying a strong foundation necessary for our keiki to grow and thrive.

Finally, expansion of the child care settings in which POD assistance may be applied, will be instrumental to increasing children's access to early learning opportunities. Inclusion of family child care homes, and removal of the accreditation requirement for child care centers will significantly increase the availability of child care seats for children in the current landscape where capacity and vacancies are highly limited. We strongly encourage the continued promotion of program quality through the accreditation support programs recently established by the Department of Human Services, and the rate incentives embedded in the POD payment structure, without the limitations to family choice and access posed by an accreditation requirement.

Aloha Chair Martin, Vice Chair Olds, and Committee Members:

**Aloha United Way and the ALICE Initiative support HB692**, which expands the preschool open door program's eligibility criteria.

Childcare costs and a shortage of seats create an economic drag on our State. The quickest solution to address this is to help working families with the cost. We would add comment that while Page 2, lines 6 and 7 has been struck, we support a continued provision to "Give Priority to children from low and moderate income families," or similar, to ensure funds reach the families where such support makes the greatest difference in accessing childcare.

The new **2024 State of ALICE in Hawaii report found that 50% of our State's residents with children are ALICE families. ALICE stands for <u>A</u>sset <u>L</u>imited, <u>I</u>ncome <u>C</u>onstrained, <u>E</u>mployed. This is a full 10% higher than the general population of 40% who are ALICE. ALICE are our households who are employed but whose incomes are not sufficient to meet basic costs, and child care costs are often one of the key drivers of that gap.** 

The reality is childcare is critical for families to earn the two incomes often needed to survive in Hawaii. Yet the childcare that makes this possible is financially inaccessible to many households in the state. The Preschool Open Doors program provides significant cost relief to families.

It will also help Hawai'i's economy, which loses up to \$476 million annually due to insufficient child care programs and options, to grow and to provide more workers to help our businesses address the workforce shortage.

Thank you for the opportunity to testify and for your support for HB692 to strengthen Preschool Open Doors and to help more ALICE families with children return to work.

On behalf of Hawai'i Children's Action Network (HCAN) Speaks!, mahalo for the opportunity to testify in **STRONG SUPPORT of H.B. No. 692**, which expands the eligibility criteria for the Preschool Open Doors (POD) program and removes the requirements that POD providers be accredited. This measure is essential in increasing access to early learning for families across Hawai'i, particularly those with young children who face financial barriers to participation.

The Need for Subsidies for Families with Two-Year-Olds – The early years of a child's life
are crucial for cognitive, social, and emotional growth. However, the cost of early learning
remains a significant burden for many families. Expanding POD eligibility to include twoyear-olds ensures that more children receive the early learning experiences necessary for
future success, reducing long-term disparities in opportunities.

Research consistently shows that early intervention and structured environments significantly impact a child's future achievements and overall well-being. Providing subsidies for families with younger children would allow more parents/guardians to enter or remain in the workforce, ultimately strengthening Hawai'i's economy while ensuring children receive the foundational experiences they need.

2. Removing Accreditation Requirement to Increase Accessibility – Currently, a limited number of group child care centers and infant-toddler centers in Hawai'i hold accreditation from organizations such as the National Association for the Education of Young Children (NAEYC) and the National Early Childhood Program Accreditation (NECPA). While accreditation is one indicator of standards, it is a costly and time-consuming process for providers. The high costs associated with accreditation, which can exceed \$4,000 for initial fees alone, often create barriers for smaller, community-based child care centers.

Since the number of child care centers in Hawai'i has been declining, removing the accreditation requirement will allow more providers to participate in the POD program, thereby expanding options for families in need. Many non-accredited centers still maintain strong care and development programs but cannot afford the financial and administrative burden of accreditation. This change will ensure that families have a broader selection of preschools to choose from without limiting access due to accreditation requirements.

By passing **H.B. No. 692**, the Legislature can take a crucial step toward making early learning more accessible and affordable for Hawai'i's families. I respectfully urge you to support this bill to expand early learning opportunities and strengthen our state's commitment to the well-being and future success of our keiki.

While my children are now grown, in graduate school and college on the mainland, I remember how hard it was to obtain and afford preschool placement for them. I remember having to camp out overnight on New Year's Day to get a space in line on the first business day of the year to place my daughter for fall school year preschool admission. The crazy things parents have to do to secure child care they can, hopefully, afford. When my youngest was a toddler, I placed her in an in-home child care in my neighborhood that I found by word of mouth. I was lucky that our family owned our own business, so I had the flexibility to work around my child care needs and still afford housing. That was back in the early 2000's when housing was not crazy like it is now, especially on Maui. Not everyone is as fortunate today as I was when my kids were young. Families are having to forego having children or move to the mainland. Hawai'i's families deserve more from our communities, and that is why I am submitting this testimony in support of HB692.

By expanding POD eligibility to include two-year-olds, this bill acknowledges the importance of early childhood development during these early childhood years and addresses a substantial gap in child care support for families with younger children. The bill will also reduce the significant financial burden many families face regarding child care expenses. Expanding the program to include two-year-olds will alleviate financial pressures, enabling people to start or grow families, and remain in the workforce in Hawai`i rather than being forced to move to the mainland.

There is a shortage of childcare options for younger children. I've been an advocate for early childhood care and education since the 1980s. I am professor emerita of University of Hawai'i Maui College, where I was the program coordinator from 2000-2019. I am also the current chair of the Early Learning Board, however this testimony is my personal testimony.

I am in support of HB 692, which would allow families with keiki two years old to kindergarten entry to apply for Preschool Open Doors (POD) state subsidies. Many families need full day, year round care and education for their keiki, and being able to stay in the same program all day and year round provides important consistency. Consistency with caring teachers optimizes development for each keiki.

While accreditation of the program would no longer a requirement for a program to accept children with POD subsidies, the requirement for the Dept. of Human Services (DHS) to provide accreditation support stays in place, and the early childhood community is seeing the ramp-up of these important supports. My name is Dr. Terry Lock. Currently, I am the Director of the Hawai'i Early Childhood Educator Excellence and Equity (ECE<sup>3</sup>) Project at the University of Hawai'i Mānoa College of Education.

HB 692 seeks to expand the Preschool Open Doors (POD) program to more young children of Hawaii's families and reduce one of the barriers for families to access POD programs. This measure lays a strong foundation for the future success of more of our youngest keiki.

As it stands, the POD program is a vital resource for families with 3- and 4-year-old children, offering much-needed financial assistance to make child care more affordable as the cost of child care is one of the largest expenses for many families on O'ahu and across the State, often exceeding housing or other essential needs.

With HB 692 the POD program will expand to add 2-year-olds. This expansion will alleviate financial pressures so more families will remain in the workforce and achieve greater economic stability, while simultaneously laying a strong foundation for their 2- year olds to grow and thrive.

In HB 692 the types of early learning programs for eligible families are listed on p. 3 from lines 16 - 21 and p. 4 from lines 1-5. I agree with licensed group child care centers, licensed group child care homes, licensed infant and toddler child care centers. However, I recommend that "accredited family child care centers" be changed to "regulated family child care programs" (see next paragraph about program accreditation). I also recommend that "exempt center-based providers" be changed to "Hawaiian language immersion preschools".

I believe that all young children and their families deserve quality child care options and that early learning program accreditation is a key marker of quality. Furthermore, I commend how the Department of Human Services' (DHS) has recently established an accreditation support program for licensed child care centers and regulated family child care programs. Because this accreditation support program is already established through DHS, I recommend changing "Participation in the program shall not require preschools or early learning programs to be accredited by an approved accredited body" which are on lines 6-8 on p. 4, to "Participation in the program shall recommend that early learning programs have a plan on how they strive to obtain or maintain accreditation by an approved accreditation

**body".** This will broaden families access to POD funds and not disrupt the complementary program through DHS which allows early learning providers to enhance quality through accreditation.

I appreciate this balanced approach of this bill, which reflects a commitment to expanding access to early learning programs. By removing barriers, this bill will open doors for more families to access affordable and reliable care and better economic opportunities.

I am testifying in support of this bill, which would expand preschool open door eligibility criteria in Hawai'i to participate in HB692 Preschool Open Doors Program.

To ensure families have access to high quality early childhood care and education from birth to kindergarten, we must fairly compensate our early care and education workforce and provide them with opportunities for professional advancement. Early learning registered apprenticeship programs are a proven recruitment and retention strategy, offering apprentices higher compensation and valuable on-the-job learning experiences as they work towards earning a higher education degree. ELRAPs have also been successful at increasing the quality of early learning programs as they develop a well-prepared, well-supported, and well-compensated ECE workforce.

However, many early learning providers are unable to participate in ELRAPs because they cannot afford to pay the higher wages of apprentices and ensure wage parity for existing staff. The ELRAP grant would remove this financial barrier by providing funding for eligible providers to participate in state- or federally-approved ELRAPs. The grant would also allow providers to pay their existing staff higher wages, ensuring that wages are comparable to federal wage requirements or prevailing industry standards.

This bill would give priority to licensed and/or regulated child care providers serving infants and toddlers (I/T) due to the greater challenges families face in accessing high-quality, affordable I/T care. I/T care and education has the highest unmet need among all early learning services in Hawai'i. Starting with our I/T child care providers will help families access quality care from the time babies need it most.

In short, ELRAPs are a proven recruitment and retention strategy for the early care and education workforce. This grant would enable more providers to participate, benefiting Hawai'i's children, families, and early education professionals. Additionally, it would support businesses by helping employees with young children—particularly mothers—stay in the workforce, addressing the common challenge of inaccessible and unaffordable child care.
