EOA's Position: The Executive Office on Aging (EOA), an attached agency to the Department

- of Health, strongly supports HB705.
- 3 **Fiscal Implications:** This measure appropriates funds for SFY 2025-2026 and the same sum for
- 4 SFY 2026-2027 for one full-time equivalent (1.0 FTE) position within the EOA and for
- 5 operating costs to be expended by the EOA for this pilot project.
- 6 **Purpose and Justification:** The purpose of this bill is to establish a Medi-Medi project within
- 7 the Advocacy, Education, and Outreach Section (AEOS) to screen residents who may be dually
- 8 eligible for Medicare and Medicaid. This Section provides information and assistance on low-
- 9 income subsidy programs that can help to offset healthcare costs such as premiums, deductibles,
- copayments, coinsurance, and late enrollment penalties. With 33 years of proven experience,
- staff and volunteer counselors educate and empower Medicare beneficiaries to make cost-
- effective, informed health care decisions based on their own needs and ability to pay.

Hawai'i is No.1 in the nation with the highest cost of living as well as having the longest

2 average lifespan at 80.7 years of age. Residents continue to struggle with the increasing costs for

- 3 healthcare services and prescription drugs. Since the pandemic, the Department of Human
- 4 Services (DHS) reported the number of Medicaid members rose 24.4% from 46,013 to 58,085.
- 5 The Medicaid eligibility redetermination period began in 2023 and ended in December 2024.
- 6 Throughout this period, a significant increase in the volume of calls, emails, website visits, and
- 7 referrals were received from Med-QUEST and the Social Security Administration (SSA) to help
- 8 those who lost coverage. Two staff and the volunteer counselors successfully addressed the
- 9 demands, however, the program experienced slower than usual response rates.
  - Currently, this Section screens for eligibility for low-income subsidy programs such as Medicaid/Medicare Savings Programs, Extra Help, or Part D plans; helps individuals to find MarketPlace options for those uninsured; and provides information and referrals for other assistance programs to address food, housing, or caregiving needs. The Medi-Medi project will streamline the Medicaid application process and ensure the submission of applications, helping individuals with quicker access to benefits. The project would help Med-Quest save time and resources, resulting in faster intake processing for initial applications. In addition, by supporting the Medicaid intake process, EOA could bill for Medicaid Administrative Claiming, thus generating ongoing revenue to sustain these services.
  - **Recommendation:** EOA strongly supports this measure provided that its enactment does not reduce or replace priorities with the Administration's budget request.

The Hawaii State Council on Developmental Disabilities **SUPPORTS HB705**, which establishes a temporary Medi-Medi Project within the Hawaii State Health Insurance Assistance Program administered by the Executive Office on Aging to assist older adults, Medicare beneficiaries, individuals with disabilities, and other underserved populations who may qualify for various low-income subsidy programs to gain access to their benefits.
