**HOUSE BILL NO. 782, HOUSE DRAFT 1**  
**RELATING TO AGRICULTURE.**

Chair Yamashita, Vice Chair Takenouchi and Members of the Committee:

Thank you for the opportunity to provide testimony on House Bill No. 782, House Draft 1 that establishes within the Department of Agriculture (Department) an twelve-member Working Group to be chaired by the Chair of the Board of Agriculture to review and make recommendations on amending or repealing unnecessary or obsolete laws pertaining to agriculture. There is an appropriation. The Department offers comments.

The measure identifies the following three issues that shall be considered for amending or repeal by the Working Group:

- (1) Restrictions on leases of State agricultural land that prohibit a residence on the property;
- (2) Restrictions on leases of State agricultural land that prohibit the raising of poultry and swine on the property; and
- (3) Caps on agricultural operation loan rates.

Other laws "pertaining to agriculture" that are possibly "unnecessary or obsolete" may be considered for review and recommendation by the Working Group.

The Department has concerns with respect to the initial issues to be considered by the Task Force. Both the Agricultural Resources Management and Agricultural Loan divisions do not concur that the issues of the operating loan cap, house building and raising of poultry and swine are unnecessary, obsolete or impede the growth and success of agriculture in Hawaii. In lieu of the proposed Working Group, the Department recommends that the Legislature commission a study to be done by a



neutral party such as the Legislative Reference Bureau to comprehensively, efficiently and unbiasedly determine the magnitude and extent of laws that qualify as unnecessary or obsolete and meriting amendment or repeal.

The Land Use Research Foundation of Hawaii (LURF) is a private, non-profit research and trade association whose members include major Hawaii landowners, developers, and utility companies. LURF's mission is to advocate for reasonable, rational, and equitable land use planning, legislation and regulations that encourage well-planned economic growth and development, while safeguarding Hawaii's significant natural and cultural resources, and public health and safety.

LURF appreciates the opportunity to express its **support of HB 782, H.D. 1** and of the various agricultural stakeholder groups who defend the goals of viable agricultural operations and the conservation and protection of agriculture, including important agricultural lands in Hawaii.

**HB 782, H.D. 1.** The purpose of this measure is to establish a working group within the DOA to review and make recommendations on amending or repealing unnecessary or obsolete laws pertaining to agriculture.

**LURF's Position.** In view of the intensifying impacts being cast upon agricultural conditions and operations by climate change, globalization, the influx of devastating invasive species and diseases, market conditions, lack of available labor, amongst other factors, the State must seek to update and amend its current laws and policies to effectively accommodate, support, and modernize the local agricultural industry.

LURF understands that outdated, and therefore unnecessary and inappropriate sections of the Hawaii Revised Statutes and agriculture-related policies are now having the negative effect of impeding efficient operations and may be retarding the growth and success of agriculture in Hawaii.

LURF members include farmers, ranchers, and landowners who own, maintain, and engage in agricultural enterprises, all of which believe that existing agricultural laws and policies must be reviewed and vetted to help sustain their businesses, and significantly heighten local food production in this State.

Agricultural stakeholders believe the review by a working group as proposed by HB 782, H.D. 1 will greatly assist in the efforts to achieve long-term sustainability of Hawaii's food supply and economic growth, and to ensure the survival and success of this critical component of the State's economy.

The purpose of this bill is also consistent with the underlying intent and objectives of the IAL laws (Hawaii Revised Statutes, Sections 205-41 to 52), which were enacted to fulfill the mandate in Article XI, Section 3, of the Hawaii State Constitution, "to conserve and protect agricultural lands, promote diversified agriculture, increase agricultural self-sufficiency and assure the availability of agriculturally suitable lands."

By recognizing the significance of, and need to assist the local agriculture industry, and implement measures which help to support the growth and maintenance of agriculture in the State, this bill significantly helps to promote economically viable agriculture and food self-sufficiency in Hawaii.

For the reasons stated above, LURF is in **support of HB 782, H.D. 1**, and respectfully urges your favorable consideration of this bill.

AHIKI ACRES

Aloha Chair Yamashita, Vice Chair Takenouchi, and members of the House Committee on Finance,

My name is Haley McKinnon and I am writing on behalf of Ahiki Acres, LLC, to support House Bill 782. This bill establishes a working group in the Department of Agriculture whose purpose is to recommend repeals and amendments for outdated laws relating to agriculture.

Ahiki Acres, a 6-acre vegetable farm located in Waimānalo, Hawai'i, has been providing fresh, high quality produce to the island of O'ahu since 2019. To meet the demand in the marketplace, the company recently bought a 5.77-acre, 20-year lease from the Hawai'i Department of Agriculture in 2022. With no agricultural background except for their training with GoFarm Hawai'i, my partner and I have acquired the skills, a network, and put in the work to build our business, currently generating \$250,000 per year. We sell most of our products at the Kailua Town Farmers' Market and partner with the following restaurants: Fête, Namikaze, and Island Vintage Coffee.

Unfortunately, acquiring an agricultural lease has been an arduous task and we continue to face challenges with our lease. We've already invested \$260K+ into building our farm and our lease has no option for us to extend when our lease ends in November 2042. As a young farmer (28 years old), I worry about the future of our farm. A dedicated working group has the potential to help us amend outdated agricultural laws and help us reach our goals in providing food for our community for years to come.

**The Hawai'i Farm Bureau supports HB 782, HD1**, which establishes a working group within the Department of Agriculture (DOA) to review and make recommendations on amending or repealing unnecessary or obsolete laws pertaining to agriculture. The East O'ahu County Farm Bureau, which represents approximately 420 farmers and supporters of agriculture from Waimanalo to Kahuku, **strongly supports HB 782 HD1**, "Relating to Agriculture," which would establish a working group to review laws pertaining to agriculture and to make recommendations for repealing or amending unnecessary or obsolete laws.

Many existing laws and policies unnecessarily restrict agricultural operations. Some of these rules date from plantation days and do not reflect the current realities of an extremely diverse industry which includes farms and ranches of different sizes raising many types of crops and livestock using different farming techniques. Hawaii Fish Company strongly supports HB782 HD1 but respectfully requests the addition of "livestock" to p. 3, (c) (2) 17 (2) Restrictions on leases of state agricultural land that prohibit the raising of LIVESTOCK poultry and swine on the 19 property;

Justification: The Hawaii Wildfire Manageent Organization (HWMO) recomends the use of livestock grazing to reduce and control invasive vegetation fuel load on Hawaii's agricultural lands. However, livestock are currently specifically prohibited on DOA diversified agriculture leases, only being allowed on pasture leases. Given the high agriculture and public need to mitigate wildfire risk, this inappropriate restriction needs to be recinded if grazing is included in the lessee's Plan of Utilization and Developent.
