Dear Chair Yamashita, Vice Chair Takenouchi, and Members of the House Committee on Finance:

The Office of Hawaiian Affairs (OHA) **SUPPORTS** HB 784 HD 1 which makes an appropriation for the operation of an additional ambulance for the island of Hawai'i to be based in Makalei.

OHA is the constitutionally established body responsible for protecting and promoting the rights of Native Hawaiians.<sup>1</sup> Among its statutory duties, OHA is required to (1) serve as principal public agency in the State of Hawai'i responsible for the performance, development and coordination of programs and activities relating to native Hawaiians and Hawaiians; (2) assess the policies and practices of other agencies impacting native Hawaiians and Hawaiians; and (3) conduct advocacy efforts for native Hawaiians and Hawaiians.<sup>2</sup>

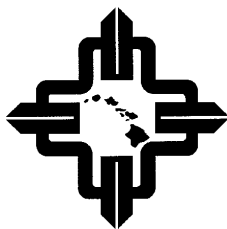
In fulfillment of its mandates, OHA seeks to advance policies, programs and practices that increase access to quality, culturally informed healthcare for Native Hawaiians. HB 784 will expand critical emergency medical services infrastructure and mitigate transportation barriers, which is crucial for Native Hawaiians who live in rural areas on the island of Hawai'i. Given the island's significant growth and aging population, an additional ambulance is necessary to help reduce death and disability among residents and visitors.

The Office of Hawaiian Affairs respectfully urges this committee to **PASS HB 784 HD 1**. Mahalo nui for the opportunity to testify.

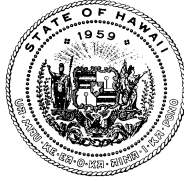

1 **Fiscal Implications:** The Department of Health (“Department”) requests that this measure be  
2 considered as a vehicle to provide this needed funding so long as it does not supplant the  
3 priorities and requests outlined in the Governors executive budget request. The appropriation of  
4 \$1,750,000 for fiscal year 2025-2026 and for fiscal year 2026-2027.

5 **Department Position:** The Department appreciates this measure and respectfully offers the  
6 following comments.

7 **Department Testimony:** The Emergency Medical Services & Injury Prevention System Branch  
8 (EMSIPSB) submits the following testimony on behalf of the Department of Health. We  
9 appreciate the intent of this bill, particularly in addressing the challenges related to distance and  
10 access to emergency services in underserved communities. Expanding access to emergency  
11 medical services in these areas is an important step toward improving healthcare delivery and  
12 ensuring timely care for individuals in remote regions.

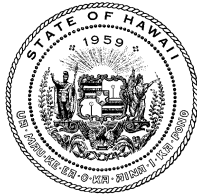
13 However, we would like to address the call volume in these communities and whether it justifies  
14 the use of traditional 911 services. Given the potentially lower frequency of emergency calls,  
15 traditional 911 responses may not always be the most efficient or cost-effective approach to  
16 meeting the community's needs. Further evaluation of call volume and service efficiency is  
17 necessary to determine the most suitable solution for these areas.

1 An alternative model worth considering is the use of Advanced Life Support (ALS) services  
2 through programs like Community Paramedicine (CP) or Mobile Integrated Health (MIH). These  
3 programs are designed to address both emergency and non-emergency medical needs, offering  
4 care within the community at a potentially lower cost compared to traditional 911 services.  
5 Community Paramedicine and MIH can provide targeted care, including follow-up visits,  
6 preventative services, and chronic disease management, without the need for costly emergency  
7 transports for non-urgent cases. Incorporating such services could significantly enhance the bill's  
8 objectives by providing tailored, sustainable solutions that reduce the strain on traditional EMS  
9 systems.

10 In conclusion, while we support the bill's intent, a thorough evaluation of community needs,  
11 along with consideration of alternative service models like CP and MIH, will ensure a more  
12 efficient and sustainable approach to healthcare delivery in underserved areas.

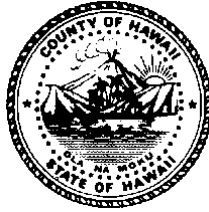

Mahalo for the opportunity to offer my **strong support** for House Bill 784 HD1, which proposes appropriations to fund the operation of the first advanced life support ambulance in the Makalei area of North Kona, on the island of Hawai'i.

The residents of North Kona face significant challenges accessing timely medical care, with primary care services often located as far as thirty miles away. Economic and transportation barriers further compound this issue, making emergency medical services a critical lifeline for the community. While the bill states additional, this advance life support unit would be the **only ambulance** in the area.

- **Supporting a Growing and Aging Population:** North Kona has experienced significant population growth, including an increase in older residents who are at greater risk of health emergencies.
- **Reducing Strain on Existing Resources:** The current emergency medical services system is overstretched and unable to meet the demands of the community effectively.

This investment will undoubtedly save lives and improve health outcomes for residents and visitors to the island of Hawaii.
