# In consideration of HOUSE BILL 86, HOUSE DRAFT 1 RELATING TO THE DEPARTMENT OF LAND AND NATURAL RESOURCES

House Bill 86, House Draft 1, proposes to appropriate moneys to the Department of Land and Natural Resources for the establishment of one full-time equivalent (1.0 FTE) permanent Makai Watch Coordinator position. The Department of Land and Natural Resources (Department) supports this bill provided that its passage does not replace or adversely impact priorities indicated in the Executive Budget request.

The Makai Watch Coordinator works with existing and prospective Makai Watch communities throughout the state to train and inform them on rules and regulations relating to marine activities. Additionally, the Makai Watch Coordinator trains these communities on how to document and report violations as well as acting as a liaison between communities and the Division of Conservation and Resources Enforcement (DOCARE). The Makai Watch Coordinator is a very important position within DOCARE as the Makai Watch Program expands DOCARE's enforcement footprint and gives communities an opportunity to engage with the Department concerning their valued ocean resources.

The Office of Hawaiian Affairs (OHA) submits this testimony in **SUPPORT of HB86 SD1** which appropriates moneys to the Department of Land and Natural Resources (DLNR) for the establishment of one full-time equivalent (1.0 FTE) permanent Makai Watch Coordinator position. Funding a full-time coordinator is a smart investment to ensure the continued success of the Makai Watch program which not only recognizes and empowers community comanagement of resources but also saves DLNR money by having citizens serve as the eyes and ears of the department.

OHA recognizes the value and importance of community-based stewardship and management which, in practice, is aligned with Native Hawaiian traditional and customary resource management practices. The Makai Watch program is a collaborative, statewide program that engages citizens and non-profits in the management of marine resources by promoting compliance with rules and community-based education and monitoring of resources. The Makai Watch program engages people who are directly impacted or live closest to natural and cultural resources and are thus in the best position to assist in understanding the overall landscape. This is a modern reflection of the ahupua'a management practices led by konohiki (caretakers) and aha councils (place-based subject matter experts).

In funding this position, the Makai Watch program can commit to facilitating community engagement and leveraging government resources to protect the natural and cultural resources. Furthermore, with recent Federal cutbacks, it is critical that our State ensures and protects our resources where the federal agencies will be unable to do so.

We write in **STRONG SUPPORT** of **HB86 HD1** which will appropriate moneys to the Department of Land and Natural Resources for the establishment of one full-time equivalent (1.0 FTE) permanent Statewide Makai Watch Coordinator position. We are proud to have been the first State of Hawai'i Makai Watch program on O'ahu.

The Hawai'i Makai Watch Program is a collaborative, statewide initiative where communities become directly involved with the Department of Land and Natural Resources's Division of Conservation and Resources Enforcement (DLNR/DOCARE) in the management and protection of nearshore marine resources through promoting education and compliance to rules and regulations. Created in the early 2000's, the Makai Watch approach is based on the idea that people who utilize, serve, and live closest to our natural and cultural resources are in the best position to help protect them. There are currently over 20 Makai Watch communities across the state collectively contributing to ensuring nearshore marine abundance now, and for future generations.

Mālama Pūpūkea-Waimea (MPW), the organization that stewards the Pūpūkea Marine Life Conservation District, became O'ahu's first Makai Watch community in 2005. In partnership with DLNR/DOCARE, and in collaboration with the Statewide Makai Watch Coordinator, MPW has trained hundreds of volunteers who have conducted thousands of educational interventions and effectively reported hundreds of in-progress violations. This collaborative approach has resulted in an increase of awareness about the rules and regulations protecting our marine resources and a decrease in both intentional and unintentional poaching. This has a direct, positive impact on the nearshore marine environment.

# Testimony Before The House Committee on Finance (FIN) IN SUPPORT OF HB86 HD1

February 24, 2025, 2:00 p.m., Room 308 & Via Videoconference

We are Olan Leimomi Fisher and Kevin Chang, Kuaʻāina Advocate and Executive Director, respectively, testifying on behalf of Kuaʻāina Ulu 'Auamo (or KUA). "Kuaʻāina Ulu 'Auamo" stands for "grassroots growing through shared responsibility," and our acronym "KUA" means "backbone." Our mission is to connect and empower communities to improve their quality of life through the collective care for their biocultural (natural and cultural) heritage, serving as a "backbone organization" that supports creative and community-driven solutions to problems stemming from environmental degradation. Hawaiʻi's biocultural resources continue to be negatively impacted by political, economic, and social changes, and the increasing dangers of climate change make fostering and empowering resilient communities acutely critical.

Currently KUA supports three major networks of: (1) over 40 mālama 'āina (caring for our 'āina or "that which feeds") community groups collectively referred to as E Alu Pū (moving forward together); (2) over 60 loko i'a (fishpond aquaculture systems unique to Hawai'i) and wai 'ōpae (anchialine pool systems) sites in varying stages of restoration and development, with numerous caretakers, stakeholders, and volunteers known as the Hui Mālama Loko I'a ("caretakers of fishponds"); and (3) the Limu Hui made up of over 50 loea (traditional experts) and practitioners in all things "limu" or locally-grown "seaweed." Our shared vision is to once again experience what our kūpuna (ancestors) referred to as 'ĀINA MOMONA – abundant and healthy ecological systems that sustain our community resilience and well-being.

# KUA supports HB86 HD1 as an incremental step towards 'āina momona.

This bill would appropriate funds to the Department of Land and Natural Resources (DLNR) to secure state funding for the full-time permanent Makai Watch Coordinator position.

The state's Makai Watch Program was formed in the early 2000s as a collaborative statewide program where community members and groups can partner with DLNR's Division of Conservation and Resources Enforcement (DOCARE), Division of Aquatic Resources (DAR), and Division of Boating and Ocean Recreation (DOBOR) to help monitor, educate, and promote our state nearshore fishery laws and rules. The program has grown significantly since its inception, now involving collaborations with 21 different communities on five of the main Hawaiian Islands. For over twenty years now, the Makai Watch Program has served to better enable DOCARE, DAR, and DOBOR to more effectively manage the state's nearshore fisheries, which has proven to be far too great a task for one state agency alone to effectively manage without strong community support and partnerships.

KUA was surprised to learn that funding for the state's Makai Watch Program, including the main Coordinator position and two new island-based positions, has to-date received no dedicated state funding, supported only by various grants and federal funding. Individual community groups also need to apply for their own grant funding to participate in this program – a big barrier to effectively gaining more community support and stability to continue participation. Indeed, it is a wonder that this program has continued to grow considering this lack of funding – but we envision how much more it could grow with dedicated state funding. The main Coordinator position was funded in 2019 as part of DOCARE's budget, Program I.D. LNR405/HA, HB2 CD1, Page 646 (2019). Unfortunately, after it was funded, the COVID-19 pandemic began and then a state hiring freeze. Eventually the funding and position lapsed.

Many of the communities in our KUA networks are part of the Makai Watch Program, which serves as a great example of successful community partnerships with the state, building trust and relationships, while also better enabling awareness of and compliance with established state rules. Many others we talked to were unaware that the state provided no dedicated funding for this program, especially given its widespread recognition, support, and community participation. With the current political climate of federal funding in a constant flux, it is evermore important to ensure our state is caring for its own regardless. Establishing state funding for the main Coordinator position for our well-established Makai Watch Program is a good and reasonable place to start.

The communities we work with are committed to ensuring the long-term health of our biocultural resources that they have cared for and depended on for generations since time immemorial. We believe our environment, the foundation of our very existence, is about long-term investment and a vision of 'āina momona. To get there it requires taking the steps necessary for greater self-sufficiency, development of a pipeline of new and more innovative career pathways, mindsets, relationships, and resources for mālama 'āina efforts. Passing this bill out of your committee supports reaching our goal to once again realize the abundant and thriving ecological balance in Hawai'i.

As a woman of East Maui and part of a family of subsistence fishers, I strongly support HB86. Our way of life depends on the health of our nearshore fisheries, which our kūpuna have cared for and relied upon for generations. However, in our rural community, enforcement of fishing laws and resource protections is severely lacking. With limited DOCARE officers assigned to vast areas, illegal harvesting and unsustainable practices often go unchecked, threatening the resources our families depend on.

The Makai Watch Program has been a vital tool in bridging this enforcement gap by empowering local communities to monitor and educate others about conservation laws. However, without dedicated state funding, the program struggles to maintain stability, forcing individual communities to seek their own funding just to participate. A full-time Coordinator would provide consistent support, training, and guidance for rural communities like East Maui, ensuring we have the resources needed to protect our fisheries.

Establishing state funding for this position is a necessary step toward selfsufficiency and sustainable resource management. It would strengthen enforcement, build trust between the state and local communities, and help preserve our subsistence lawai'a traditions for future generations.

I appreciate the significance of community-based stewardship and have witnessed first hand positive impacts to monitoring efforts, which aligns with Native Hawaiian traditional and customary resource management practices. The Makai Watch program fosters statewide collaboration, engaging local community members and nonprofits in marine resource management through education, monitoring, and promoting compliance with conservation rules.
