In consideration of HB935 RELATING TO DIGITAL EQUITY.

Chair Ilagan, Vice Chair Hussey and members of the Committee. The Department of Business, Economic Development and Tourism (DBEDT) provides the following comments on HB935 that establishes and appropriates fund for a digital navigator pilot program to offer technical assistance with computers and electronic devices to residents.

Hawaii Broadband and Digital Equity Office plays a crucial role in advancing the digital navigator work. The Hawaii Digital Equity Plan addresses the community need for devices, internet access, and digital skills training, which will rely on a network of digital navigators—individuals who help communities with access and effective use of digital technology.

We estimate \$100,000 in appropriation for the two-year pilot project for operational needs to include a temporary position hire, travel, advertising, and other operational costs. We ask that the appropriation be added to the general fund line item as opposed to the special fund for the pilot program.

HB 935 - RELATING TO DIGITAL EQUITY

Chair Ilagan, Vice Chair Hussey, and Members of the Committee:

The University of Hawai'i, representing the interests of the State in the implementation of federally funded broadband investments, supports the intent of HB 935 to establish and fund a digital navigator pilot program to offer technical assistance with computers and electronic devices to residents. Support to grow the digital literacy and readiness for all of Hawai'i's residents is key to the Connect Kakou statewide initiative.

The current plan for the state's National Telecommunications and Information Administration (NTIA) Broadband, Equity, Access and Deployment (BEAD) program, includes funding to initiate and deploy, a statewide Community Digital Navigator program, in partnership with the Hawai'i State Public Library System (HSPLS). The program is in its startup phase now, and we anticipate initial services being available from an initial set of HSPLS branches before the end of the calendar year.

Supporting HB935 - "Relating to Digital Equity"

Thank you for this opportunity to share testimony supporting HB935. I support and hope you will amend the measure to highlight the State's need for digital literacy, consumer education and public interest advocacy to achieve digital equity for the Islands.

HB935 proposes to support "digital navigator" services statewide, though the islands of Molokai and Lanai are not included as they should be. By partnering with the State Library, each island can have at least one point of presence for digital equity efforts with up to fifty sites statewide.

Clearly, consumer education is needed to ensure that State agencies effectively protect consumers and engage local resources to address community needs. Digital navigators can support a healthy information ecosystem, increase digital literacy, and ensure that public interests are understood.

Through these pilot efforts, the State can thoughtfully listen and consider local information needs that are not met by the commercial marketplace, including: public health & safety; education; community based economic development; culture & arts; and, civic engagement.

If the proposed "digital navigator" services are matched with information literacy, consumer education and public interest advocacy, this measure could go far to address the lack of information equity across platforms and the digital divide.
