Chair Kahaloa, Vice Chair Kusch and Members of the Committee:

Thank you for the opportunity to testify with comments and an amendment to House Bill No. 967 which establishes a Statewide Interagency Food Systems Coordination Team and Interagency Food Systems Working Group within the Department of Agriculture.

Farmers face costs that are 40% higher on average than those faced by producers in the continental U.S. Biosecurity is driving those costs up every day.

Including local food in our school and state institutions has the potential to positively impact our local farmers as well as our keiki. The need to work together across agencies is paramount toward getting regional food kitchens off the ground.

As we see in those examples, multiple agencies are needed to coordinate on complex issues like biosecurity and school food - the same is true for many other complex issues Hawai'i farmers and the local food system faces such as land, capital and market access. Coordination is essential to make sure we work together effectively.

The Senate Resolution 111 Sustainable Food Systems working group has already completed a report outlining initial priorities for coordinating statewide food systems over the next year. A number of foundations supported this initial work.

The HDOA respectfully requests an appropriation and authorization to hire personnel in addition to the departmental resources that are to be committed to the Statewide Interagency Food Systems Team and the Interagency Food Systems



Working Group to ensure progress is made on key food systems issues like biosecurity and farm to school. HDOA proposes the following amendment to Section 3 of the bill (page 5, line 14 to page 6, line 13):

"SECTION 3. There is appropriated out of the general revenues of the State of Hawaii the sum of ~~\$944,100~~ or so much thereof as may be necessary for fiscal year 2025-2026 and the same sum or so much thereof as may be necessary for fiscal year 2026-2027 to be allocated for the purpose of hiring appropriately skilled personnel to supplement the Department's staff support to be assigned to the Statewide Interagency Food Systems Team and the Interagency Food Systems Working Group, and as follows:

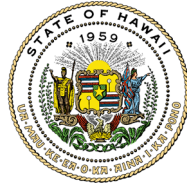
- ~~(1) \$399,300 for the establishment of one full-time equivalent (1.0 FTE) food system specialist position within the department of agriculture;~~
- ~~(2) \$253,400 for the establishment of one full-time equivalent (1.0 FTE) policy analyst position within the department of agriculture;~~
- ~~(3) \$191,400 for the establishment of one full-time equivalent (1.0 FTE) administrative assistant position within the department of agriculture; and~~
- (4) \$100,000 for the establishment and operation of the interagency food systems working group established pursuant to section 2 of this Act, to include conducting stakeholder coordination, public meetings, and information management.

The sums appropriated shall be expended by the department of agriculture for the purposes of this Act."

The HDOA is optimistic that the effort of the Working Group will result in a measurable, science-based, and functional Plan that will promote the State's highest priorities of increasing the economic viability of existing agricultural operations and assist in the establishment of new ones in direct support of increasing local food self-sufficiency and exports.

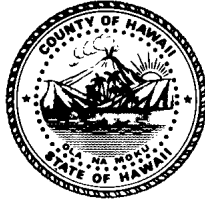



Aloha Chair Kahaloe, Vice Chair Kusch, and members of the committee,

On behalf of Hawai'i Foodbank, I express our support for HB 967, Relating to Food Systems. This bill Establishes the Statewide Interagency Food Systems Coordination Team and the Interagency Food Systems Working Group within the Department of Agriculture; requires reports to the Legislature; establishes positions; and appropriates funds.

As the state's largest hunger-relief organization, Hawai'i Foodbank has been committed to ensuring no one in Hawai'i goes hungry since 1983. We work with over 225 agency partners on O'ahu and Kaua'i to distribute food, and programs like Food 4 Keiki and 'Ohana Produce Plus provide nutritious meals to children and families. Last year, Hawai'i Foodbank provided food for 17.7 million meals and served an average of more than 150,000 people each month. In addition to addressing daily needs, our organization mobilizes during emergencies to provide immediate relief and aid long-term recovery efforts.

Food insecurity is a growing crisis in Hawai'i, with nearly 1 in 3 households struggling to access adequate food. One in ten households go a whole day without food some or most months. A statewide strategy developed in collaboration with partners across the food system is a necessary step to developing a more sustainable and resilient food system in Hawai'i, and we are supportive of this important effort.

Aloha Chair Kahaloe, Vice-Chair Kusch, and Members of the Committee:

I am Brian Miyamoto, Executive Director of the Hawai'i Farm Bureau (HFB). Organized since 1948, the HFB is comprised of 1,800 farm family members statewide and serves as Hawai'i's voice of agriculture to protect, advocate, and advance the social, economic, and educational interests of our diverse agricultural community.

The Hawai'i Farm Bureau supports HB 967, which establishes the Statewide Interagency Food Systems Coordination Team and the Interagency Food Systems Working Group within the Department of Agriculture (DOA). This measure aims to improve coordination among state agencies to strengthen Hawai'i's food system, requires reports to the Legislature, establishes positions, and appropriates funds for its implementation.

A coordinated approach to food system development can help address challenges related to local food production, distribution, procurement, and market access. Farmers and ranchers often face regulatory barriers and logistical challenges that limit their ability to expand local food production. By facilitating collaboration between government agencies and agricultural stakeholders, this initiative has the potential to streamline policies, improve procurement processes, and increase opportunities for farmers to participate in state food programs such as Farm to School and Farm to State.

However, we have concerns regarding the proposed salary amounts for the new positions. Ensuring that salaries align with comparable state positions is necessary to maximize funding efficiency and ensure that resources are directed toward direct support for farmers and food producers rather than administrative overhead.

Additionally, there is uncertainty regarding who the Statewide Interagency Food Systems Coordination Team reports to and where their authority is derived from. Clarification is needed to define their decision-making role, ensure accountability, and prevent

duplication of efforts with existing programs and agencies already working to improve Hawai'i's food system. Without clear oversight and guidance, the effectiveness of these teams may be limited.

To improve HB 967, we recommend:

- Ensuring that farmers and ranchers are actively represented in the working group to provide real-world perspectives on the challenges and opportunities within Hawai'i's food system.
- Adjusting salary levels to be consistent with similar positions within the DOA and other state agencies to ensure fiscal responsibility.
- Defining the reporting structure and decision-making authority of the coordination team and working group to ensure clear oversight and prevent redundancy.
- Developing clear performance metrics and accountability measures to assess the effectiveness of the coordination team and working group in improving food system outcomes.

The significant barriers to local food production span business concerns, land access, water access, cost-of-living, housing capacity, and more. Without a coordinated effort there will be significant barriers to success.

One topic not addressed in this bill is invasive species. Whether it is albizia breaking powerlines and stopping water pumps from providing water for harvest and sanitization, Little Fire Ants discouraging our next generation of Hawai'i grown farmers, Coconut Rhinoceros Beetle/Two Line Spit Bug destroying a cultural resource and food crop, or the mirad of caterpillars, molds, and more destroying existing farm businesses and markets... invasive species have a significant impact on Hawai'i's capacity to host a sustainable and resilient food system.
