Testimony in Support of HCR168

Aloha Members of the Hawaii State Legislature,

I am writing to express my strong support for House Concurrent Resolution 168 (HCR168), which requests clear definitions of wildfire suppression stages in the Hawaii State Fire Code. This resolution is a vital step toward improving wildfire management and public safety in our state.

Clear and standardized definitions, such as "uncontrolled," "contained," "controlled," "extinguished," and "fully extinguished," will significantly enhance communication between firefighting personnel, emergency responders, and the public. This clarity can save lives, prevent property damage, and reduce confusion during wildfire emergencies.

The emphasis on constant monitoring after wildfires are deemed "fully extinguished," specifically requiring 48 to 96 hours of vigilance, is crucial in preventing the recurrence of devastating fires, such as the Lahaina Fire of 2023. Continued vigilance ensures early detection and immediate suppression of potential hotspots.

However, I acknowledge that this resolution presents challenges, including increased resource requirements, financial implications, operational complexity, and enforcement challenges. To address these concerns, I propose the following solutions:

#### 1. Resource Allocation and Financial Support:

Secure dedicated state or federal funding specifically for wildfire monitoring and suppression.

Explore public-private partnerships or grants to alleviate financial strain on fire departments.

#### **Operational Efficiency:**

Implement advanced monitoring technology such as drones, infrared cameras, and automated sensors to efficiently detect hotspots without overly burdening personnel.

Provide comprehensive training for firefighting personnel on new technologies and updated protocols, reducing operational confusion and improving effectiveness.

#### **Flexible Protocols:**

Allow experienced fire chiefs and incident commanders discretion to adjust monitoring durations based on real-time assessments and risk evaluations.

Periodically review and revise guidelines as necessary, ensuring they remain practical, adaptable, and effective in various operational scenarios.

## **Enforcement and Accountability:**

Establish clear accountability measures and reporting requirements to ensure transparency without excessive bureaucratic burden.

Foster inter-agency collaboration to share best practices, improving compliance and effective enforcement.

I firmly believe HCR168, coupled with these proactive measures, will significantly bolster Hawaii's resilience against devastating wildfires. Thank you for your thoughtful consideration of this critical matter.
