- 14 rotating to meet our regulatory commitments. Inspite of these challenges, the HEER Office is

- 1 willing to work with the public and provide an understanding of the Department's role in
- 2 protecting human health and environment, just not in the role as co-chair of the working group.

This year the date is April 10th. Pohakuloa is contaminated with a wide range of toxins, including Depleted Uranium, from 80 years of bombing and shelling millions of live

rounds annually. It's also a high wind area. Taking kids to Pohakuloa to breathe toxic air is like taking kids to Red Hill to drink toxic water. It makes no sense. Across the Saddle Rd from PTA if Gilbert Kahele.Park, formerly Mauna Kea Park. On numerous occasions, our organization detected high levels of radiation, with our certified radiation monitors coming off Pohakuloa toward the park. It's long past time for State and County action to protect the health and safety of Hawaii's people, especially the keiki. Mahalo.

Aloha Chair Takayama, Vice Chair Keohokapu-Lee Loy, and Members of the Committee on Public Safety,

On behalf of our over 20,000 members and supporters, the Sierra Club of Hawai'i **SUPPORTS HCR28/HR27**, which would enable a working group established last year to commence and complete its work assessing and mitigating the significant public safety and environmental health concerns and risks associated with the U.S. Marine Corps' Pu'uloa Range Training Facility (PRTF).

Testing of soil, sand, fish, and residences - including tests conducted by the U.S. Marine Corps - have indicated that significant amounts of lead may have migrated and may be continuing to migrate into the highly popular open spaces, nearshore waters, and neighborhoods and schools adjacent to the PRTF. This includes the movement of lead via erosion, bullet fragments that escape the facility (as documented by community members), and airborne dispersal from lead dust released upon bullet impacts. However, despite their own tests showing extremely high levels of lead in soil samples and despite the Hawai'i Department of Health's urging to further investigate the risks to public health and safety, the U.S. Marine Corps have maintained that no further action is needed on their part to address the community's and Health Department's concerns.

The Sierra Club emphasizes that there is no safe level for lead exposure, which can pose significant risks to human health, and especially for keiki and pregnant women. Even low concentrations of lead can impair nearly all organ systems in the body, with the most severe and irreversible effects on neurological development in children. Childhood lead exposure has been linked to developmental delays, behavioral issues, immunotoxicity, reproductive toxicity, and increased risk of hypertension, kidney damage, and cancer. There is therefore a clear risk that



significant, irreversible, and generational harms may be inflicted upon local families and visitors, including infants, children, and pregnant women, who live, attend school, or recreate in the 'Ewa Beach region surrounding the PRTF. Allowing this risk to continue is simply unconscionable.

By extending and urging the reconvening of the HR18 working group, HCR28/HR27 provides a critically needed opportunity for the public and relevant stakeholders to come together, assess, and mitigate the risk of significant harm to public and environmental health and safety likely being posed by the PRTF. This work is highly time sensitive: not only may toxic lead exposure already be occurring for hundreds of people on a daily basis, but a major storm, tsunami, or similar event may result in a sudden release of lead and other heavy metals from the contaminated berms and soil within the facility, creating an even higher level of exposure risk that may be exponentially more difficult to remediate.

Therefore, the Sierra Club of Hawai'i respectfully urges the Committee to **PASS** this measure. Mahalo nui for the opportunity to testify.

I am writing in **strong support of HR27/HCR28** which urges the Department of Health to reconvene the working group established pursuant to House Resolution No. 18, H.D. 1 (2024), to continue addressing the critical issues of water and air contamination and remediation stemming from the operation of the Pu'uloa Range Training Facility (PRTF) in 'Ewa Beach, Oahu.

As documented in House Concurrent Resolution No. 22 (2024), the PRTF, a century-old Marine Corps shooting range, poses significant environmental and public health risks due to lead contamination in its impact berms, which border residential neighborhoods and a busy beach park. Soil sampling by the Surfrider Foundation in 2022 revealed elevated lead levels on the beach side of the facility, raising concerns about leaching into the ocean, contamination of nearshore coral reefs and marine life, and airborne dispersion into nearby communities. The working group established in 2024, set to dissolve on June 30, 2025, has been tasked with addressing these urgent threats, yet it has never convened a meeting, and substantial challenges remain unresolved.

Further evidence of the ongoing crisis is detailed in a November 15, 2023, letter from 'Ewa Neighborhood Board members Liam Chinn and Alexander Gaos to Congressman Ed Case. The letter highlights deficiencies in the Marine Corps Base Hawaii's (MCBH) Sampling and Analysis Plan, including the refusal to test lead contamination in downwind residential areas or the nearshore coral reef environment and sea life, inadequate monitoring frequency, and the lack of a comprehensive remediation strategy for the heavily contaminated Alpha and Bravo berms, which constitute 80% of the facility's contaminated soil. These shortcomings underscore the need for continued oversight and action beyond the current working group's term. The Ewa Neighborhood Board, Hawaii State House, and Senate have all passed resolutions—specifically Ewa Neighborhood Board Resolution (March 29, 2023), House Resolution No. 104 (2023), and Senate Resolution S.R. No. S.D. 1 (2023)—deeming the Pu'uloa Range Training Facility incompatible with its surroundings and calling for the relocation of live fire training away from its current site. These resolutions highlight not only the environmental contamination but also the severe noise pollution, safety hazards from stray bullets, and disruption to community infrastructure, such as the closure of a tsunami evacuation route.

Until such time that live fire training can be permanently relocated, the full extent of contamination must be identified so proper remediation can be initiated to protect the health of residents, marine ecosystems, and future native Hawaiian families slated to reside in approximately 600 homes planned by the Department of Hawaiian Home Lands (DHHL) adjacent to PRTF.

The health and safety of Ewa Beach residents, marine ecosystems, and public spaces like Pu'uloa Beach Park remain at risk without sustained collaboration among stakeholders, including the Department of Health, MCBH, community representatives, and environmental experts. HCR28 and HR27 would ensure the working group's efforts persist, providing a framework for transparent, science-based solutions to this environmental and public health emergency.
