The West Oahu Kennel Club is an organization that puts on 4 all-breed conformation dog shows licensed by the American Kennel Club yearly. The club holds its shows at an elementary school over the weekend which gives us access to the space necessary to set up 2 50' x 50' rings and 2 20' x 40' tents for shade where the individual handlers can wait with their dogs for judging. Additionally, the exhibitors usually set up their own tents as a base for grooming their dogs before entering the ring.

As the Show Chairperson for the club, finding a school that could accommodate our shows after COVID was difficult. Since we have to apply for the AKC license at least 6 months in advance, we need to have a place that we know will be available to us. West Oahu Kennel Club is licensed by the American Kennel Club for the island of Oahu west of Red Hill. Having an area in the Kalaeloa parklands dedicated for dog activities would be ideal.

More importantly, it would be beneficial to have a secure location for people to learn more about their pets, congregate with fellow pet owners, and hold training classes for their pets without interfering with other people's enjoyment of the park.

Hello, my name is Sara Barker, and I own and operate a dog training business by the name of Ember Paws Dog Training. I offer affordable dog training via private sessions and group classes to dog owners across the island, and even providing services of residence on Kauai, Maui, and the big Island. I specialize in basic obedience training as well as training task trained service dogs to assist disabled individuals with various disabilities. As a dog trainer and small business owner here in Hawaii, I have come across so many struggles with being able to provide services to pet owners who so desperately need affordable dog training, primarily due to the lack of pet friendly parks, and the additional permitting requirements in order to help dog owners and their furry friends. Having a dedicated park for dog training and events would eliminate the burden that I have as a small business owner, of not only trying to find a pet friendly park, but will also eliminate the time put into having to request a permit for every training session. Due to Hawaii's strict requirements, I have ultimately had to provide group classes in my very small backyard, which is quite difficult when more than 3 dogs are in a class. Having a larger dedicated space where trainers would be able to offer group classes would mean we would be able to help even more dog owners train their dogs, thus increasing the taxes that I pay out yearly, while also effectively reducing the number of dogs in our over filled animal shelters and rescues due to lack of training.

As well as being a dog trainer and business owner, I am also an active participant and volunteer for all things dog sports. My dogs actively participate in FastCAT and Agility, and I would absolutely love to participate in other dog sports such as dock diving and barn hunt which are not yet started here in Hawaii, but there is a huge demand for it. As a volunteer for Terriers in Paradise and the Shetland Sheepdog Club of Hawaii, I have personally experienced the hardships we as volunteers and club organizers have to deal with due to not having a dedicated space for dog events. As a volunteer on FastCAT days, we spend nearly 13 hours a day working hard for the clubs so they can provide a fun activity for Hawaii dog owners. About 4 of those hours is just for set up and take down. Having a dedicated space would allow for us to leave up the FastCAT track overnight, or better yet, have a permanent FastCAT track so the 20 other dedicated volunteers can spend more time helping in other areas of the event. Hawaii also doesn't have a single location for dock diving which is an easy sport just about anyone can do with their dog. I have had nearly 50 different clients come to me about wanting to get started in dock diving, but we have no place that has enough space for NADD (North American Diving Dogs) event regulations and requirements. Having a dedicated facility would allow for us to actually bring dock diving to Hawaii, where dog owners would be able to take paid dock diving lessons and

participate in dock diving events. I know several other people who would fly in from other islands just to participate in dock diving, which would help boost Oahu's economy and support local small businesses. And while I myself will not be living here much longer, I would absolutely come back to support Hawaii's dog sports, trainers, clubs and events, and I know several others who will do the same.

For those reasons, I am in support of HCR68.

The Pacific Pet Alliance is a Hawai‘i non-profit organization that promotes responsible pet ownership through education and advocacy.

The Pacific Pet Alliance (PPA) would like to submit testimony in support of HCR 68.

Oahu has no animal friendly venues that are suitable for education and training purposes especially on the leeward coast. Ewa Beach Community Park is the only dogs friendly park where clubs can hold large events such as dog shows and canine performance. There are also no indoor facilities that can hold 4H groups, animal educational seminars, or cat/rabbit/ bird shows that require a secure indoor venue at a reasonable cost to non-profit clubs.

Imagine trying to use ranches at \$1000 @ day or the outdoor venue at the Kroc Center for \$300 an hour or being told your 4H groups could use the facilities but the kids aren’t allowed to bring their animals. Oahu also lacks a public fairgrounds. All of this seems to go against the State’s mission of agricultural sustainability. Such a facility would go a long way to benefit the community and add to our quality of life.

The Pacific Pet Alliance respectfully requests the support of the Hawaii State Legislature for this much needed facility in our community. Thank you for this opportunity to testify.

Dear Chair Wakai and Members of the Senate Committee on Energy and Intergovernmental Affairs:

The American Kennel Club (AKC) writes today on behalf of the Pacific Pet Alliance, our Hawaii kennel clubs and the many responsible dog owners in the community to respectfully ask you to include a ten-acre animal education and training facility within the recently deeded 400 acres of former Navy-owned land of Kalaeloa for public park and public recreational area purposes. This addition would allow for Hawaiians to enjoy public spaces, promote responsible pet ownership—leading to less animals ending up in the shelter system – and generate significant economic impact to the region.

There is a tremendous need for such a project as the needs of the animal community on O‘ahu have been overlooked. Given the restrictions in place in city parks and the competition for park usage with other sports groups, it’s extremely difficult to find suitable and animal -friendly venues for dog shows, dog sports, cat shows, bird shows, and 4H groups.

A robust animal education and training facility would also have economic benefits for the island. In 2023, 6700 people and participated in 130 dog events in Hawaii. The AKC estimates that the economic impact of [dog shows is vast](#). Surveys demonstrate that exhibitors at AKC conformation dog shows spend an average of \$982 per show weekend. This means spending by AKC dog show exhibitors for a show weekend could inject more than \$2.15 million into the local economy. And this amount does not include spending for events such as Agility, Rally, Obedience, and similar competitions. With a dedicated sports complex for these and other dog events, it is likely that the number of participants could increase, generating several million dollars into the local economy.

Additionally, the AKC believes wholeheartedly in promoting responsible dog ownership. Not only is this beneficial to dog owners and the dogs themselves, but it is good for the broader community. Unfortunately, [one major reason for a dog to be surrendered](#) to a shelter is when the owner is not able to handle the animal as it has not been properly trained. An animal education and training facility within the Kalaeloa Parklands with readily available obedience classes could both increase the enjoyment of dog ownership and serve to reduce one of the causes of dogs ending up in the shelter system. Furthermore, AKC competitions and events held at the complex would provide more opportunities for the community to enjoy activities with their dogs and further support and promote responsible pet ownership and training. In order for complex to be able to accommodate as many activities as is feasible, the site should include: bathrooms, parking, secure indoor meeting and exhibition rooms, food preparation facilities, and secure storage areas.

An animal education and training facility within the Kalaeloa Parklands would serve to benefit both people and their animals, increase the practice of responsible pet ownership, and generate a significant economic impact for the local economy.

The AKC appreciates the state’s attention to increasing the opportunities of pet-owning Hawaiians in accessing public spaces. Thank you for reviewing our recommendations for the Kalaeloa Parklands.
