Strong Support for House Concurrent Resolution No. 94 – Requesting the Governor to issue a proclamation designating Hawai'i as a Purple Heart State on August 7, 2025.

WRITTEN TESTIMONY ONLY

Honorable Chair, Vice Chair and Members:

Thank you for the opportunity to offer testimony in **strong support** for House Concurrent Resolution No. 94. This resolution is a formal request to the Governor to issue a proclamation to designate Hawai'i as a Purple Heart State on August 7, 2025. This designation proposes to honor and express gratitude to our veterans who were injured or killed while serving our nation in combat.

On May 6, 2024, Honolulu Mayor Rick Blangiardi approved Ordinance 24-7, which was introduced by Councilmember Augie Tulba as Bill 7 (2024). Ordinance 24-7 declared Honolulu a Purple Heart City. This resolution seeks to expand the designation at the state level.

The Institute of Heraldry is agency of the United States Army and provides the following synopsis of the Purple Heart on their website:

“The original Purple Heart, designated as the Badge of Military Merit, was established by General George Washington by order from his headquarters at Newburgh, New York, August 7, 1782. The writings of General Washington quoted in part:

The General ever desirous to cherish a virtuous ambition in his soldiers, as well as to foster and encourage every species of Military Merit, directs that whenever any singularly meritorious action is performed, the author of it shall be permitted to wear on his facings over the left breast, the figure of a heart in purple cloth or silk, edged with narrow lace or binding. Not only instances of unusual gallantry, but also of extraordinary fidelity and essential service in any way shall meet with a due reward”.”

Good Morning Chair Lee, Vice Chair Inouye, Members of the Committee,

I am in **Strong Support** of HCR94, which is REQUESTING THE GOVERNOR TO ISSUE A PROCLAMATION DESIGNATING HAWAII AS A PURPLE HEART STATE ON AUGUST 7, 2025.

Before I testify, I would like to introduce myself. I am not a recipient of this prestigious award, nor am I submitting testimony for my own personal benefit. I am simply Sergeant Jiang, a proud United States Army active-duty veteran. I served for 5 years, have been overseas once, and I had a CONUS assignment. My MOS was a 13F, but my MOS code was 13F30L7. I was a Fire Support Specialist, a Forward Observer, but most importantly, a soldier. I worked with Field Artillery and was attached to the infantry. I was the person with the radio that performed reconnaissance, intel, and provided artillery fire, but I was also able to work with the infantry's mortar platoons, the air force's fighters, and the navy's ships.

I believe the designation of Hawaii as a Purple Heart State would let veterans, especially recipients of the incredibly honorable award be recognized. Bringing light to not only the honor and glory, but the pain and sadness as well. This will not only raise awareness for our veterans, but also preserving and educating our future generations. Given Hawaii's deep military history, This resolution would assist in raising awareness for its designated day, as well as our troops. The Purple Heart award is awarded to those who have been wounded or made the ultimate sacrifice protecting our freedom, values, and the fundamentals we built America on. While its true that there are mixed feelings in Hawaii about the military presence, we cannot overlook the sacrifices made by those who wear our uniform, many even calling this place home. Regardless of politics and personal feelings towards the matter, we must find gratitude. Honoring those recipients is about recognizing the human cost of service and those the individuals that stepped forward to protect those who didn't or couldn't. Without our Armed Forces, we may not be living the lives we are living today. Hawaii's involvement with the military first started when it was seen as a strategic location in the Pacific. As a Ranger in the United States Army, I have been deployed to combat zones.
