The Hawaii Military Affairs Council ("MAC") **supports** HCR121 / HR117.

The MAC was established in 1985 when the Chamber was appointed by the State to serve as the liaison to the military. The MAC advocates on behalf of Hawaii's military, and is comprised of business leaders, academic institutions, State and County officials, members of the CODEL, community leaders, labor unions and organizations and retired U.S. flag and general officers. The MAC works to support Hawaii's location as a strategic U.S. headquarters in the Indo-Asia-Pacific region which is crucial for U.S. national and homeland security.

The Military Affairs Council has been working with the Hawaii Department of Transportation, Army Garrison Hawaii and Navy Region Hawaii to provide safe passage along Kolekole Pass in time of emergency, whether natural or man-made. There was a practice run with Hawaii Emergency Management Agency and partners in February. We are grateful to HDOT for making early investments in road improvements. The Army and Navy are committed to do their part and are requesting funds as a part of this partnership. The Hawaii Congressional Delegation is also a most supportive partner in this collective commitment to ensure that Oahu's westside community members will have an alternative road to get to safety in time of emergency.

**I STRONG SUPPORT of HR 175 /HCR 179 which convenes a legislative working group for a paid family and medical leave program for the state.**

We are an aging population and must rely on our children to help with our well-being at the cost of losing their jobs.

It is important that the working group develop recommendations on a paid family leave policy and program that supports working family caregivers to better balance their job and family responsibilities, reducing their stress and allowing them to better support their loved ones

As I age, I wonder what will happen if I need my children to relocate so they can be my caregiver. Will this mean they will lose their current employment; will they be able to find a new job should they relocate. Will they be able to take paid family leave if available at their job site.
