AN ANNUAL FESTIVAL CELEBRATING PACIFIC ISLAND CULTURE AND ARTS**

Dear Chair Kapela and members of the Committee,

The SFCA is pleased to SUPPORT H.R. 158/H.C.R. 163 which urges the State Foundation on Culture and the Arts to establish an annual festival celebrating Pacific island culture and arts.

In 2024, the State Foundation on Culture and the Arts (SFCA) participated in Hawaii's hosting of the 13th Festival of Pacific Arts and Culture (FestPAC) with uniquely created exhibitions and presentations featuring Hawaiian traditions and art forms. FestPAC took place from June 6-16, 2024. During this time, the SFCA, Hawaii State Art Museum/Capitol Modern launched *Ke Ao Lama - Enlightened World*, a showcase of Pacific peoples, ingenuity and creativity. Through this collective of exhibitions, Capitol Modern showcased the proliferation of Pacific culture, from traditional practice to contemporary expression that highlights the evolution of enlightened indigenous thought and creativity. The Festival brought 13,688 guests to the Hawaii State Art Museum during the month of June 2024. The SFCA invested over \$800,000 of Federal, State and Special Funds in hosting the Festival of Pacific Arts and Culture at the Hawaii State Art Museum. This included over forty hotel rooms for native Hawaiians living on the neighbor islands to travel to Oahu to present during the festival.

Through this experience, the State Foundation on culture and the Arts is committed to an annual Ke Ao Lama Festival contingent on availability of funding and staff resources.
