Testimony on S.B. 1061 – RELATING TO DIGITAL EQUITY

Chair DeCoite, Vice Chair Wakai, and Members of the Committee:

Thank you for the opportunity to provide testimony in support of S.B. 1061. We respectfully request that the Committee also consider incorporating additional provisions contained in S.B. 1045.

The federal and state governments have committed over \$400 million to modernize our subsea and terrestrial infrastructure and equip residents with the tools and knowledge to safely navigate the internet. With this once-in-a-generation funding commitment, it is crucial that our state broadband policies and programs are comprehensive and holistic. While S.B. 1061 establishes funds for a digital navigator pilot program, S.B. 1045 goes further by allocating federal funding for digital navigators, transferring the Broadband Office from the Department of Business, Economic Development, and Tourism (DBEDT) to the Office of Enterprise Technology Services (ETS) in the Department of Accounting and General Services, creating a Broadband Infrastructure Special Fund, and consolidating various broadband functions throughout state government.

As broadband becomes increasingly essential in our daily lives, transferring the Broadband Office provides an opportunity to centralize broadband responsibilities currently spread across state agencies, including the duties of the Director of the Department of Commerce and Consumer Affairs and the Hawaii Broadband Assistance Advisory Council. Our office will work closely with the relevant departments to compile all broadband functions for the Legislature's consideration. Additionally, with the construction of new subsea broadband infrastructure, our state expects to generate revenue from negotiated lease agreements. Creating a special fund will ensure these revenues are used to lower the cost of internet services, provide technical assistance to communities, and support broadband projects.

The University of Hawai'i, representing the interests of the State in the implementation of federally funded broadband investments, supports the intent of SB 1061 to establish and fund a digital navigator pilot program to offer technical assistance with computers and electronic devices to residents. Support to grow the digital literacy and readiness for all of Hawai'i's residents is key to the Connect Kakou statewide initiative.

The current plan for the state's National Telecommunications and Information Administration (NTIA) Broadband, Equity, Access and Deployment (BEAD) program, includes funding to initiate and deploy, a statewide Community Digital Navigator program, in partnership with the Hawai'i State Public Library System (HSPLS). The program is in its startup phase now, and we anticipate initial services being available from an initial set of HSPLS branches before the end of the calendar year.
