- 1 **Fiscal Implications:** This measure imposes additional responsibilities for the Department of  
2 Health ("Department") but does not include an appropriation for the necessary resources.
- 3 **Department Testimony:** The Office of Medical Cannabis Control and Regulation (OMCCR)  
4 provides the following testimony on behalf of the Department.

5 The Department appreciates the intent to address unauthorized operation of a  
6 dispensary, particularly given the rise in unlicensed and unregulated retailers selling intoxicating  
7 cannabinoid products, posing risks to public health and safety. However, the Department has  
8 concerns about the personal safety of Department staff issuing administrative cease and desist  
9 notices to illegal cannabis retailers operating in violation of criminal code. In regulating medical  
10 cannabis and hemp-cannabinoid products, the Department collaborates with and relies on the  
11 support of state and county law enforcement agencies to address non-compliance and more  
12 serious criminal offenses. We defer to these agencies to resolve conflicts that may escalate to  
13 the arrest, raid, search, seizure, or other civil or administrative actions associated with the  
14 unauthorized operation of a dispensary.

1           The Department respectfully notes that exempting permitted “hemp processors, hemp  
2   product retailers, or hemp produce retailers”, as proposed on page 3, lines 9 to 12, may provide  
3   an unintended loophole in the law allowing an unlicensed dispensary to obtain a hemp  
4   processor permit and market illicit cannabis, under the guise of hemp, without being  
5   subjected to the new enforcement authorities proposed in this measure.

Dear Chair Dela Cruz, Chair Rhoads and members of the Joint Committees:

We submit this testimony on behalf of Cure Oahu in **support** of **S.B. 1064, SD1**, which 1) prohibits persons from operating a medical cannabis dispensary without a license from the Department of Health, 2) prohibits individuals from providing certain services to individuals engaging in unlicensed cannabis operations, 3) requires the Department of Health to send a cease and desist notice to violators, and 4) establishes criminal penalties.

The purpose of this bill is to provide the Department of Health with clear enforcement tools to shut down illegal websites that are significantly impacting the regulated medical cannabis industry. There are numerous websites that are currently operating and advertising their sale of cannabis products, some which acknowledge that Hawaii is a medical cannabis only state, but some that do not and still openly sell cannabis products.

We appreciate the prior committee's amendments made in the SD1, which narrow the scope of the original language and add language relating to enforcement.

We respectfully ask that the Committees move this measure to continue discussions on how to provide the department with the appropriate enforcement authority to shut down illegal activity.

Thank you for the opportunity to submit testimony in support of this measure.

**Subject: SB 1064 Testimony - STRONGLY OPPOSE**

*No law shall limit how much food and medicine you can legally grow for your own family and community.*

This bill will CRIMINALIZE FARMERS who have the innate human right to grow cannabis for themselves and their communities WITHOUT a government license.

How evil and/or incompetent does a legislator need to be to support the use of taxpayer dollars to dispatch law enforcement to fine, harass, steal, and destroy Hawaiian farmers and farming operations just to protect the interests of the corporate-State cannabis monopoly on growing, processing, and distributing a natural plant medicine to the community? As a civil servant and political leader, are you so desperate and greedy that you MUST tax a plant crop to fill your coffers?

Perhaps you do not even realize that that your actions - such as this specific bill - are directly undermining and sabotaging many farmers in Hawaii's socially/environmentally equitable, regenerative agricultural movement because you are so detached from your food and from the 'āina which provides for us ALL, that you cannot comprehend the concept of actually SUPPORTING farmers so you continue to hinder and micromanage the vast majority of them into financial bankruptcy with your corporate-minded, ag community-absent legislation.

### **Unlicensed Vs. Licensed Farms**

Cannabis cultivation, along with organic food cultivation, is our natural human right and civil liberty. Just ask Carrie Ann Shirota at the Hawaii American Civil Liberties Union if you are still confused about the ethics of government regulation, interference, and encumbrance with community self-sufficiency and regenerative organic agricultural practice and production.

Therefore, it is every individual's CIVIL RIGHT to cultivate cannabis for one's self, family and friends. Cannabis cultivation is a right to medical and agricultural self determination and a financially-sustainable traditional system of community-driven healthcare that balances both community-grown economic and medical support from within.



**Any individual who is farming and cultivating THC products NOT for public retail or wholesale sales should NOT be required to obtain and maintain a license or pay taxes on cannabis cultivation.**

**Furthermore, any individual who is farming and cultivating cannabis products WITHOUT THC (i.e. seeds, plants, clones, hemp products, etc.) for public retail or wholesale sales should NOT be required to obtain and maintain a “dispensary” license.**

Cannabis cultivation on private property, shared between family and friends is none of the government's business and the State of Hawaii has no right to institute mandatory licensing and taxes on those individuals.

### **Social Equity and Fair Compensation for Farm Laborers**

It is very apparent that these bills are written by individuals who have ZERO experience farming, let alone ZERO personal experience using the cannabis plant for its intended medicinal and spiritual purposes. That lack of experience is evident in the lack of foresight regarding who will be doing the actual cannabis farming. The lack of experience of the authors who wrote these cannabis bills is also evident in their glaring ignorance regarding the immense difficulty to be a career farmer in Hawaii dealing with the numerous detrimental factors and uncertainties that make farming so financially costly and psychologically draining that the average person is physically and mentally INCAPABLE of successfully (profitably) farming in the long run, year after year. Most beginning farmers in Hawaii (namely GoFarm graduates) fail to continue farming consistently past the 3 year mark, and even fewer can claim to still be farming seriously after 5 years.

Therefore, it is incredibly naive and glib for the champions of these shortsighted cannabis legalization bills to simply state with such a blind certainty that this “budding industry” will produce many valuable jobs for local people to afford to continue living here in Hawaii.

Historically, farm workers were routinely exploited for cheap labor. Plantation workers were fundamentally one step above indentured servitude and slavery. Historically, immigrant populations are routinely imported and exploited for cheap labor because they are vulnerable communities with limited socioeconomic opportunities and alternatives. Historically, this was the ONLY way for the plantation corporations to remain profitable.



Unless the State of Hawaii is going to ensure tourism-subsidized HEALTHCARE and HOUSING for Hawaii's farmers, there will be NO SOCIAL EQUITY and NO FARMERS to grow Hawaii's agricultural industries.

NO FARMERS = NO FARMS = NO FOOD or MEDICINE

Report Title: DOH; Medical Cannabis; Licensure; Requirement; Penalty

Description: Prohibits persons from operating a medical cannabis dispensary or producing, manufacturing, or selling cannabis products without a license from the Department of Health. Prohibits individuals from providing certain services to individuals engaging in unlicensed cannabis operations. Requires the Department of Health to send a cease and desist notice to violators. Establishes criminal penalties.

Aloha Chairs, Vice Chairs, and committee members,

My name is Karlyn Laulusa and I am the CEO of Noa Botanicals, a medical cannabis licensee. I stand in strong support of SB1064 and I would like to recommend amendments to address some concerns from the cannabis community.

For context, much of the opposing testimony is from the local grower community and my recommended amendments should help to address those concerns. This bill should be aimed at illegal cannabis dispensaries that are operating an online platform or retail store in a commercial property.

Language that specifically identifies online platforms or retail store operators will prevent any potential misinterpretation by regulators or enforcement related to caregivers, local growers, etc.

In terms of testimony provided by the Department of Health (DOH) related to budget and staffing concerns I'd like to highlight that licensing fees increased by \$76,000 from 2023 to 2024 with no increases in facilities – and the lowest patient participation since 2021. Further the department has \$11M that it has collected in said fees but has yet to deploy. Those funds could be used to add additional support for the administrative processes that would result with the implementation of said changes.



Again, the bill as written allows for misinterpretation even with sections F1 and F2. Below are my recommended amendments:

SECTION 1. Chapter 329D, Hawaii Revised Statutes, is amended by adding a new section to be appropriately designated and to read as follows:

**"§329D- Unauthorized operation of a dispensary; criminal penalty.** (a) It shall be unlawful for any person to operate a an online or retail cannabis dispensary without a license from the department pursuant to this chapter.

(b) No person shall intentionally, knowingly, or recklessly provide commercial real estate or other real property to a retail cannabis seller without a license from the department pursuant to this chapter.

~~(b)~~ (c) No person shall intentionally, knowingly, or recklessly operate any search platform, web hosting services, social media platform, or other entity that posts information advertising the sale of cannabis products by an unlicensed person or entity engaged in the production, manufacture, or sale of cannabis or manufactured cannabis products without a license pursuant to this chapter.

~~(e)~~ (d) The department shall issue a cease and desist notice to any person or entity who violates subsection (a) or (b) or (c); provided that the cease and desist notice shall be issued before initiating criminal proceedings.



(d) Any person who violates subsection (a) shall be guilty of a class C felony.

(e) It shall be an affirmative defense to subsection (b) that the person providing commercial real estate or other real property to a retail cannabis seller without a license from the department pursuant to this chapter that participates in the sale of cannabis products had requested, examined, and reasonably relied upon a license that appeared to have been issued by the department that was shown by the unlicensed person or unlicensed entity engaged in the production, manufacture, or sale of cannabis or manufactured cannabis products establishing that the unlicensed person or unlicensed entity was licensed by the department to engage in the production, manufacture, or sale of cannabis or manufactured cannabis products pursuant to this chapter. The failure of the person providing commercial real estate or other real property to a retail cannabis seller to request and examine a license issued by the department from the unlicensed person or unlicensed entity engaged in the production, manufacture, or sale of cannabis or manufactured cannabis products before providing commercial real estate or other real property and form a conclusive basis for the person's violation of this section.

~~(e)~~ (f) It shall be an affirmative defense to subsection (c) ~~(b)~~ that the person operating any search platform, web



hosting services, social media platform, or other entity that posts information advertising the sale of cannabis products had requested, examined, and reasonably relied upon a license that appeared to have been issued by the department that was shown by the unlicensed person or unlicensed entity engaged in the production, manufacture, or sale of cannabis or manufactured cannabis products establishing that the unlicensed person or unlicensed entity was licensed by the department to engage in the production, manufacture, or sale of cannabis or manufactured cannabis products pursuant to this chapter. The failure of the person operating any search platform, web hosting services, social media platform, or other entity that posts information advertising the sale of cannabis products to request and examine a license issued by the department from the unlicensed person or unlicensed entity engaged in the production, manufacture, or sale of cannabis or manufactured cannabis products before providing access to any search platform, web hosting services, social media platform, or other entity that posts information advertising the sale of cannabis products shall be construed against the person operating any search platform, web hosting services, social media platform, or other entity that posts information advertising the sale of cannabis products and form a conclusive basis for the person's violation of this section.

(f) This section shall not apply to:



(1) Hemp processors, hemp product retailers, or hemp produce retailers with a valid permit under chapter 328G; or

(2) Primary qualified caregivers registered under chapter 329 who are acting within the scope of their permit or registration."

SECTION 2. This Act does not affect rights and duties that matured, penalties that were incurred, and proceedings that were begun before its effective date.

SECTION 3. New statutory material is underscored.

SECTION 4. This Act shall take effect on December 31, 2050.

**KEY COMPONENTS:**

- Expands the medical cannabis program to allow island-wide access to medical cardholders.
- Expands the medical cannabis program to allow unlimited licensing—with strict size regulations—resulting in buy-in from small, community-based businesses and local cultivators, significantly reducing the black market.
- Forms a regulatory system to allow cultivation, wholesaling, and delivery.
- Provides an affordable avenue for people with little means to start a cultivation farm business.
- Allows reciprocity for out-of-state medical patients.
- Provides a non-law enforcement inspection framework that enables the program to operate efficiently and has a low start-up cost for the state to initiate the program.
- Provide limits and rules for the size of the business, preventing large business monopolies.
- Provides comprehensive farming practice regulations that offer responsible stewardship for the land and farming practices such as Korean Natural Farming
- Provides clear compliance guidance related to product testing and removes unnecessary regulations.
- Builds a tax structure that allows state auditors to oversee cannabis businesses to ensure compliance with the regulatory framework and prevent diversion.
