On the following measure: S.B. 1272, RELATING TO TOWING

Chairs Keohokalole and Lee and Members of the Committees:

My name is Melissa Lam, and I am an Enforcement Attorney at the Department of Commerce and Consumer Affairs' (Department) Office of Consumer Protection (OCP). The Department offers comments on this bill.

Tow companies are regulated by state law, which sets how much they can charge for a regulated tow (§ 290-11, HRS), subject them to penalties for violations of consumer protection law (§ 480-2, HRS), describe how they must handle tows requested by the police for disabled motor vehicles (§ 291C-165.5, HRS) and require them to have adequate signage and insurance coverage for their tow trucks (§ 291C-135, HRS). Under existing state law, OCP is authorized to investigate and bring enforcement actions for violations of consumer protection laws committed by tow companies. In addition, each

county has the power to enact and enforce ordinances regulating towing operations (§ 46-1.5(27), HRS).

While the Legislature has adopted several measures to regulate towing companies and protect individuals from predatory practices, towing is an industry that generates numerous complaints to OCP. Owners whose vehicles are being towed are vulnerable to exploitation at the hands of the towing company, due to an inherent imbalance of power. Knowing that individuals need their vehicles back as soon as possible, unscrupulous towing companies may insist on cash payments or tack on illegitimate fees. The company is likely to offer terms on a take-it or leave-it basis, secure in the knowledge that very few vehicle owners are likely to pursue a dispute.

This bill would provide government oversight of the towing industry and afford additional protection for vehicle owners by requiring all towing companies to meet certain minimum standards in order to legally operate. The Towing Authority would have to ability to suspend, revoke or decline to review licenses for violating state towing laws.

The Department appreciates the bill's intent to regulate the towing industry and to provide minimum qualifications for towing companies. Nonetheless, the Department is of the position that the creation of the Towing Authority may benefit from a more in-depth study outside of the legislative session.

Section 3 of this bill seeks to amend HRS § 46-20.5. The Department recommends that the language should specify that the counties cannot enact an ordinance that provides less consumer protections than state law.

OCP is willing to work with the introducer and committee members to explore legislation that would incentivize towing companies to come into compliance with existing law.

Subject: Opposition to Senate Bill No. 1272 – Towing Regulations

I strongly oppose Senate Bill 1272, which seeks to establish a new towing authority and impose excessive licensing and regulatory burdens on towing operators in Hawaii. While consumer protection is important, this bill goes far beyond reasonable oversight, harming small businesses and introducing costly, unnecessary bureaucracy with no clear financial accountability.

Burdens on Small Businesses

The bill's licensing and compliance requirements are excessive, disproportionately affecting small towing businesses that already comply with county regulations. Additional costs for licensing, insurance, and facility upgrades will push smaller operators out of business, leaving only large corporations to dominate the industry.

Increased Costs and Unclear Fees

This bill creates a Towing Authority without detailing how much funding will be required or where the money will come from. If towing operators are expected to fund it through unspecified fees, it creates financial uncertainty that could make business operations unsustainable.

Unethical Political Maneuvering

SB1272 sneaks in unrelated provisions affecting county-level powers, homelessness policies, and nonprofit exemptions—none of which belong in a towing bill. This kind of political nonsense undermines the bill's integrity and distracts from real industry concerns. If lawmakers want to address these issues, they should do it in a separate, transparent bill—not tack them onto towing regulations to push through their agenda.

Conclusion

Instead of creating another layer of costly bureaucracy, the Legislature should focus on enforcing existing county towing regulations and targeting actual predatory practices. SB1272 is harmful, unnecessary, and a burden on small businesses—I urge the committee to reject it.
