Chair Elefante and Members of the Committee:

The Department of the Attorney General (Department) strongly supports this bill and offers the following comments.

This bill amends section 134-9.6, Hawaii Revised Statutes (HRS), to amend the annual reporting requirements for the Department and the chief of police of each county concerning licenses to carry firearms.

The bill removes the deadline of April 1 for the Department to publish its annual report, which will allow the Department time to complete the required aggregation of the data it receives from the county police departments. The report is still due annually.

The bill extends the date that the county police departments provide the data to the Department from February 1 to March 31 of each year for the prior calendar year, allowing the county police departments additional time to provide the data to the Department.

The amendments in the bill will give the county police departments more time to provide reportable data and will give the Department sufficient time to complete the annual report with its existing resources.

We respectfully ask your Committee to pass this bill. Thank you for the opportunity to provide testimony.

Testimony in Opposition to Senate Bill SB1314

Aloha,

I am writing to express my strong opposition to Senate Bill SB1314, which seeks to amend the annual reporting requirements imposed on the Department of the Attorney General and the chief of police of each county regarding licenses to carry firearms. As a staunch supporter of the 2nd Amendment, I believe this bill infringes upon the fundamental rights of law-abiding citizens to bear arms and protect themselves.

The 2nd Amendment of the United States Constitution guarantees the right of the people to keep and bear arms. This right is essential for self-defense, the protection of property, and the preservation of individual liberties. By imposing additional reporting requirements on firearm licenses, SB1314 could be seen as an infringement on these constitutional rights.

Legal Justifications: The 2nd Amendment states, "A well regulated Militia, being necessary to the security of a free State, the right of the people to keep and bear Arms, shall not be infringed". The Supreme Court has affirmed this right in landmark cases such as District of Columbia v. Heller (2008), which recognized an individual's right to possess firearms for lawful purposes, including self-defense within the home. Additionally, McDonald v. Chicago (2010) extended this protection to state and local governments. These rulings underscore the importance of the 2nd Amendment in safeguarding individual liberties against government overreach.

In Hawaii, the state constitution mirrors the U.S. Constitution in protecting the right to keep and bear arms. However, recent rulings by the Hawaii Supreme Court have challenged this interpretation. For example, the court has emphasized the "spirit of Aloha," prioritizing the safety and well-being of residents over the unrestricted right to carry firearms in public. Despite this, the federal rulings in Heller and McDonald remain applicable, reinforcing the individual right to bear arms.

Furthermore, the 9th Circuit Court of Appeals has recently ruled in favor of protecting 2nd Amendment rights in cases such as Teter v. Lopez, which declared Hawaii's ban on butterfly knives unconstitutional. This ruling highlights the ongoing legal challenges to restrictive firearm laws in Hawaii and underscores the importance of upholding constitutional rights.

Reasons to Oppose SB1314:

- 1. **Privacy Concerns**: The bill requires detailed reporting on firearm licenses, which could raise privacy concerns for law-abiding citizens. The collection and dissemination of personal information related to firearm ownership may lead to potential misuse or unauthorized access, compromising the privacy and security of individuals.
- 2. **Burden on Law Enforcement**: The additional reporting requirements imposed by SB1314 could place an undue burden on the Department of the Attorney General and the chief of police of each county. This could divert resources and attention away from more pressing public safety concerns, ultimately affecting the efficiency and effectiveness of law enforcement agencies.
- 3. **Lack of Evidence for Effectiveness**: There is no substantial evidence to suggest that the additional reporting requirements proposed by SB1314 would significantly enhance public safety or reduce firearm-related incidents. Law-abiding citizens who possess firearm licenses are already subject to background checks and other regulatory measures. Imposing further reporting requirements may not yield the intended benefits.
- 4. **Potential for Discrimination**: The bill's requirement to analyze denials based on applicants' failure to meet certain standards and to recommend remedies for disparities in denial rates by age, gender, or race could lead to unintended consequences. This could result in discriminatory practices or biased decision-making processes, further complicating the issue of firearm licensing.

In conclusion, I urge you to reconsider the implications of Senate Bill SB1314 and to uphold the constitutional rights of Hawaii's citizens. The 2nd Amendment is a cornerstone of our democracy, and any legislation that seeks to undermine it must be carefully scrutinized. I respectfully request that you vote against SB1314 and protect the rights of law-abiding citizens to bear arms.

Increased Reporting Requirements Serve No Purpose

Historically, increased data collection on firearm owners has often been used to justify **future restrictive measures, rather than to ensure public safety**. This bill creates a **slippery slope** toward more invasive tracking and potential discrimination against legal firearm owners.

Conclusion

SB 1314 does nothing to improve public safety and only adds unnecessary bureaucratic burdens while raising privacy concerns for law-abiding citizens. Rather than increasing reporting requirements, the state should focus on enforcing existing laws against criminal misuse of firearms.

EXECTIVE ORDER DATED

2/7/2025

By the authority vested in me as President by the Constitution and the laws of the United States of America, it is hereby ordered:

- Section 1. Purpose. The Second Amendment is an indispensable safeguard of security and liberty. It has preserved the right of the American people to protect ourselves, our families, and our freedoms since the founding of our great Nation. Because it is foundational to maintaining all other rights held by Americans, the right to keep and bear arms must not be infringed.
- Sec. 2. Plan of Action. (a) Within 30 days of the date of this order, the Attorney General shall examine all orders, regulations, guidance, plans, international agreements, and other actions of executive departments and agencies (agencies) to assess any ongoing infringements of the Second Amendment rights of our citizens, and present a proposed plan of action to the President, through the Domestic Policy Advisor, to protect the Second Amendment rights of all Americans.
- (b) In developing such proposed plan of action, the Attorney General shall review, at a minimum:
- (i) All Presidential and agencies' actions from January 2021 through January 2025 that purport to promote safety but may have impinged on the Second Amendment rights of lawabiding citizens;
- (ii) Rules promulgated by the Department of Justice, including by the Bureau of Alcohol, Tobacco, Firearms, and Explosives, from January 2021 through January 2025 pertaining to firearms and/or Federal firearms licensees;
- (iii) Agencies' plans, orders, and actions regarding the so-called "enhanced regulatory enforcement policy" pertaining to firearms and/or Federal firearms licensees;
- (iv) Reports and related documents issued by the White House Office of Gun Violence Prevention;

- (v) The positions taken by the United States in any and all ongoing and potential litigation that affects or could affect the ability of Americans to exercise their Second Amendment rights;
 - (vi) Agencies' classifications of firearms and ammunition; and
 - (vii) The processing of applications to make, manufacture, transfer, or export firearms.
- Sec. 3. Implementation. Upon submission of the proposed plan of action described in section 2 of this order, the Attorney General shall work with the Domestic Policy Advisor to finalize the plan of action and establish a process for implementation.
- Sec. 4. General Provisions. (a) Nothing in this order shall be construed to impair or otherwise affect:
- (i) the authority granted by law to an executive department, agency, or the head thereof; or
- (ii) the functions of the Director of the Office of Management and Budget relating to budgetary, administrative, or legislative proposals.
- (b) This order shall be implemented consistent with applicable law and subject to the availability of appropriations.
- (c) This order is not intended to, and does not, create any right or benefit, substantive or procedural, enforceable at law or in equity by any party against the United States, its departments, agencies, or entities, its officers, employees, or agents, or any other person.
