# Testimony in SUPPORT of SB1439 RELATING TO NUISANCES

- 1 Fiscal Implications: This measure will not impact the priorities identified in the Governor's
- 2 Executive Budget Request for the Department of Health's (Department) appropriations and
- 3 personnel priorities.
- 4 **Department Position:** The Department **supports** the SB1439 measure.
- 5 **Department Testimony:** The Environmental Health Services Division (EHSD), Vector Control
- 6 Branch (VCB) provides the following testimony on behalf of the Department.
- 7 SB1439 amends Hawaii Revised Statutes (HRS) Chapter 322, Part 1, Removal, prevention (of
- 8 nuisances) by adding "Abatement, Destruction" and "public or environmental" to clarify that
- 9 the Department of Health has the legal authority and obligation to prevent and address
- 10 nuisances that affect public health, environmental health, or both. The additional language
- 11 updates the statute and aligns it with Departmental practices and purpose, ensuring that the
- 12 Department has clear legal authority to act in the interest of public and environmental health
- for purposes such as invasive species control and biosecurity.
- 14 HRS, Chapter 322-1, pertains to the abatement of nuisances. HRS, Chapter 322-1, directs the
- 15 Department to examine all nuisances, including foul or noxious odors, gases or vapors, water in
- 16 which mosquito larvae exist, sources of filth, and all causes of sickness or disease, onshore and

- in any vessel, which the Department determines are dangerous or injurious to health. Further,
- 2 HRS, Chapter 322-1, authorizes the Department to cause the dangerous or injurious nuisance to
- 3 be abated, destroyed, removed or prevented. However, as currently written, the language in
- 4 HRS, Chapter 322-1 directs the Department to act when a nuisance is dangerous or injurious to
- 5 "health," which leaves ambiguity whether "health" does or does not broadly include
- 6 "environmental health" or whether "health" refers solely to an individual's health rather than
- 7 public health.

- 8 The addition of "public or environmental" to HRS 322-1 simultaneously recognizes and
- 9 authorizes the Department's actions when nuisances directly threaten public health and/or
- 10 environmental health. The proposed language adds clarity and readability to the statute.

While I understand the importance of addressing environmental health concerns, I am deeply concerned about the vague language in this bill and how it could be used to justify the elimination of chickens on the islands. Such an action would worsen food security for many residents, especially those already struggling with poverty and the current chicken and egg shortage.

The bill grants broad authority to the Department of Health without clearly defining what constitutes a "nuisance" or specifying how enforcement will be carried out. This ambiguity leaves room for subjective interpretation and unintended consequences. Without clear guidelines, the bill could disproportionately affect low-income communities that rely on backyard chickens as a vital food source.

Hawai'i is already facing challenges in food security, and many residents depend on chickens for fresh eggs and meat. Removing these resources would force more reliance on costly imports, further burdening families who are already struggling to afford basic necessities. If this bill is intended to target noise or population control, I urge the committee to provide explicit language ensuring that it does not negatively impact food security or residents who responsibly raise chickens.

For these reasons, I strongly urge you to vote against SB1439 or amend it to provide clearer definitions and protections for local food sources.

While it is necessary to address threats to ecosystems, the environment, and public health, this should only be done when no other options exist. The department must be held accountable for its decisions, ensuring transparency to the public, fairness, and respect for individual rights. For example, stray cats, which are often left unchecked, contribute to environmental harm by killing over 2 billion birds annually and spreading harmful parasites like *Toxoplasma gondii*, which causes toxoplasmosis. This parasite, commonly transmitted through cat feces, can lead to severe health issues in humans, including flu-like symptoms, vision problems, and even brain damage in vulnerable individuals such as pregnant women and those with weakened immune systems. Despite this, chickens—an animal that provides significant value to the environment—are frequently targeted as nuisances. Chickens serve as a sustainable food source, their waste can be used as natural fertilizer, and they contribute far more positively to ecosystems than stray cats. Policies must be based on science, logic, and fairness rather than arbitrary classifications of what constitutes a nuisance.
