- 1 **Department Testimony:** The Department of Health (DOH) Child & Adolescent Mental Health
- 2 Division (CAMHD) strongly supports this bill. It has been 50 years since the Mental Health
- 3 Services for Children and Youth statutes have been codified. The amendments proposed by this
- 4 bill bring the statute up to date to reflect the current role of the Child & Adolescent Mental
- 5 Health Division in addressing intensive mental health needs of children and adolescents in
- 6 Hawaii.
- 7 Although originally a branch of the Adult Mental Health Division, Child & Adolescent Mental
- 8 Health became its own Division of the Department of Health decades ago as research emerged
- 9 about the distinct and specialized nature of child and adolescent mental health services. Today
- 10 CAMHD is the state's Medicaid provider for intensive mental health services for children and
- adolescents with a serious emotional disturbance (SED). CAMHD works collaboratively with
- other child-serving agencies and has developed a comprehensive array of treatment services for
- 13 youth with SED via Purchase of Service contracts. Mental health assessments, clinical oversight
- and care coordination are provided by employees at Family Guidance Centers on Oahu, Hawaii,
- Maui, and Kauai. In addition, the Family Court Liaison Branch on Oahu provides mental health
- services to youth who are incarcerated or detained. This system of care is based on core values to
- provide child and family-centered, culturally sensitive, least restrictive and evidence-based
- mental health services. Over the past 30 years, CAMHD has leveraged federal system of care

- 1 grants to actively develop and improve the child and adolescent mental health service system of
- 2 care in Hawaii based on national standards and best practices.
- 3 In 2023, CAMHD partnered with the University of Hawaii, School of Public Health to conduct a
- 4 five-year statewide needs assessment of mental health services for youth. The final assessment
- 5 report is expected by December of 2027. Once completed, this assessment will be used to
- 6 develop a Child & Adolescent Mental Health Services Plan.

Hawaii law, HRS §334-10, established the State Council on Mental Health (SCMH) as a 21-member body to advise on the allocation of resources, statewide needs, and programs affecting more than one county as well as to advocate for adults with serious mental illness, children with serious emotional disturbances, individuals with mental illness or emotional problems, including those with co-occurring substance abuse disorders. Members are residents from diverse backgrounds representing mental health service providers and recipients, students and youth, parents, and family members. Members include representatives of state agencies on mental health, criminal justice, housing, Medicaid, social services, vocational rehabilitation, and education. Members include representatives from the Hawaii Advisory Commission on Drug Abuse and Controlled Substances and county service area boards on mental health and substance abuse.

The Hawaii State Council on Mental Health (SCMH) strongly supports SB1442 SD1, which seeks to clarify and update the responsibilities of the Child and Adolescent Mental Health Division (CAMHD) within the Department of Health to better reflect current mental health systems of care for Hawaii's children and adolescents.

Mental health challenges among youth in Hawaii have become increasingly complex, requiring a comprehensive, coordinated, and evidence-based approach to ensure that children and adolescents receive the

appropriate services and support. By modernizing the statutory language governing CAMHD, this bill ensures that Hawaii's mental health care framework aligns with best practices and evolving community needs.

SB1442 SD1 is critical because it:

- 1. **Clarifies CAMHD's role** in delivering high-quality mental health services, ensuring efficiency and accountability in service delivery.
- 2. Supports a system of care model that **prioritizes early intervention**, family involvement, and culturally competent services.
- 3. Improves coordination between CAMHD and other child-serving agencies, strengthening Hawaii's overall mental health system.

The Hawaii State Council on Mental Health remains committed to advocating for policies that enhance mental health care access and effectiveness for Hawaii's youth. We believe SB1442 SD1 is a vital step toward ensuring that every child in our state has access to the support they need to thrive.

For these reasons, we respectfully urge the Committee to pass SB1442 SD1.

### Hawaii Substance Abuse Coalition Supports SB1442 SD1:

ALOHA CHAIR, VICE CHAIR, AND DISTINGUISHED COMMITTEE MEMBERS. My name is Alan Johnson. I am the current chair of the Hawaii Substance Abuse Coalition (HSAC), a statewide organization for substance use disorder and co-occurring mental health disorder treatment and prevention agencies and recovery-oriented services.

Updating mental health codes for children is important for several reasons:

- 1. **Improved Diagnosis and Treatment** As our understanding of mental health evolves updated codes allow for more accurate diagnoses and treatment plans tailored to children's unique developmental needs.
- 2. **Reflecting New Research** Advances in psychology and psychiatry reveal new conditions, refine existing ones, and improve classification methods, ensuring that children receive appropriate care.
- 3. **Better Insurance Coverage** Updated codes help ensure that insurers recognize and cover new and emerging mental health conditions, reducing financial barriers to treatment.
- 4. **Early Intervention** More precise coding can lead to earlier identification of mental health issues, allowing for timely intervention, which is crucial for long-term well-being.
- 5. **Tracking Trends and Outcomes** Updating codes helps researchers and healthcare providers track mental health trends in children, assess treatment effectiveness, and develop better policies.
- 6. **Reducing Stigm**a More refined language and categorization can help reduce stigma by framing mental health conditions in a more accurate and supportive way.

Overall, updating these codes ensures that children's mental health care remains current, effective, and accessible.

Aloha Chairs and Members of the Ways and Means Committee and the Judiciary Committee,

My name is Mai Phan, and I am a student at the University of Hawai'i at Mānoa in the School of Social Work. I am also a constituent of Representative Daniel Holt (District 28) and Senator Karl Rhoads (District 13). Thank you for the opportunity to testify at this hearing. I am testifying as an individual in strong support of Senate Bill 1442 SD1, which aims to strengthen and modernize mental health services for children and adolescents in Hawai'i.

By improving accessibility, coordination, and effectiveness, this bill will help address the rising rates of depression, anxiety, suicidality, and other mental health challenges among Hawai'i's youth. SB1442 SD1 proposes Family Guidance Centers, long-term planning, and a focus on early intervention and community-based care, which will reduce crises and hospitalizations and ensure that young people receive the support they need.

As a social work student interning at the Boys & Girls Club, I witness firsthand the challenges youth face. While I do not speak on behalf of the organization, my experience working with the youth there, 98% of whom come from vulnerable backgrounds, has shown me

how critical accessible mental health care is for their well-being. Many of these children face economic hardship, unstable home environments, and adverse childhood experiences (ACEs), all of which increase their risk of developing mental health issues. This bill will provide the necessary support systems to help these youth thrive and become happy and healthy adults.

The benefits of SB1442 SD1 extend to all of Hawai'i's youth. Many of us have young people in our lives whom we deeply care about, whether they are our children, grandchildren, siblings, nieces, nephews, or cousins. By passing this bill, we are investing in their future and ensuring they have greater access to high-quality and effective mental health care. For these reasons, I support Senate Bill 1442 SD1 which prioritizes the well-being of Hawai'i's youth.
