<u>DEPARTMENT'S POSITION</u>: The Department of Human Services (DHS) supports the bill's intent with suggested amendments and provides comments.

<u>PURPOSE</u>: The purpose of this bill is to establish and implement an early learning contracts program to make available a designated number of seats at licensed infant and toddler child care centers and family child care centers for families referred by the department at a negotiated rate and schedule. Requires DHS to submit reports to the Legislature.

DHS can use contracts for direct service slots and has recently been granted a waiver by the federal Office of Child Care (OCC) to temporarily exempt DHS from meeting the specified provisions in the 2024 Child Care and Development Fund (CCDF) Final Rule for grants or contracts for direct services for infants and toddlers, children with disabilities, and children in underserved geographic areas.

DHS has requested consultation with federal advisors about how CCDF may be used to increase the supply and quality of care and best practices learned from other CCDF lead agencies on successful implementation of contracting child care services.

Additionally, DHS will issue a Request for Information to understand market options from service providers as part of the procurement process for this service. The department seeks to determine the per child cost necessary for a contracted infant and toddler classroom to ensure stable funding, as well as the feasibility of a center exclusively enrolling subsidized children, and the development of a workable contract payment structure or structures and would welcome comments on this subject by proponents of this measure.

DHS understands the importance of improving child care affordability for families, parent choice, and stable child care operations and respectfully recommends the following amendments to include reference to the State Constitution:

• Section 2, paragraph (b), line 4, to read: The department of human services shall contract directly with licensed infant and toddler child care centers, provided that a child care center shall not be eligible for a contract if the center is part of, owned by, or operated by a private educational institution and the awarding of the contract would violate article X, section 1, of the Hawaii State Constitution, and contract through an intermediary, with family child care centers that serve:...

The Executive Office on Early Learning (EOEL) supports the intent of S.B. No. 1609 which requires the Department of Human Services (DHS) to implement an early learning contracts program for seats at licensed infant and toddler child care centers and family child care centers. We defer to DHS regarding implementation and funding and offer the following comments.

EOEL supports the concept of contracted early care services because of its potential to provide more stability and a better financial model for our community-based providers. Subject: Measure S.B. No. 1609 - Relating to Child Care

Mahalo for the opportunity to testify in support of S.B. No. 1609. We defer to the Department of Human Services regarding implementation of the bill and provide comments.

The demand for affordable, high-quality child care in Hawai'i far exceeds available capacity, leaving many families—particularly those with children under age three—struggling to secure care. At the same time, child care businesses face significant challenges in maintaining operations, as the current tuition-based model places the bulk of the financial burden on families. Without a more stable funding mechanism, many providers are unable to sustain or expand their programs, further exacerbating the child care shortage.

This bill, which establishes a contracted slot pilot program, would help stabilize child care businesses, allowing them to increase capacity while also alleviating the financial strain on families. This approach ensures a more reliable funding stream for providers while improving access to care for working families across the State.

The Department of Community Services respectfully requests an amendment to require the department to contract with at least two group child care centers on Oʻahu, rather than just one. Given that Oʻahu is home to over 70% of the state's population, expanding the number of contracted providers on the island would better reflect the demand for services and maximize the bill's impact.

We also respectfully request the addition of requiring the department to contract with at least one licensed infant and toddler center per county as well. There is an overall shortage of early childhood seats in general, however, there is an especially critical shortage of infant-toddler care. In the most recent estimation, there were 1.5 children age 3 to 5 for each group child care center seat compared to 29 children under age 3 for each licensed infant-toddler center seat.

Should the committee be amenable, we propose the following amendments to section 2, page 2, lines 12-14:

"...(1) The program shall provide contracts for at least one licensed [or regulated] infant and toddler center per county[;]. The program shall also provide contracts for at least two licensed group child care centers in the city and county of Honolulu and one licensed group child care center in each of the counties of Hawaii, Maui, and Kauai; and..."

Early Childhood Action Strategy (ECAS) is a statewide cross-sector collaborative designed to improve the system of care for Hawai'i's youngest children and their families. ECAS partners work to align priorities for children prenatal to age eight, streamline services, maximize resources, and improve programs to support our youngest keiki.

ECAS supports, with amendments, SB1609, which would require the Department of Human Services to establish and implement an early learning contracts program to make available a designated number of seats at licensed infant and toddler child care centers and family child care centers for families referred by the Department. Funding for an early learning contracts program is available through existing federal monies.

Hawaii faces significant unmet need for child care. There is sufficient capacity for less than 20% of children birth-5 years old in regulated child care settings, and lack of openings and long waiting lists are chronic issues for families searching for care. These capacity issues can be even more problematic for families eligible for and/or receiving child care subsidy assistance, whose financial constraints may severely limit their options to search and wait for care.

Compounding the problem are systemic disincentives for child care providers to participate in the child care subsidy system, which further decrease low-income working families' access to quality child care settings. Specifically, unstable and unpredictable enrollment and attendance of children, as well as insufficient payment rates to cover the cost of quality care can deter providers from serving subsidy children and undermine the financial stability and operating capacity of those providers who do.

Direct contracts for subsidized classrooms between DHS and infant/toddler and family child care providers, as proposed by **SB1609**, would facilitate more predicatable, robust and stable payments to child care providers. The increased financial stability for child care providers provided by contracts would support their ability to staff their programs, stay in business, provide higher quality services, and potentially open up more spaces for children. Families would ultimately have more programs from which they can find and access child care.

We respectfully recommend the following amendments:

• Section 1, page 1, lines 10 to 15, clairfying and adding to the types of child care programs with which the Department may contract, to read:



Accordingly, the purpose of this Act is to require the department of human services to establish and implement an early learning services contracts program to make available a designated number of seats at licensed infant and toddler child care centers and group child care centers, and registered family child care centers homes for families referred by the department...

- Section 2, page 2, paragraph b, lines 4 to 7, adjusting contracts with family child care providers to be an option but not mandatory, on top of contracts with infant/toddler and group child care centers:
 - (b) The department of human services shall contract directly with licensed infant and toddler child care centers and group child care centers, and may contract, through an intermediary, with family child care centers homes that serve...
- Section 2, page 2, paragraph c, lines 12 to 14, specifying the minimum number of contract types, per county, to better reflect the higher population of children and demand for child care services on O'ahu:
 - (c) (1) The program shall provide contracts for at least one licensed or regulated child care program infant and toddler center per county. The program shall also provide contracts for at least two licensed group child care centers in the City and County of Honolulu and one licensed group child care center in each of the counties of Hawai'i, Maui, and Kauai; and...

Thank you for this opportunity to provide testimony **in support of SB1609**. With the limited availability of quality, affordable child care options for our keiki, the bill's proposal to stabilize and support the financial viability and operating capacity of our child care programs and incentivize their participation in the subsidy system is key to sustaining and increasing access to the child care families need to survive and thrive.

Members of AAUW of Hawaii thank you for this opportunity to testify in **strong support of SB 1609** which establishes a child care classroom contracts program requiring the Department of Human Services (DHS) to contract directly with child care center providers in licensed infant and toddler child care centers and group child care centers.

Hawai'i is experiencing a child care crisis. The demand for available, quality, and affordable child care far exceeds the current capacity in Hawaii. There is only one opening for every four children ages six and below. The situation is even worse for those seeking a child care space for infants and toddlers with only one opening for every 37 children. This leaves families, and single parent households in particular in a bind.

Families eligible for subsidies often can't afford to wait the months it may take to get off of a waitlist. They must find care immediately to keep the job that meets the work requirements for the subsidies.

By improving financial stability, this measure also helps child care providers maintain operations and avoid program closures.

This measure will support a consistent supply of child care slots for families receiving subsidies and incentivize child care providers to continue caring for them.
