S.B. 1638, SD1 RELATING TO AIR CARRIERS

Senate Committee on Ways and Means

The Hawai'i Department of Transportation (HDOT) provides the following comments on S.B. 1638, SD1, which proposes establishing the Molokai Air Carrier Subsidy Program within HDOT to provide direct financial subsidies to airlines operating out of Molokai Airport.

As an airport operator receiving federal funding, HDOT is subject to Federal Aviation Administration (FAA) grant assurances that prohibit the direct subsidization of air carriers. Establishing a state-funded subsidy program within HDOT would conflict with these federal requirements and could jeopardize HDOT's eligibility for federal funding.

Rather than providing direct subsidies, HDOT is actively working to procure an air charter service contract that will enable the State to support the transportation of high-priority travelers, including medical personnel, patients, and other essential service providers, to and from Molokai.

To implement this service, \$1,000,000 million in General Funds (GF) funding is needed for this fiscal year to ensure timely execution and availability of critical air transportation. By the next fiscal year, HDOT will have a sustainable funding mechanism in place, with departments utilizing the service contributing to the cost, ensuring long-term viability without reliance on additional general funds.

- 3. A structured subsidy program ensures accountability and efficiency, requiring compliance with state and federal regulations while ensuring funds are used solely for operational costs that benefit Molokai residents. The program also mandates annual reporting to the Legislature, providing transparency in how subsidies are allocated.

SB1638 - SUPPORT

Aloha Chair Dela Cruz, Vice Chair Moriwake, and Respected Committee Members,

SB1638: Establishes within the Department of Transportation the Molokai air carrier subsidy program to provide subsidies to airlines operating out of Molokai airport. Appropriates moneys.

Thank you in advance for taking the time to read my testimony. I have a sincere love for, and personal roots on Molokai, and these are the reasons why I support this bill:

MOLOKAI BILLS: SB1638, SB1570, SB1640, SB557. I believe the bills Sen DeCoite has introduced, are
making a serious attempt to call needed attention to, address, and resolve many of the complex issues
Molokai is facing right now. All are interconnected and have a roll in solving the unreliable air transportation,
needed access to medical care, and Molokai's economic crises for both the short, and long term. Senator
DeCoite and we the residents of Molokai can't do this alone; we need your support and commitment in
tackling issues that have now become a very serious problem to the health and safety of a segment of
Hawaii's residents – Molokai.

Our economy as you know, has been consistently declining and is now particularly fragile. At its best, Molokai has always been basic, but if you take a thoughtful look around you'll quickly recognize that Molokai has far more needs than wants – and those needs are now far more serious, in a far more concerning way.

Our residents' health, safety and current economic situation sincerely needs attention and commitments from our State.

The costs to our Molokai people have been incalculable:

- **FINANCIAL HARDSHIPS.** There are approximately 2500 jobs on island, and many pay minimum wage. Approximately one-third of our residents live through government assistance or social security.
 - Most residents have **limited resources which limits access to any off-island services** families may require;
 - Many are also **responsible for ohana who require off-island travel companions** who have limited mobility and resources;
 - Because of the **lack of any long-term care facilities, families face constant travel** because loved ones must reside at off-island medical facilities instead of here at home; and
 - Many can't afford the **underinsured travel expenses of airfare, car rental and many times hotel** lodging because of unreliable air service.
- LIMITED ACCESS TO MEDICAL PROFESSIONALS. Due to the erratic air transportation, medical professionals and specialists no longer can afford to practice on Molokai. The air transportation problem has cut access to most medical professionals coming to Molokai.

- UNRELIABLE AIR TRAVEL. Because of delayed or cancelled flights, many of us find missed appointments and off-island procedures can't immediately be rebooked until months later which leads to compounded medical problems, expenses, and stress.
- **PREPAY DENTAL SERVICES.** The majority of our on-island Dentists now are requiring payment upfront for their dental services. Residents must choose how they're going to manage their monthly cash flow when requiring dental care. Many simply forego dental treatment until its unbearable or use the hospital emergency room which is inevitably more costly. Waiting for insurance reimbursements also impede their ability to afford daily needs, or other off island travel needs.
- VULNERABLE DEMOGRAPHICS. The majority of our island's demographics are the elderly and the young

 they can be vulnerable, less inclined, or unable to speak up and advocate for themselves. They in particular
 need access to in-person visits with medical specialists/professionals who can recognize and identify
 what they may not be able to convey. The air transportation problem has cut access to most medical
 professionals coming to Molokai.
- **HIGH UNEMPLOYMENT.** Traditionally we've had the highest unemployment in the state, normally two to three times the state average which **means some of our residents only have sporadic medical coverage** which can expire before they can even be seen if flights are cancelled or randomly rebooked, when needing off-island specialist, or before a specialist can fly to Molokai.

Our past visitor numbers supported more consistent air transportation, a stronger local economy, job stability and the ability for more local businesses and residents to thrive. It provided our community and future generations – more choice and more opportunities.

- AIRPORT RUNWAY EXPANSION. We also must acknowledge the reasons why we have only one airline, and the serious problems it's causing to the health and welfare of our community. We certainly don't need to expand the runway to receive jumbo jetliners, but we can set parameters to receive planes that could bring us back to our past visitor numbers. These are not more visitors, but familiar numbers our community has experienced in the past, giving us the ability to return to past operational capacities and opportunities that we're familiar with.
 - Molokai had various types of larger jets in the past Aloha Airlines 127-seater Boeing 737-200 jets, Hawaiian Airlines Boeing 123-seater 717-200 jets, etc. But as we know, because of increased federal regulations and restrictions, they no longer can land on our shorter runway.
 - We need to consider accommodating types of aircraft that are currently flying inter-island, airlines with a secure business model and successful track record, and try to become a part of that model to receive reliable service and lower airfares for our families.

Comments:

As a Nurse practitioner living and working on Molokai I see the physical and mental tole that not having reliable air travel puts on the residents here. At the very least, basic needs such as healthcare should be met for citizens, yet with only one airline these needs are not always met even when the one airline is running. Many residents are not able to board the small planes due to injuries, or physically limiting conditions. Mokulele has been inconsistent with flying, and even more inconsistent with their larger plane which can accommodate some of these individuals. There are stories of people's conditions becoming life threatening simply because they were not able to get to their medical appointment off island. Molokai has a few primary care providers with a few specialists who travel to the island once a month or every few months depending. Surgery, MRIs, ICU's, and most specialists are all off island. Even a simple Ultrsound by a trained ultrasound tech is not always available.

This issue has gone on too long. This bill would encourage other airlines to fly to Molokai increasing options to residents as well as creating competition between each other, thus keeping prices affordable and encouraging the airlines to do their best in order to get passengers. Residents already pay high prices for healthcare. Most insurances don't cover the cost that travel incurs. We must not forget that flights, cars, food, sometimes hotels as well, are all needed for residents to get basic healthcare needs met. Most need to also take time off work, and some need to have a family member or friend travel with them as well, thus increasing the financial burden. These costs quickly stack up putting people already strapped for money in even more dire straights.

Pregnant ladies routinely are told to stay off island for up to a month prior to their delivery dates due to the seriousness of pregnancy and the lack of reliable methods to get them off island in case of an emergency. Insurance often doesn't cover their hotels, cars, food, not to mention the lack of income during that period as they and their families take off work in order to keep the mother and unborn baby safe.

Please support this bill and others that help increase access to travel and healthcare for residents.
