**DEPARTMENT'S POSITION**: The Department of Human Services (DHS) appreciates the intent of this measure and offers comments.

<u>PURPOSE</u>: The purpose of the bill is to appropriate funds to the Department of Human Services to achieve the full funding, including estimated payment increases, of Medicaid home and community-based services.

DHS previously received funding to increase reimbursement rates for Home and Community Based Services based on rate studies conducted by DHS' Med-QUEST Division's (MQD) consulting actuaries and submitted to the Legislature prior to the 2023 and 2024 Legislative sessions. Those rate studies presented three options for levels of funding – Low, Medium, and High. The Low option was funded by the Legislature, which increased the Level 1 and Level 2 per diem rates for both Oahu and the Neighbor Islands, as well as increasing the rates for Adult Day services. In addition, DHS has an executive budget request this Legislative session to increase rates for In-Home services up to the Low option amount detailed in the rate study, which totals \$23.8M, including \$14.06M N funds. The state fund appropriation of

\$9.74M has already been allocated to Med-QUEST Division's (MQD) program ID for Health Care Payments HMS 401. If full funding represents the High option from the rate studies, then additional funding totaling \$35 million (\$14.3 million state funds/\$20.7 million federal funds) would be needed to fund the High option.

DHS respectfully requests an amendment deleting from Section 2, page 4, line 21 through page 5, line 5:

"...provided that the department of human services shall obtain the maximum federal matching funds available for this expenditure; provided further that the department of human services shall pursue all funding sources known to the State, including private grants, prior to expending any general revenues appropriated pursuant to this Act."

Medicaid funding includes federal matching and state funds for every covered Medicaid expenditure. Also, federal Medicaid matching rates are set by the federal government, and all covered Medicaid expenditures automatically have the appropriate federal matching rate applied. Thus, the mandate to obtain "maximum federal matching funds" is unnecessary and would complicate the implementation of any reimbursement increases. Further, private grants are not allowed to be the state fund portion of Medicaid expenditures. Thus, we respectfully request that these clauses be deleted.

DHS respectfully requests that this program and appropriation not conflict with, reduce, or replace priorities identified in the executive budget.
