S.B. 344 RELATING TO HIGHWAY SAFETY

Senate Committee on Transportation and Culture and the Arts

The Department of Transportation **supports S.B. 344**, which requires persons under the age of 16 to wear a helmet while riding a skateboard. Clarifies that the Act does not infringe on county ordinances prohibiting skateboards on streets and roadways.

According to the Hawaii Department of Health, from 2019 through 2023, there were 11 serious skateboard injuries on our roadways, 2 of which were under the age of 17 and neither of them were wearing helmets.

According to the National Library of Medicine, wearing a helmet while skateboarding reduces the risk of head injuries by up to 88 percent.
