# In consideration of **SENATE BILL 465** RELATING TO THE KIKIAOLA SMALL BOAT HARBOR

Senate Bill 465 proposes to appropriate funds for a carrying capacity study of Kīkīaola Small Boat Harbor on Kaua'i. The Department of Land and Natural Resources (Department) acknowledges the intent of this measure and offers the following comments.

The Legislature appropriated \$4.1 million in Capital Improvement Project funds in the 2022 budget for design, permitting, and construction of a second boat launch ramp at Kīkīaola Small Boat Harbor. The Department is currently awaiting final permitting approval for the new boat launch ramp and anticipates starting construction later this year. The new boat launch ramp is expected to help alleviate concerns raised about ramp use by commercial operators and their guests.

Because the second ramp has not yet been constructed or evaluated, conducting a carrying capacity study at this time may be premature. The Department believes that assessing the harbor's capacity should occur after the new ramp is operational, allowing for a more accurate evaluation of its impact on harbor usage and congestion.

However, if the Committee decides to advance this measure, the Department supports the appropriation in this measure, provided that its passage does not replace or adversely impact priorities indicated in the Executive Budget request.

Aloha,

I am submitting testimony in **support** of SB456 that requires the Department of Land and Natural Resources to conduct a study of the carrying capacity of the Kikiaola Small Boat Harbor in the Count of Kauai and submit a report to the Legislature. This bill is essential for keeping the Kikiaola Small Boat Harbor a safe viable resource for the community and environment.

First, this study will contribute to efforts protecting the environment. Aloha Chair Inouye and Vice Chair Elefante, and members of the Committee on Water and Land,

I am writing in strong support of SB 465, which requires the Department of Land and Natural Resources (DLNR) to conduct a study on the carrying capacity of Kikiaola Small Boat Harbor in Kekaha. Kauai.

It is alarming that Kikiaola Small Boat Harbor holds approximately 60% of the commercial boat permits for the Island of Kauai. Housing such a large proportion of commercial activities at this small harbor has created constant safety concerns, limited recreational access, and strained resources.

The logistical challenges of hosting 60% of the island's commercial operations are compounded by permit holders frequently changing their vessels to increase their carrying capacity.

## Our key concerns are:

- **Safety Risks:** The increased carrying capacity of commercial vessels without proper oversight poses significant safety risks.
- **Environmental Impact:** The increased commercial activity may harm marine ecosystems.

• **Community Impact:** The changes are negatively affecting the local community, particularly recreational fishermen and residents of Kekaha.

Conducting a comprehensive study on the carrying capacity of Kikiaola Small Boat Harbor will ensure sustainable and safe operations, balancing commercial and recreational activities.
