**SENATE BILL 659, SD1
RELATING TO THE DEPARTMENT OF EDUCATION**

Chair Dela Cruz, Vice Chair Moriwaki, and members of the committee, thank you for the opportunity to submit testimony on Senate Bill 659, SD1. The State Procurement Office (SPO) appreciates the intent of this bill and provides the following comments and recommendations:

The language in the SD1 version does not provide guidance for purchases of \$25,000 to less than \$100,000, which is not subject to the requirement to conduct procurements through an electronic system.

The SPO offers the following comments on procurements valued at \$25,000 to less than \$100,000.

- While procurements of \$25,000 to less than \$100,000 shall be exempt from the requirement to conduct procurements through an electronic system, the bill should address procurement thresholds. No less than three written quotes are required for procurements of \$25,000 to less than \$100,000, with the exception of rural communities. The SPO acknowledges challenges that may be faced by schools in rural communities, including finding vendors of local products. Thus, for schools in rural communities, no less than two written quotes are required for procurements of \$25,000 to less than \$100,000
- If the department is unable to receive the required number of written quotes as required by this section, written justification shall be provided and kept by the department in the procurement file.
- All awards of \$2,500 must be on the Hawaii Awards and Notice Data System (HANDS) or similar Department of Education procurement platform

- The SPO may request data from the department to evaluate the efficacy of this Act, pursuant to section 103D-212.
- The department must exercise due diligence to ensure that agencies are not engaging in parceling, which is the artificial division of goods so as to intentionally circumvent the procurement process.

For these reasons, and to ensure compliance, accountability, and transparency, the SPO recommends that Section 1, page 1, lines 4-12, read as follows:

§302A – Procurement; locally sourced products; geographic preference; small purchase. Notwithstanding section 103D-305(c) and any law to the contrary, procurements of less than \$100,000 for local edible produce and local value-added processed, agricultural, or local food products for the department shall be exempt from the requirement to conduct procurements through an electronic system and shall instead be subject to no less than three written quotes for procurements of \$25,000 to less than \$100,000; provided that the department may allow for no less than two written quotes for procurements of less than \$100,000 for local edible produce and local value-added processed, agricultural, or local food products to supply schools in rural communities, as determined by the department; provided further that if the department is unable to receive the required number of written quotes as required by this section, written justification shall be provided and kept by the department in the procurement file. All awards exceeding \$2,500 shall be posted electronically on the Hawaii Awards and Notice Data System (HANDS), or similar department of education procurement platform, and shall be compliant with section 103D-310(c). The State Procurement Office may request data from the department to evaluate the efficacy of this Act.

Bill Title: SB 0659, SD1 RELATING TO THE DEPARTMENT OF EDUCATION.

Purpose of Bill: Exempts from the electronic procurement system the Department of Education's purchase of fresh local agricultural products and local value-added processed, agricultural, or food products not exceeding \$100,000, subject to certain requirements. Requires the Department of Education to establish guidelines for determining a geographic preference for locally sourced products. Effective 7/1/2050. (SD1)

Department's Position:

The Hawaii State Department of Education (Department) supports SB 659, SD 1.

This bill will increase the School Food Services Branch's (SFSB) small purchase procurement capacity and flexibility to procure more locally grown produce. This will aid in the Department's progress toward meeting the 30% by 2030 local farm-to school ingredients purchase goals.

The Department recognizes that it will be responsible for establishing guidelines with a geographic preference for locally sourced products in accordance with the United States Department of Agriculture's National School Lunch Program and state procurement laws, including the necessity of gathering competitive bids.

The process proposed in this bill will allow us to purchase items that currently are unavailable from our distributors such as poi and limu.

Exempting the Department from the electronic procurement system will increase opportunities to procure from local farmers across the state who may be electronically limited, yet food safety compliant. The SFSB further recognizes that educating farmers about procurement compliance is a

part of its farm to school mission.

UluPono Initiative supports SB 659 SD 1, Relating to Department of Education.

Dear Chair Dela Cruz and Members of the Committee:

My name is Mariah Yoshizu, and I am the Government Affairs Associate at UluPono Initiative. We are a Hawai'i-focused impact investment firm that strives to improve the quality of life throughout the islands by helping our communities become more resilient and self-sufficient through locally produced food, renewable energy, clean transportation choices, and better management of freshwater resources.

UluPono supports SB 659 SD 1, which exempts from the electronic procurement system the Department of Education's (DOE) purchases of fresh local agricultural products and local value-added processed, agricultural, or food products not exceeding \$100,000, subject to certain requirements. This bill also requires the DOE to establish guidelines for determining a geographic preference for locally sourced products.

UluPono supports the State's farm-to-institution efforts, including the DOE's Farm to School Program, which has the potential to leverage the department's significant buying power to become one of the state's largest purchasers of local food (perhaps one day the largest) while also shaping the tastes, attitudes and eating habits of Hawai'i's keiki for healthy outcomes. The State has committed to local food procurement goals through 2050 (including the DOE's own statutorily required goal of 30% local by 2030), and it is important to provide opportunities for local producers to participate in institutional purchasing.

While the DOE's regional kitchen construction plans advance, the fact remains that these facilities won't be operational for many years. The department should seize current opportunities to strengthen relationships with local food producers. By engaging farmers now, we can align DOE's food requirements with local agricultural production and build supply chain capacity. This proactive approach not only serves today's students better than waiting for kitchen completion, but also sets up the regional kitchen strategy for long-term success — ensuring a robust supply chain is ready when these facilities open.

Investing in a Sustainable Hawai'i



By expanding the small purchase exemption for the DOE, schools across the state will have an additional tool now to procure fresh products from local farmers and ranchers.

Aloha Chair Dela Cruz, Vice-Chair Moriwaki, and Members of the Committee:

I am Brian Miyamoto, Executive Director of the Hawai'i Farm Bureau (HFB). Organized since 1948, the HFB is comprised of 1,800 farm family members statewide and serves as Hawai'i's voice of agriculture to protect, advocate and advance the social, economic, and educational interests of our diverse agricultural community.

The Hawai'i Farm Bureau supports SB 659, SD1, which allows the Department of Education to procure fresh local agricultural products and local value-added processed agricultural or food products under \$100,000 without using an electronic procurement system. It also requires the department to establish guidelines with a geographic preference for locally sourced products.

Hawai'i's Farm to School program plays a crucial role in improving student nutrition, supporting local farmers and ranchers, and increasing the state's food security. The state has committed to sourcing at least 30 percent of school meals from local food sources by 2030 under Act 175, SLH 2021. However, one of the main challenges in achieving this goal has been the complexities of the procurement process, which has historically favored large, out-of-state suppliers over local farmers.

SB 659, SD1 addresses this issue by exempting the Department of Education's purchases of fresh local agricultural products and value-added food products under \$100,000 from the electronic procurement system. This change will streamline the purchasing process and make it easier for local farmers and ranchers to participate in school food procurement. By allowing DOE to establish geographic preferences, the bill ensures that local producers are given a fair opportunity to compete in supplying Hawai'i's schools.

Increasing DOE procurement of locally grown agricultural products will help create a stable and reliable market for local farmers, encouraging them to expand production. Currently, many farmers hesitate to scale up operations due to uncertainty in demand. By

simplifying the purchasing process, SB 659, SD1 helps provide the consistency that local farmers need to plan, invest, and grow more food for Hawai'i's students.

To fully support the success of this initiative, the Hawai'i Farm Bureau encourages additional efforts to assist local farmers and ranchers in navigating the procurement system. Educational workshops, technical assistance, and direct collaboration between DOE and local producers will further enhance participation and ensure that Hawai'i-grown food reaches students across the state.

We urge the committee to pass SB 659, SD1 to support local farmers, strengthen Hawai'i's Farm to School program, and increase the availability of fresh, locally grown food for Hawai'i's students.

The Hawai'i Farmers Union is a 501(c)(5) agricultural advocacy nonprofit representing a network of over 2,500 family farmers and their supporters across the Hawaiian Islands. **HFU supports SB659.**

SB659 seeks to streamline the procurement of locally sourced agricultural products for Hawaii's public schools by exempting purchases under \$100,000 from the electronic procurement system and requiring the Department of Education (DOE) to establish guidelines with a geographic preference for locally sourced products.

Instead of broadly directing DOE to establish "guidelines", the bill should explicitly align these guidelines with HRS §103D-1002 (Hawaii product preferences) and enhance them by mandating the purchase of locally sourced products when priced within 10% of the lowest out-of-state option and recognizing discretionary purchases up to 15% higher with justification. This ensures stronger support for Hawaii's farmers while maintaining cost efficiency in school food procurement.

Alaska's Sec. 29.71.040 provides a model, requiring state-funded entities to buy in-state agricultural and fisheries products if they are of similar quality and price, with a 7% mandatory preference and 15% discretionary preference.

****Proposed Amendment to Section 1 §302A(b):****

"The department shall establish guidelines with a geographic preference for locally sourced products when procuring products. The guidelines shall include the following provisions:

(1) The department shall award contracts for locally sourced products if the cost is no more than 10% higher than the lowest-priced out-of-state option; and

(2) The department may award contracts for locally sourced products if the cost is no more than 15% higher than the lowest-priced out-of-state option, provided that justification for the selection is documented."

This adjustment strengthens the bill's intent by ensuring that Hawaii's procurement policies prioritize local food while remaining flexible for budgetary considerations.

Aloha Chair Donovan M. Dela Cruz, Vice Chair Sharon Y. Moriwaki, and Members of the Senate Committee on Ways and Means,

Hawaii Food+ Policy is in strong support of SB659 SD1, which proposes to streamline procurement processes for the Department of Education by allowing the purchase of fresh local agricultural products and value-added food products up to \$100,000 without requiring an electronic procurement system, while maintaining compliance with existing procurement rules for purchases under \$25,000.

This bill directly supports Hawai'i's ongoing efforts to strengthen local agriculture and food sustainability. By simplifying procurement requirements, SB659 SD1 reduces barriers that may currently prevent small-scale farmers and producers from participating in institutional purchasing. These changes will enable schools to source more fresh, locally grown products, benefiting both students and the local economy.

SB659 SD1 aligns with Hawai'i's local procurement objectives established in Act 176 (SLH 2021), Act 144 (SLH 2022), and Act 175 (SLH 2021), which emphasize increasing local food procurement minimums. SB659 SD1 would also support local farm-to-school initiatives. By raising the small purchase threshold, the safeguards against parceling would also still be acknowledged but not prohibitive. This bill will help the Department of Education meet all of the above goals while ensuring accountability through Hawaii Compliance Express.

Additionally, the potential to allow quicker payment methods such as checks or cash will ease financial burdens on small producers, encouraging greater participation. This measure will foster new and stronger relationships between schools and local farmers while advancing Hawai'i's food security and sustainability goals.

We respectfully urge your support for SB659 SD1 as a critical step toward strengthening our local food systems and supporting Hawai'i's agricultural community.

As a Nutritionist, I have extensively researched and written on the importance of consuming locally-sourced fruits and vegetables for human health/longevity, economic health, and planetary health.

An increasingly large body of scientific evidence shows that improved access to local fruits and vegetables leads to improved health outcomes and reduced markers of long-term chronic illness. Locally-sourced produce is generally more nutrient-dense than imported counterparts. A diet high in locally-sourced plants resembles the food patterns of ancient Hawaiians, who experienced far lower rates of chronic diseases we currently see in our communities (obesity, Diabetes, metabolic syndrome, hypertension, etc...)

Evidence also shows that local purchases support the local economy. Importantly, it will encourage local food production, which improves the state's food security and food sovereignty. Finally, increased local food production reduces the state's reliance on imported foods, improving our resilience and reducing carbon emissions from cargo shipments (one of the world's major polluters).

This bill will support the health of our communities, our land, and our economy. I strongly support this bill.

****Proposed Amendment to Section 1 §302A(b):****

“The department shall establish guidelines with a geographic preference for locally sourced products when procuring products. The guidelines shall include the following provisions:

(1) The department shall award contracts for locally sourced products if the cost is no more than 10% higher than the lowest-priced out-of-state option; and

(2) The department may award contracts for locally sourced products if the cost is no more than 15% higher than the lowest-priced out-of-state option, provided that justification for the selection is documented.”

This adjustment strengthens the bill's intent by ensuring that Hawaii's procurement policies prioritize local food while remaining flexible for budgetary considerations.
