

**DEPARTMENT'S POSITION:** The Department of Human Services (DHS) appreciates the intent of this bill and provides the following comments.

**PURPOSE:** The purpose of the bill requires the Department of Human Services to adjust the minimum certification periods for Supplemental Nutrition Assistance Program benefits households, participate in the Elderly Simplified Application Project, and report to the Legislature. Effective 7/1/2027. (SD1)

The Committee on Health and Human Services amended this measure by:

- (1) Inserting an effective date of July 1, 2027, to allow the Department of Human Services to complete the implementation of its new eligibility system for the Supplemental Nutrition Assistance Program; and
- (2) Making technical, nonsubstantive amendments for the purposes of clarity and consistency.

The Department has identified that the current SNAP household count is at approximately 84,000, with the number of individuals participating totaling nearly 160,000.

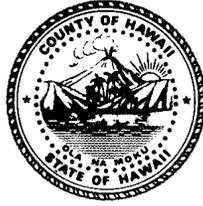
Individuals aged sixty (60) years of age or older comprise twenty (20) percent of the overall number of SNAP participants and are part of approximately thirty-five (35) percent of all SNAP households. More research is needed to determine the number of households that are only composed of individuals aged sixty (60) years or older and the number of households entirely composed of adults with disabilities. However, we anticipate the proposed change to the number of eligible senior households would increase the overall workload and overload the processing capacity to process benefit eligibility determination using our current eligibility system and the present workforce.

The U.S. Department of Agriculture (USDA), Food and Nutrition Service (FNS) oversees SNAP and allows states the option to extend the certification period for SNAP households aged sixty years or older from twelve (12) months to twenty-four (24) months without a waiver. However, due to limitations of our present eligibility system, certification periods cannot be extended automatically beyond the 12 months.

The Department will be implementing a new eligibility system in the fall of 2026 that will be able to support what is proposed in this measure by having the ability to implement and automate the extended 24-month certification period.

I am writing to you in strong support of SB 961 SD1, extending certification periods for most Supplemental Nutrition Assistance Program, (SNAP) households, including up to 36 months for kūpuna households.

Supplemental Nutrition Assistance Program, SNAP provides essential support to families, but the complicated application and recertification process often causes eligibility issues, resulting in recipients losing their much-needed benefits.

### **Hawaii Substance Abuse Coalition Supports SB961 SD1:**

*ALOHA CHAIR, VICE CHAIR, AND DISTINGUISHED COMMITTEE MEMBERS. My name is Alan Johnson. I am the current chair of the Hawaii Substance Abuse Coalition (HSAC), a statewide organization for substance use disorder and co-occurring mental health disorder treatment and prevention agencies and recovery-oriented services.*

By increasing access to nutritional meals, especially for the elderly, SNAP (Supplemental Nutrition Assistance Program) **plays a crucial role in supporting individuals during their recovery process** when dealing with mental health conditions and substance use disorders:

1. **Support During Recovery:** Individuals undergoing treatment for substance use disorders or mental health issues often need additional resources to stabilize their lives. SNAP provides essential support to ensure they can focus on recovery without worrying about food access.
2. **Improved Treatment Outcomes:** Studies show that food insecurity is linked to worse outcomes for people with mental health conditions. SNAP may help improve adherence to treatment plans, better medication efficacy, and greater engagement in therapy.
3. **Indirect Community Support:** SNAP also supports caregivers and families of individuals with behavioral health illnesses. When families can access healthy meals, it creates a more stable and supportive environment for everyone.
4. **Reduced Financial Stress:** Many people with behavioral health illnesses face financial instability due to employment challenges or medical costs. SNAP helps reduce food insecurity, alleviating one major source of stress, which can exacerbate mental health symptoms.

By updating eligibility systems and workforce, SNAP will improve nutrition, reduce food insecurity and provide critical support, SNAP benefits act as a foundation for better health and recovery for those managing behavioral health challenges.

Chair Dela Cruz, Vice Chair Moriwaki, and Members of the Committee:

The Hawaii Primary Care Association (HPCA) is a 501(c)(3) organization established to advocate for, expand access to, and sustain high quality care through the statewide network of Community Health Centers throughout the State of Hawaii. The HPCA **SUPPORTS** Senate Bill No. 0961, Senate Draft 1, RELATING TO THE SUPPLEMENTAL NUTRITION ASSISTANCE PROGRAM.

By way of background, the HPCA represents Hawaii's Federally Qualified Health Centers (FQHCs). FQHCs provide desperately needed medical services at the frontlines to over 150,000 patients each year who live in rural and underserved communities. Long considered champions for creating a more sustainable, integrated, and wellness-oriented system of health, FQHCs provide a more efficient, more effective and more comprehensive system of healthcare.

This measure, as received by your Committee, would direct the Department of Human Services (DHS) to:

- (1) Set the minimum certification periods for Supplemental Nutrition Assistance Program (SNAP) benefits to 24 months for households in which all adult members are 60 years of age or older, and 12 months for all other households;
- (2) Participate in the SNAP Elderly Simplified Application Project to adjust the benefit periods and other requirements for recipients based on age and disability status; and
- (3) Report demographic and utilization data to the 2027 and 2027 Legislatures.

This bill would take effect on July 1, 2027.

SNAP, formally known as the "Food Stamps Program", is the largest federal food assistance program that is currently in operation. It provides food-purchasing assistance for low- and no-income people. SNAP provided assistance to approximately 40 million persons in 2018, at an expenditure of \$57.1 billion. Approximately 9.2% of American households received SNAP benefits at some point during 2017, with approximately 16.7 of all children living in households receiving SNAP benefits.

Founded during the height of the Great Depression, SNAP is the cornerstone of our national social safety net. It is intended to prevent mass starvation precipitated from unemployment and homelessness. The program was also seen as a way of helping the poor while boosting the economy and ensuring that America's farmers would obtain a fair price for their labors by allowing government to purchase and distribute excess goods in time of crisis.

The COVID-19 Pandemic demonstrated how food scarcity and poverty threatened the health and welfare of our citizens in times of dire crisis. With so many people unemployed, entire families struggled to put food on the table on a consistent basis. Lines at the food bank and food drives stretched for miles and people waited for hours to receive surplus food.

While COVID-19 no longer poses the threat it did in years past, Hawaii's citizens still struggle because of stagnant wages and the rising cost of housing, food and other essentials. The lines for surplus food are still long as citizens continue to be challenged in putting food on their tables.

The HPCA has strongly endorsed this Program in previous years and we continue to urge your support. Additional SNAP benefits for a recipient can mean the difference between having to decide whether someone's last amount of cash will go for food or rent or medications or other necessities.

**For these reasons, the HPCA respectfully urges your favorable consideration of this measure.**

Dear Chair Dela Cruz, Vice Chair Moriwaki, and members of the Committee:

Thank you for the opportunity to submit testimony in support of **S.B. 961**, which would require the Department of Human Services (DHS) to adjust the minimum certification periods for Supplemental Nutrition Assistance Program (SNAP) benefits households, participate in the Elderly Simplified Application Project (ESAP), and report to the Legislature.

SNAP is a critical lifeline for more than 160,000 Hawai‘i residents. Without it, many of these individuals would not have any money to pay for food at all. Since benefits are federally funded, federal rules require tedious paperwork and documentation both upon initial application and for periodic recertification.<sup>1</sup> Some SNAP users lose these crucial benefits during the recertification process, despite no changes to eligibility. This phenomenon, known as “churn,” adds significantly to the administrative burden of administering SNAP at the state level.

This bill would provide some relief for the churn issue. Federal rules allow states to extend the SNAP certification period to 12 months for most households, with just a six-month “interim report.” However, Hawai‘i currently requires a full recertification every six months, increasing the possibility for churn. For households with seniors or people with disabilities, Hawai‘i allows a longer 12-month certification, but for these households, it can be as long as 24 months, or even up to 36 months using what’s known as the ESAP waiver. In addition to the three-year certification period, this waiver allows those who are 60+ to waive the recertification interview and allows for a simplified application process. As of 2024, 23 other states have already implemented ESAP and there are more to follow suit.<sup>2</sup>

**Table 1. Hawai‘i certification periods vs. maximum federal certification periods**

Group	Hawai‘i’s current certification period	Maximum allowable certification period
Kūpuna (ages 60+) or adults with disabilities	Every 12 months	Every 36 months*
All other households	Every 6 months	Every 12 months

\*36 months is only allowable as part of the ESAP waiver; 24 months requires a simpler waiver application

The proposed extended certification periods for most households have twofold benefits, reducing workload for both applicants and eligibility staff. We have a unique opportunity to ease the burden on both sides of the application process. Thank you for considering these comments in your deliberation of S.B. 961.

On behalf of Hawai'i Children's Action Network Speaks!, I am writing in **SUPPORT of SB 961 SD1**. This bill requires the Department of Human Services (DHS) to adjust the minimum certification periods for Supplemental Nutrition Assistance Program (SNAP) benefits households, participate in the Elderly Simplified Application Project (ESAP), and report to the Legislature.

In Hawai'i, SNAP plays a critical role in supporting many of our most vulnerable residents. In fact, more than half of SNAP recipients in Hawai'i are in families with children, and SNAP lifted 62,000 people above the poverty line in Hawai'i, including 26,000 children, per year between 2015 and 2019, on average.<sup>1</sup>

The average SNAP benefit per household with children in Hawai'i was \$1,098 per month in fiscal year 2022. In 2024, Hawai'i received \$732.5 million in SNAP benefits, not only lifting up low-income families, but also directly supporting approximately 900 food retailers in Hawai'i.

There is a lot of room to enhance SNAP's reach. From 2017 to 2019, only 62% of eligible Hawai'i residents participated in SNAP,<sup>2</sup> indicating that there are tens of thousands people in Hawai'i who need the support of SNAP but are not getting it.

These measures proposed in this bill would streamline access to SNAP benefits for all households, but particularly for Hawai'i's elderly and disabled populations. By simplifying access and reducing administrative hurdles, the state can ensure that more eligible Hawai'i residents receive the assistance they need and that the local economy is boosted with more dollars going to local food retailers.

Mahalo for this opportunity to provide testimony. Please pass this bill.

HFIA supports this measure. Food insecurity has reached alarming rates in our state in recent years. Current data suggests up to 30% of families in the State face food insecurity and that in some areas that number could be as high as 40%.

The Supplemental Nutrition Assistance Program (SNAP) is a vital resource to help families in need in Hawaii. It also benefits all Hawaii consumers by bringing much needed Federal funds into our food systems and acting as a stabilizing force in the food industry at large.

Hawai'i Public Health Institute (HIPHI)<sup>1</sup> and the Healthy Eating, Active Living<sup>2</sup> (HEAL) coalition is in **support with amendments of SB 961**, which requires the Department of Human Services to adjust the minimum certification periods for Supplemental Nutrition Assistance Program benefits for households, and would participate in the Elderly Simplified Application Project.

**Please amend this bill for it to go into effect in 2025, not 2027.**

One in three households in Hawai'i faces food insecurity. Federal Supplemental Nutrition Assistance Program (SNAP) benefits are a lifeline to many of these residents. Local families in need receive over \$600 million annually in SNAP benefits. Unfortunately, the state has made accessing these benefits incredibly difficult. The state needs to improve the enrollment process and ensure local SNAP-eligible residents can receive the federal benefits they need.

## Short Certification Periods

Residents in Hawai'i face frequent SNAP recertification requirements, with some needing to re-certify as often as every six months. Kūpuna (60 years and over) are required to recertify annually, even though federal regulations permit them to do so only once every three years.<sup>3</sup>

Hawai'i has the opportunity to extend SNAP certification periods to the federal maximum for all recipients. This change would significantly reduce the paperwork burden on families and kūpuna, easing stress and administrative challenges.

Importantly, it would also reduce the risk of losing benefits during the recertification process, a common issue caused by paperwork difficulties and bureaucratic barriers. By adopting this policy, Hawai'i can ensure more consistent access to essential food assistance for its residents.

#### **Decreased Workload for SNAP Staff**

Hawai'i's SNAP department faces overwhelming demand for its services, yet it lacks sufficient staffing to meet that demand effectively. By reducing the frequency of recertification, the department can significantly decrease its administrative workload.

This would free up valuable resources and allow staff to focus on improving the overall efficiency and accessibility of both the SNAP application and recertification processes. Streamlining these operations would benefit not only the department but also the thousands of residents who rely on SNAP for essential food assistance.

#### **Manual Extension is Better than No Extension**

While the current SNAP eligibility system may not be designed to automatically accommodate three-year certification periods, manually extending certifications is a far more efficient solution than requiring full reapplications. The time required for staff to manually process an extension is significantly less than the time needed to review a new application, reducing administrative burden and ensuring continued access to food assistance for those in need. We cannot afford to delay this critical change based on the uncertain timeline of a new eligibility system that may eventually support it.

Please pass SB 961 to ensure we're doing everything we can to make SNAP as accessible as possible. Mahalo for your consideration.

Dear Chair Dela Cruz, Vice Chair Moriwaki, and members of the Committee,

The Hawai'i Hunger Action Network, a coalition of more than twenty local organizations with the mission to advocate for food security for Hawai'i households, would like to express strong support for **SB 961**. This bill would require the Department of Human Services (DHS) to adjust the minimum certification periods for Supplemental Nutrition Assistance Program (SNAP) benefits households, participate in the Elderly Simplified Application Project (ESAP), and report to the Legislature.

SNAP is critical to the over 160,000 residents who receive benefits in Hawai'i. However with 1 in 3 households experiencing food insecurity, it is still not reaching everyone who needs help. One issue our Network members report is that the frequent need to recertify can result in some families losing benefits, even when they still qualify. Extending certification periods to the maximum allowable by federal law could alleviate the burden on both applicants and SNAP staff workers.

This bill would extend the certification period to 12 months for most households and up to 36 months for kūpuna and people with disabilities—an opportunity to reduce the risk of losing benefits due to paperwork issues. Following suit of 23 other states, implementing ESAP would also simplify the process by allowing kūpuna to waive recertification interviews.<sup>1</sup>

Mahalo for your leadership and for your consideration of **SB 961**. Extending SNAP certification periods will be a tremendous relief for struggling families as well as eligibility staff.
