Chair DeCoite, Vice-Chair Wakai, and members of the Senate Committee on Economic Development & Tourism, the Department of the Prosecuting Attorney of the City and County of Honolulu ("Department") submits the following testimony in <u>strong opposition</u> to S.C. R. 121.

My name is Steve Alm and I am the Prosecuting Attorney for the City and County of Honolulu. My number one job is to protect the people of our county. This resolution, if passed, would promote an activity that would be harmful to the residents of Hawai'i. Gambling is illegal for good reasons.

The purpose of Senate Concurrent Resolution 121 is to request that the Department of Business, Economic Development, and Tourism set up a gaming working group. One of the charges that this group will have is to "...[d]evelop a comprehensive tourism gaming policy framework that would serve as a catalyst for economic growth, job creation, capital investment, and a significant source of tax revenue for the State..." We stand in *strong opposition* to this resolution because it will open the door to legalize gambling in our state. One need only to look at some of the participants on the working group (Boyd Gaming, DraftKings, and BetMGM) to see the intent of this resolution. Legalizing gambling will not serve our community and will only increase the societal harms from gambling that citizens already suffer from because they partake in illegal gambling.

The societal costs are real for many people in our state despite gambling being illegal. In a 2016 article in the Hawai'i Journal of Medicine & Public Health, the estimated "social and

financial damage from problem gambling" was \$26,300,000.¹ This study found that each problem gambler could "cost society \$1200 each year." This was the cost in 2016. Since then these costs have risen which means that we are paying more, already. Problem gamblers also "suffer from other addictions, mental illness, and medical problems", all which "place a high burden on our healthcare system."²

Research from the University at Buffalo Clinical and Research Institute on Addictions found:

- An estimated 750,000 of America's youth between the ages of 14 and 21 are problem gamblers (they gamble more than intended or steal money to support gambling).
- 11% of youth gamble twice per week or more; 68% report gambling at least once in the past year.
- Frequent and problem gambling numbers rise as socioeconomic status (SES) declines; gambling involvement tends to decrease as SES rises. ³

Recent research by the Rady School of Management (University of California San Diego) found that "legalization leads to more irresponsible gambling spending among lower-income consumers than many higher-income gamblers."⁴ Given Hawai'i's high cost of living, do we really want to do harm to our poorer residents?

Research has also found that legalized sports wagering increases intimate partner violence. "...[W]hen sports gambling is legalized, the effect of NFL home team upset loses on intimate partner violence increases by around ten percentage points."⁵

These statistics beg the question--Why do we need to study an activity that we already know will cause harm to our citizens? Some will pose the argument that people are already gambling, even though it is illegal. In fact, the illegality of this activity in our state is the very tool that is keeping many more from participating in it. Once we promote legalized gambling and put the societal stamp of approval on it, many individuals who are deterred from wasting their lives and finances away, will then participate. This is not worth the few extra tax dollars legal gambling would generate.

Finally, given the availability of gambling in other locations, no one will be coming to Hawai'i specifically to gamble. Any tourist who gambles means its money not spent on dinner at a local shop or restaurant or a visit to the Polynesian Cultural Center.

My name is Brandon Maka'awa'awa, and I strongly oppose SCR 121.

We cannot build gaming policy for Hawai'i by giving power to those who stand to profit the most. This resolution places gaming operators in a working group intended to shape regulations that will govern them. That is not responsible policy development. It is a conflict of interest.

This resolution gives the impression that the policy direction has already been set, rather than explored objectively. A true working group should reflect fairness, transparency, and community leadership, not corporate leverage.

Even House policymakers raised this concern just days ago. They questioned why gaming companies were specifically named when other industries, like labor and social services, were not. Having members say that the table has already been set is not only concerning but makes us question who is looking out for the best interest of not just Native Hawai'ians but all of Hawaii. Several acknowledged that if industry experts are involved at all, they should be limited to providing data, not influencing decisions.

The Nation of Hawai'i is not opposed to discussions about gaming. But if we are going to have them, we must ensure Native Hawaiians and other key stakeholders have real influence. Any policy that affects our land, our people, and our economy should be built with us, not for us.

For these reasons, I respectfully ask this committee to reject SCR 121 and instead support a more balanced, community-first approach.

Aloha Chair DeCoite, Vice Chair Wakai, and Members of the Committee,

I respectfully urge you to reject SCR 121. This resolution grants corporate gaming companies direct influence in shaping the very policies that are supposed to regulate them. This approach puts private interests before public good and undermines the integrity of the policymaking process from the outset.

A working group of this importance should be rooted in fairness and transparency, not shaped by commercial operators who have a financial stake in the outcome. While industry input can be useful in a technical advisory capacity, it is not appropriate for those same companies to serve as decision-makers. This concern was shared by several members during the House debate, who questioned the inclusion of specific companies and the absence of voices from labor, social services, and other key sectors.

This is especially troubling given that some of the companies now seeking a role in this process have previously opposed the legalization of gaming in Hawai'i. The sudden interest in joining the conversation appears driven more by profit than by public policy, and it raises valid concerns about long-term intent.
