Chair Rhoads, Vice Chair Gabbard, and Committee Members:

The League of Women Voters of Hawaii <u>strongly supports SCR 158, Proposed SD1</u>, which urges the President of the United States, and all members of any current and future administrations, to abide by the laws of the United States pf America, including by complying with orders issued by United States Courts.

We urge the President of the United States to support a system of checks and balances as established by the Constitution.¹

We urge the President to follow Constitutional provisions regarding the number of terms allowable for a President. ²

We urge our President to respect appointed judges and justices.3

¹ On April 14, 202, Donald Trump said "When somebody's the President of the United States, the authority is total, and that's the way it's got to be."

² Last weekend the President insisted it would be possible to seek a third term as President. "There are methods which you could do it," he said, including a scenario in which Vice President J.D. Vance ran at the top of the 2028 ticket with Donald Trump as his running mate, only for Donald Trump to assume the Oval Office after the election."

³ In January 2016 Donald Trump expressed disdain for our justice system, joking that he could commit a capital crime without repercussions: "I could stand in the middle of Fifth Avenue and shoot somebody, and I wouldn't lose any voters, OK?. "It's, like, incredible."

Especially concerning the President's recent executive order mandating that the federal Election Assistance Commission requires documentation of citizenship on national voter registration forms. It is already illegal for noncitizens to register and vote in federal or state elections. This new process creates another barrier to voting, is unnecessary and seeks to divide us. The League of Women Voters stands opposed to onerous barriers that threaten the right to vote. The League of Women Voters seeks to make democracy work, encourages eligible citizens to register to vote, then vote.



The Hawai'i State Teachers Association (HSTA) <u>supports</u> SCR158, proposed SD1 which urges the President of the United States, and all members of any current and future administration, to abide by the laws of the United States of America, including by complying with orders issued by the United States courts.

Our nation currently faces significant federal uncertainty and a likely constitutional crisis as government officials, including those at the highest levels, disregard the very laws and judicial orders they are sworn to uphold. Dear Chair Rhoads, Vice-Chair Gabbard, and Members of the Committee:

The Rule of Law.

Where has it gone? It is unbelievable that that we are now having to urge the President of the United States, and all members of any current and future administration to abide by the laws of the United States, including by complying with orders issued by the United States courts.

To say that their "unprecedented actions" are unauthorized by law, arbitrary and capricious, and motivated by unconstitutional animus is an understatement. This Trump nightmare brought to us by Project 2025 is instituting a new normal: the judiciary becoming powerless to order any relief for those who should be protected under the U.S. Constitution. If that's true, the laws are meaningless—all of them—because Trump and his goons can do whoever they want, wherever they want, whenever they want, and no court can do anything about it once it's done.

As former federal Judge Paul Grimm succinctly stated: "Without those checks and balances, we don't have the rule of law. No right of any individual in this country is safe".

My family has long understood the price of freedom—not in the abstract, but in blood and courage. My maternal grandfather was born and raised in St. Nolff, a small town in Brittany, France. During the Second World War, members of my family were part of the French Resistance. They risked everything—confronting the Gestapo, operating in secrecy, enduring fear and uncertainty—because they refused to live under tyranny.

Last June, I traveled to Normandy for the anniversary of the D-Day invasion. Standing on those beaches, looking up at the German fortifications that still scar the cliffs, I was struck by the sheer audacity and bravery of the Allied forces. Our soldiers were mowed down in waves, and yet they kept advancing. The cost was staggering—but they knew what was at stake. The world was teetering on the edge of permanent despotism.

That Allied victory was only possible because of the combined courage of the American, British, and Canadian troops *and* the resistance movements throughout occupied Europe—including families like mine in Brittany. Their sacrifices spared us from 79 years of fascist rule.

Today, I testify not only as a citizen or as a civil rights attorney, but as a descendant of people who faced down fascism and paid the price. The atmosphere we are living in now—the growing authoritarianism, the assault on truth, the scapegoating of the vulnerable—bears a disturbing

resemblance to the 1930s in Germany. History does not repeat itself exactly, but it rhymes. And I recognize the tune.

We must not allow complacency to become complicity. What we do now—what *you* do as legislators—will determine whether this democracy holds. My family didn't stand down then. I won't stand down now nor we all those in Hawai'i who care about living under the rights provided by not only our federal constitution but also under our Hawai'i constitution.

Conclusion

With this history embedded in our minds and now facing these simply horrific violations of our U.S. Constitution, our law firm **strongly supports the Proposed SD1**, urging the Judiciary Committee to approve it.

The Federalist No. 51, at 321 (James Madison) ...Per the Constitution's design, the Hawai'i Constitution supplies an additional guarantee of individual rights. See, e.g., State v. Honorable Karl Rhoads, Chair; Honorable Mike Gabbard, Vice-Chair, and members of the committee:

I support this strong and proper expression of our legislature in supporting the rule of law in the proposed draft of SCR 158.

Our system of government is based on separating powers among three co-equal and independent branches of government. Each branch checks the other two to prevent any one branch from becoming too powerful.

From the earliest days of his second term, the President has sought to control federal spending without Congress, stopping payments or canceling numerous grants and loans authorized by the legislative branch. This action violated the U.S. Constitution's core separation of powers, as well as the Impoundment Act (enacted when former President Richard Nixon attempted similarly usurpation of the Congress' power of the purse). The administration has also sought to unilaterally shut down Congressionally-created agencies, including the U.S. Agency for International Development (USAID), the world's largest humanitarian organization, and has moved to hamstring the U.S. Department of Education. The administration has effectively shuttered the Consumer Financial Protection Bureau, created after the 2008 financial crash to protect consumers from financial fraud. Scientists, researchers and universities across the country have seen funds cut off vital and unfinished studies and research.

State attorneys general, public employees, and nonprofits have petitioned federal courts, and judges have almost uniformly blocked the executive's attempts to usurp legislative power. A key underpinning of the U.S. rule of law is the executive branch's commitment to respect Congress's power of the purse—the legislative branch has the sole authority to pass laws that determine where and how federal dollars should be spent. Similarly, the executive branch must also respect the judiciary's legal decisions, and not cherry-pick which rulings it will follow.

It's fundamental to our constitution and the rule of law that people must follow court orders. The President and his administration are no different. Since at least the Civil War, Presidents have complained about court rulings but have followed them. As U.S. Chief Justice John Roberts recently reminded, whatever debates there might be about the powers of the three branches of the

federal government, if someone doesn't like a lower court ruling, the remedy is to appeal it — NOT ignore it, intentionally disobey it, slow-walk compliance, or attempt to intimidate or threaten the judge (by impeachment or bodily harm) who made the decision.
