Chair Gabbard, Vice Chair Richards, and Members of the Committee,

The Hawaii Cattlemen's Council **supports SCR164/SR133** which requests the Department of Agriculture to adopt rules authorizing rodeos on lands zoned for agricultural use.

Rodeo values and skills are closely intertwined with paniolo cattle production. These events serve all ages and teach the participants responsibility and love of the land, while providing the community with a way to connect more closely to the hard work that goes into producing the food on their plate. Moreover, these rodeos often serve as fundraising events for the community. We support DOA adopting rules to authorize rodeos on agricultural land.

We appreciate the opportunity to testify on this measure. The Hawaii Cattlemen's Council (HCC) is the Statewide umbrella organization comprised of the four county-level Cattlemen's Associations. Our member ranchers represent over 60,000 head of beef cows; more than 75% of all the beef cows in the State.
