Testimony in Support of SR174/SCR194 - Reduce Disposable Surgical Equipment in Health Care Services

The Environmental Caucus of the Democratic Party of Hawaii submits this testimony in strong support of SR174/SCR194, requesting the Department of Health to reduce the use of disposable surgical equipment and adopt sustainable practices in the provision of health care services, taking examples from California and Japan.

Key Points in Support:

1. **Environmental Impact:** Disposable surgical equipment contributes significantly to medical waste, much of which ends up in landfills or incinerators, exacerbating Hawaii's waste management challenges. Transitioning to sustainable practices can dramatically reduce the ecological footprint of the healthcare sector.
2. **Global Examples:** California has already made strides toward waste reduction in healthcare facilities through initiatives like reusable surgical gowns and instruments, which have reduced overall waste and saved costs in the long term. Japan has implemented similar practices, integrating sterilization technology to safely reuse medical equipment, setting an example of sustainability in healthcare.
3. **Economic Benefits:** While the initial investment in reusable surgical equipment may be higher, the long-term cost savings are significant. Reusable equipment reduces the need for constant procurement of disposable items and decreases waste disposal costs for hospitals and clinics.
4. **Public Health and Safety:** Sustainable healthcare practices promote a cleaner environment, which in turn supports public health. Reducing disposable waste minimizes the risks associated with improper waste disposal, such as contamination or pollution.

5. **Alignment with State Goals:** Supporting this resolution aligns with Hawaii's sustainability initiatives and its commitment to reducing waste and promoting responsible resource use. This effort also reflects Hawaii's role as a global leader in environmental stewardship.

We commend the Department of Health for leading this critical initiative and urge the committee to pass SR174/SCR194, enabling Hawaii's healthcare sector to become a model for sustainable practices.
