**Establishing a Sister State Relationship Between the State of Hawai'i and the Kingdom of Norway**

My name is William F. Anonsen, Managing Partner and Principal of The Maritime Group, and a member of the Consular Corps of Hawai'i. I respectfully would like to express my strong and enthusiastic support for the establishment of a formal Sister State relationship between the State of Hawai'i and the Kingdom of Norway. Such a partnership would not only be forward-thinking and strategically aligned, it would also honor a shared maritime legacy that began nearly a century and a half ago.

As the Managing Partner and Principal of *The Maritime Group*, an international maritime consulting firm based in Honolulu, and a proud member of the Consular Corps of Hawai'i, I have dedicated a significant portion of my career to building international bridges through maritime partnerships and diplomacy. I also speak from personal experience: I was born in Skien, Norway, and my extended family continues to live throughout the country in Oslo, Drammen, Arendal, Ski, and Fredrikstad. My 92-year-old mother still lives independently in Drammen, and I return to Norway often to maintain strong personal and professional ties to my homeland.

That homeland shares a historic link with Hawai'i that dates back to October 1879, when the sailing bark *BETA* sailed out of Drammen, Norway, carrying approximately 300 Norwegians who had signed contracts to work on Hawai'i's sugar plantations. This marked the first organized recruitment of Norwegians for labor in what was seen by many as the "Promised Land" in the Pacific. It was the beginning of a significant, if modest, chapter in Hawai'i's immigration story, as the Hawaiian Kingdom sought skilled and hardy laborers to support its expanding plantation economy.

These early Norwegian immigrants endured long voyages and challenging work under the tropical sun, but many brought with them not only strength and endurance but also values that still resonate in Hawai'i today: craftsmanship, maritime knowledge, and a deep sense of community. Some remained in the islands after their contracts ended, contributing to Hawai'i's diverse cultural and economic landscape.

Today, Hawai'i and Norway continue to share natural affinities as oceanic societies, champions of sustainability, and leaders in innovation. A Sister State relationship would deepen our cooperation in areas such as:

- **Renewable Energy & Green Innovation:** Norway's global leadership in offshore wind, hydrogen, and electrified maritime systems aligns perfectly with Hawai'i's renewable energy goals.

I respectfully encourage the Hawai'i State Legislature and State administration to move forward with a formal resolution and initiate discussions with the Norwegian government to establish this Sister State relationship. I am fully committed to supporting this effort and look forward to assisting in its advancement.
