RECOGNIZING JUNE 21, 2025 AS INDIGENOUS PEOPLE'S DAY, JULY 1, 2025, AS CANADA DAY, AND SEPTEMBER 30, 2025, AS TRUTH AND RECONCILIATION DAY, IN ACKNOWLEDGEMENT OF THE ENDURING FRIENDSHIP BETWEEN THE PEOPLE OF CANADA AND HAWAII, THE INDEPENDENT SOVEREIGNTY AND SELF-DETERMINATION OF THE PEOPLE OF CANADA, AND A COMMITMENT TO NEVER AGAIN ALLOW THE SOVEREIGN RIGHT OF A PEOPLE TO SELF-DETERMINATION TO BE TAKEN AGAINST THEIR WILL.

Chair Kapela, Vice Chair Kong, and members of the Committee. The Department of Business, Economic Development and Tourism (DBEDT) <u>supports</u> **SCR 197 SD1** recognizing June 21, 2025 as Indigenous People's Day, July 1, 2025, as Canada Day, and September 30, 2025, as Truth and Reconciliation Day, in acknowledgement of the enduring friendship between the people of Canada and Hawai'i, the independent sovereignty and self-determination of the people of Canada, and a commitment to never again allow the sovereign right of a people to self-determination to be taken against their will.

DBEDT supports this resolution in friendship and solidarity with our Canadian neighbors.

Hawai'i is home to many part-time residents from Canada and is one of our major overseas visitor markets. We share a history dating back to when Hawai'i was a

kingdom, and commonalities in recognizing the rights of its indigenous peoples and the importance of preserving its culture. And we recognize the sovereign right of a people to self-determination regarding the future of its country.
