Chairs Elefante and Wakai, and members of the Committee:

My name is Jennifer Sabas, and I am the Director of the Daniel K. Inouye Institute. I am pleased to submit testimony in strong support of SCR24 Proposed SD1 regarding the 442<sup>nd</sup> Regimental Combat Team.

The U.S. Army had briefly removed, but a loud outcry from across the nation, added back, the page on its website about the famed 442nd Regimental Combat Team - the most decorated unit of its size in military history. The 442<sup>nd</sup> suffered enormous loss of life, and in Senator Dan Inouye's case, loss of limb, proving their loyalty to this country with their blood, while this same country imprisoned Japanese American families solely because of the color of their skin. Senator Inouye would often share his father's words to him as he prepared to leave the islands, "This country has been good to us. If you must give your life, so be it. Do not dishonor your country. And, do not dishonor your family."

The story of the 442nd Regimental Combat Team is not "radical" Diversity, Equity and Inclusion. How insulting, especially as it comes from those who never put on the uniform or never saw combat. Rather, they are part of the Greatest Generation - brave, understated warriors who loved their country and were willing to shed blood and give up their lives. Many of them did.

*February 1943, upon signing the Executive Order that created the 442nd Regimental Combat Team. The only All Japanese Unit during World War II.*

The Hawaii Military Affairs Council ("MAC") **supports** SCR 24 Proposed SD1, which strongly urges the United States Department of Defense to maintain all references to the 442nd Regimental Combat Team on its websites for the public.

The MAC was established in 1985 when the Chamber was appointed by the State to serve as the liaison to the military. The MAC advocates on behalf of Hawaii's military, and is comprised of business leaders, academic institutions, State and County officials, members of the CODEL, community leaders, labor unions and organizations and retired U.S. flag and general officers. The MAC works to support Hawaii's location as a strategic U.S. headquarters in the Indo-Asia-Pacific region which is crucial for U.S. national and homeland security.

First and foremost, the 442nd Regimental Combat Team are brave warriors who fought to prove their loyalty to this nation during World War II with their blood, and their lives. The recent removal of webpages honoring the 442nd RCT from the U.S. Army's official website sparked widespread protests and calls for immediate restoration. This action threatened to erase the legacy of the most decorated unit of its size in U.S. military history.



The 442nd RCT, composed primarily of Japanese American soldiers, fought heroically in World War II despite facing racism and the incarceration of their families at home. Their motto "Go For Broke" exemplifies their unwavering loyalty and sacrifice for a country that doubted them.

Sharing the story of the 442nd RCT on Department of the Army/ Department of Defense websites ensures that this vital part of American military history, honoring the contributions of brave Japanese American warriors is not forgotten. Patriotism is and should always be color-blind.

HCCR members include: ACLU of Hawai'i; Japanese American Citizens League of Honolulu; Muslim Association of Hawai'i; SILAH; Hawai'i Commission on the Status of Women; Hawai'i Civil Rights Commission; Hawai'i Friends of Civil Rights; Hawai'i Coalition for Immigrant Rights; Honolulu-Hawai'i NAACP; The Refugee and Immigration Law Clinic; African American Lawyers Association; and others.

We support SCR24 (SD1 Proposed) STRONGLY URGING THE UNITED STATES DEPARTMENT OF DEFENSE TO MAINTAIN ALL REFERENCES TO THE 442<sup>ND</sup> REGIMENTAL COMBAT TEAM ON ITS WEBSITES FOR THE PUBLIC.

The 100<sup>TH</sup> Infantry Battalion and the 442<sup>nd</sup> Regimental Combat Team, comprising of Japanese American soldiers in Hawai'i and the US continent, proudly served our country during WWII. Meanwhile, 120,000 Americans of Japanese ancestry on the West Coast, including 2,000 AJAs from Hawai'i, were incarcerated in concentration camps throughout the US.

The US Army, in response to a federal Executive Order, removed all references to the 100<sup>th</sup> Infantry Battalion and the 442<sup>nd</sup> Regimental Combat Team under the auspices of the Executive Branch's mandate to eliminate diversity, equity and inclusion (DEI) references and initiatives. After much outcry, the US Army restored the historic achievements of the 442<sup>nd</sup>/100<sup>th</sup> – the most decorated military unit of its size and service in US history.

A statement from the Hawai'i State Legislature which recognize Japanese Americans as well as all ethnic groups is essential to acknowledge the contributions that diverse communities provide our nation.

REQUESTED AMENDMENT: Please mention and recognize the 100<sup>th</sup> Infantry Battalion, the initial AJA army unit which was then combined with the 442<sup>nd</sup> Regimental Combat Team.


The 100th Infantry Battalion, which would lead to the formation of the 442nd Regimental Combat Team (RCT), is uniquely called “One Puka Puka,” giving a nod to their Hawai‘i roots, since “puka” in Hawaiian means hole, which resembles a zero.

These American of Japanese ancestry (AJA) soldiers of the 100th Infantry Battalion were born in Hawai‘i and served in the multi-ethnic, U.S. Army - Hawai‘i National Guard. After the attack on Pearl Harbor, they endured discrimination and were segregated into the 100th Infantry Battalion because they looked like the enemy. They fought and died in Italy and France for America, the country they loved.

Despite early suspicion and questions of loyalty, they would become, with the 442nd RCT, the most decorated in U.S. military history. The 100th/442nd are the flagship units of the U.S. Army. S.C.R. 24 is a good reminder to keep the 100th/442nd in the forefront to show what these great Americans did for Hawai‘i, America and the world.

Aloha, Chairs Elefante and Wakai and Members of the PSM and EIG Committees:

Thank you for this opportunity to submit testimony in **STRONG SUPPORT** of the Proposed SCR SD1 urging the U.S. Department of Defense to maintain references to the highly-decorated 442nd Regimental Combat Team on its website for the public to view and to be educated.

On February 19, 1942, the President of the United States signed Executive Order 9066 authorizing the forced relocation of Japanese Americans (AJAs) to internment camps. The AJAs lost their freedom, their property, their livelihood, and their dignity, all because they were AJAs. Yet the Nisei sons of those families volunteered to fight for America. They fought two battles - the enemy who made war on America, and here at home, the internal enemy of bigotry.


I am a father and a grandfather and often think about what I would say to a son who wanted to volunteer to fight as I, and the rest of my family were in prison camps. What would I have said? I read that some parents told their sons as they sent them off to war, "Don't shame the family." Would I have said those words or would I, as a father, say "Don't go!" The Nisei sons chose to fight the enemy from without and within. Many did not come home.

It is sad and disturbing that in 2025, the Federal government has chosen to bleach the history of the 442nd from its website. Why? What cogent reason?

America is a diverse nation. And our history, sadly, includes treating that diversity with disdain and cruelty. Yet we also have a record of facing these evils, working to address them and progressing, albeit slowly, to become a community that recognizes the oneness of humanity and celebrating that diversity.

The recent action by the Federal government is a step backwards towards a dark, painful, and ugly period in our history. Let's not let that happen. SCR24 SD1 is a step in the right direction. We must continue to move our country forward and honor the work of the many who came before us, who went through hell for the cause of unity in diversity.
