All of South Maui traffic is channeled from Piilani Highway through a single ingress-egress to Veterans' Highway. Several hours each workday traffic barely moves because of commuting vehicles. If there is a fire or severe flooding, the choke point could be catastrophic. The North-South Collector Road has been in the works for almost three decades with only two segments completed to date. The road will alleviate traffic once complete and will also, critically, provide another ingress/egress for South Maui. The vital segment connecting the southern segments to Veterans' Highway is unfortunately not even scheduled for planning at this time.

Please support SCR38 to start planning the connection of the North-South Collector Road to Veterans' Highway.

As a resident of North Kihei, the North-South Collector Road (NSCR) is a much anticipated, much needed route through Kihei.
