#### A BILL FOR AN ACT

RELATING TO THE DEPUTY DIRECTOR OF HIGHWAYS OF THE DEPARTMENT OF TRANSPORTATION.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. Section 76-16, Hawaii Revised Statutes, is 1 amended by amending subsection (b) to read as follows: 2 The civil service to which this chapter applies shall 3 comprise all positions in the State now existing or hereafter 4 5 established and embrace all personal services performed for the State, except the following: Commissioned and enlisted personnel of the Hawaii 7 (1)National Guard, and positions in the Hawaii National 9 Guard that are required by state or federal laws or

(2) Positions filled by persons employed by contract where the director of human resources development has certified that the service is special or unique or is essential to the public interest and that, because of circumstances surrounding its fulfillment, personnel
