## A BILL FOR AN ACT

RELATING TO FIREARMS.

### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. Section 134-10.5, Hawaii Revised Statutes, is
2 amended to read as follows:

3 "\$134-10.5 Storage of firearm; responsibility with respect 4 to minors. (a) No person shall store or keep any firearm [on 5 any-premises] under the person's control if the person knows or 6 reasonably should know that a minor is likely to gain access to 7 the firearm without [the] permission [of the parent or guardian 8 of the minor], unless the person:

9	(1)	Keeps the firearm in a securely locked box or other
10		container or in a location that a reasonable person
11		would believe to be secure; or

12 (2) Carries the firearm on the person or within such close
13 proximity thereto that the person can readily retrieve
14 and use it as if it were carried on the person.

15 (b) For purposes of this section, "minor" means any person 16 under the age of eighteen years."

Section 707-714.5, Hawaii Revised Statutes, is amended to read as follows: 2 3 "§707-714.5 Criminally negligent storage of a firearm. 4 (1) A person commits the offense of criminally negligent 5 storage of a firearm if the person violates section 134-10.5 and 6 a minor obtains the firearm. [For purposes of this section, 7 "minor" means any person under the age of eighteen years.] 8 (2) This section shall not apply if the minor obtains the 9 firearm as a result of an unlawful entry to any premises by any 10 person. 11 (3) [Criminally negligent storage of a firearm is a 12 misdemeanor.] Any person violating subsection (1) shall be 13 guilty of a misdemeanor; provided that it shall be a class C 14 felony offense if the minor obtains the firearm and it results 15 in the injury of the minor or another person; provided further 16 that it shall be a class B felony offense if the minor obtains 17 the firearm and it results in the death of the minor or another 18 person. 19 (4) For purposes of this section, "minor" means any person under the age of eighteen years." 20
