7 **PART II. PROGRAM APPROPRIATIONS**

8 SECTION 3. APPROPRIATIONS. The following sums, or so much
9 thereof as may be sufficient to accomplish the purposes and
10 programs designated herein, are hereby appropriated or
11 authorized from the means of financing specified to the office
12 of Hawaiian affairs for the fiscal biennium beginning
13 July 1, 2025, and ending June 30, 2027. The total expenditures
14 and the number of positions in each fiscal year of the biennium
15 shall not exceed the sums and the position ceiling indicated for
16 each fiscal year, except as provided elsewhere in this Act, or
17 as provided by general law.

1 PART III. MISCELLANEOUS PROVISIONS AND EFFECTIVE DATE

2 SECTION 4. If any portion of this Act or its application
3 to any person, entity, or circumstance is held to be invalid for
4 any reason, the legislature declares that the remainder of the
5 Act and each and every other provision thereof shall not be
6 affected thereby. If any portion of a specific appropriation is
7 held to be invalid for any reason, the remaining portion shall
8 be expended to fulfill the objective of the appropriation to the
9 extent possible.

10 SECTION 5. If manifest clerical, typographical, or other
11 mechanical errors are found in this Act, the board of trustees
12 of the office of Hawaiian affairs may correct these errors. All
13 changes made pursuant to this section shall be reported to the
14 legislature at its next regular session.

15 SECTION 6. This Act shall take effect on July 1, 2025.
