# A BILL FOR AN ACT

RELATING TO FARM TO FAMILIES.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. The legislature finds that one in three
 households in Hawaii is struggling to secure consistent access
 to food. This data paints a sobering picture of families in
 distress, underscoring the need for immediate action to restore
 the basic dignity of nourishment to every household across the
 islands.

7 The legislature further finds that the crisis 8 disproportionately affects the most vulnerable in Hawaii, the keiki. Nearly thirty per cent of children in Hawaii are growing 9 10 up in food-insecure homes, some enduring entire days without a 11 meal. When experiencing hunger, keiki can face increased risk 12 of cognitive issues, aggression, anxiety, behavioral problems, 13 depression, and suicide ideation. For families facing hunger, 14 fresh, healthy produce is often one of the first things to fall 15 off grocery lists, negatively affecting long-term health.

16 The legislature also finds that this emergency17 disproportionately impacts Native Hawaiian and Pacific Islanders

1 the most, with more than forty per cent of households
2 experiencing hunger, a reflection of longstanding inequities in
3 access to resources, economic opportunity, and essential
4 services. The legislature believes that the State's communities
5 should not bear this burden alone.

6 The legislature recognizes that Hawaii's food banks worked 7 with over five hundred agency partners, such as schools, 8 community-based nonprofits, churches, community centers, and 9 food pantries, to distribute more than twenty-seven million 10 meals in 2023, collectively serving two hundred forty thousand 11 individuals each month, in every community across the State. 12 These numbers are nearing the numbers served during the height 13 of the coronavirus disease 2019 (COVID-19) pandemic, but the 14 support systems available during the COVID-19 pandemic are no 15 longer there.

16 The legislature additionally finds that to try to bridge 17 the gap between the State's food banks and their partners to 18 bring fresh, Hawaii-grown produce to families, the food banks 19 have partnered with five hundred seventy-five local farms and 20 food hubs to create a consistent market for Hawaii agriculture 21 producers, strengthening the State's community food systems and

creating a healthier, more resilient Hawaii. For example, the
 Hawaii Foodbank invested over \$11,000,000 in Hawaii-grown
 produce over the last five years, which, using the local foods
 economic multiplier, equates to an investment of nearly
 \$19,000,000 in the State's local economy.

6 The legislature notes that as the cost of importing food 7 continues to rise, increasing the State's reliance on local 8 agriculture is not only a sustainable solution but also a 9 necessary one. Farmers across Hawaii have the potential to grow 10 more fresh, nutritious food that can directly serve those most 11 in need. By strengthening the connection between local farms 12 and community food systems, the State can reduce its dependence 13 on imports and ensure that more families have access to Hawaii-14 grown produce like Okinawan sweet potato, choy sum, bok choy, 15 long beans, breadfruit, kalo, and more.

16 The legislature further finds that programs that encourage 17 partnerships between farmers and food assistance programs can 18 make a profound impact. By investing in Hawaii-grown 19 agriculture producers, the State can support not only local 20 farmers but also the communities they feed. This approach 21 aligns with the values of mālama 'āina--caring for the land--and

ensures that the State honors the deep connection between the
 land and the people of Hawaii. Uplifting local farmers will
 also uplift the entire community, fostering a more resilient
 food system that can withstand future challenges.

5 Accordingly, the purpose of this Act is to establish and 6 appropriate funds for the Hawaii farm to families program to 7 fund food banks in the State to purchase, store, and transport 8 fresh, Hawaii-grown or -produced food to food insecure 9 communities. This program will serve the State's food needs, 10 provide Hawaii's agriculture producers with a market to support 11 their operations, and keep moneys circulating within the State 12 to boost the local economy.

13 SECTION 2. Chapter 141, Hawaii Revised Statutes, is
14 amended by adding a new part to be appropriately designated and
15 to read as follows:

16 "PART . HAWAII FARM TO FAMILIES PROGRAM
17 \$141- Definitions. For the purposes of this part:
18 "Department" means the department of agriculture.
19 "Food bank" has the same meaning as in title 7 United

20 States Code section 7501(5).

"Fresh, Hawaii-grown or -produced food" means fruits,
 vegetables, nuts, coffee, eggs, poultry and poultry products,
 livestock products, milk and milk products, aquacultural and
 maricultural products, and horticultural products that are one
 hundred per cent grown, raised, and harvested in Hawaii.

6 §141- Hawaii farm to families program. (a) There is
7 established the Hawaii farm to families program to be
8 administered by the department. Under the program, the
9 department shall relieve food shortages by providing funds to
10 food banks located in the State to facilitate consistent supply
11 chains of fresh, Hawaii-grown or -produced food to food insecure
12 communities.

(b) Food banks that receive support pursuant to this
section shall use the funds to purchase, store, and transport
fresh, Hawaii-grown or -produced food in the State to recipients
at no cost to the recipients.

17 §141- Rules. The department shall adopt rules pursuant
18 to chapter 91 necessary for the purposes of this part."

19 SECTION 3. The department of agriculture shall submit a
20 report to the legislature no later than twenty days prior to the
21 convening of the regular sessions of 2026 and 2027 that contains
