## A BILL FOR AN ACT

RELATING TO TRESPASS.

### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that agricultural theft 2 and vandalism are on the rise in the State, with some estimates 3 putting the cost at upwards of \$14 million when accounting for 4 the cost of the crime and preventing it. In addition to the 5 financial burden on farmers and ranchers in the State, 6 agricultural theft and vandalism also pose a threat to the 7 safety of farmers and ranchers in the State, as many trespassers 8 on agricultural lands are armed to illegally hunt game on 9 private agricultural land. Confrontations between trespassers 10 and farmers sometimes turn deadly, for example the death of 11 Cranston Pia in 2024, who was shot while protecting his 12 livestock from a trespasser's hunting dogs. The legislature 13 also finds that existing penalties for trespassers on 14 agricultural land are insufficient to deter criminals from 15 trespassing on agricultural land, as many instances of 16 trespassing fail to result in a prosecution, leading to many 17 trespassers being repeat offenders.

Section 134-7, Hawaii Revised Statutes, is amended by amending subsection (b) to read as follows: 2 3 "(b) No person who is being prosecuted for one or more charges for a felony, a crime of violence, a criminal offense 4 5 relating to firearms, criminal trespass on agricultural land 6 under section 708- , or an illegal sale or distribution of any drug in a court in this State or elsewhere, or who has been 7 8 convicted in this State or elsewhere of having committed a felony, a crime of violence, a criminal offense relating to 9 10 firearms, criminal trespass on agricultural land under section 708- , or an illegal sale or distribution of any drug shall 11 12 own, possess, or control any firearm or ammunition." SECTION 4. This Act does not affect rights and duties that 13 14 matured, penalties that were incurred, and proceedings that were 15 begun before its effective date. 16 SECTION 5. New statutory material is underscored. SECTION 6. This Act shall take effect upon its approval. 17
