RELATING TO TRAUMA-INFORMED CARE.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. The legislature finds that children and 1 2 families who are referred to the department of human services 3 child welfare services branch have undergone a significant 4 amount of trauma. 5 The malama ohana working group created by Act 86, Session 6 Laws of Hawaii 2023, has submitted a report to the legislature that provides recommendations to create transformative changes 7 8 to the State's existing child welfare system. Among the recommendations, the malama ohana working group has put forward 9 a recommendation that calls for all child welfare services **10** branch staff in the department of human services to receive 11 12 comprehensive trauma-informed care training as part of 13 developing a trauma-informed organization. The legislature also finds that, in order for an 14 15 organization to fully adopt a trauma-informed approach, there

must be policies and practices that address the needs of staff,

including training on the impacts of vicarious trauma, secondary

- 1 traumatic stress, and burnout that staff experience as a result 2 of their work. Accordingly, the purposes of this Act are to direct the 3 office of wellness and resilience to collaborate with the 4 department of human services to, either directly or by contract, 5 design, administer, and implement a program for trauma-informed 6 7 organizational assessments and a training curriculum for the department of human services child welfare services branch 8 9 staff, and appropriate funds for the program. SECTION 2. The office of wellness and resilience, in 10 collaboration with the department of human services, shall 11 design, administer, and implement a trauma-informed care 12 organizational assessment and training program, either directly **13** 14 or by contract. 15 The trauma-informed organizational assessment and training curriculum for the department of human services child welfare 16 services branch staff shall specifically include: 17
- 18 (1) An evidence-based assessment tool to help child
 19 welfare services branch staff assess their current
 20 policies and procedures in the context of serving
 21 children and families who have experienced trauma;

1	(2)	An evidence-based assessment tool to measure the
2		degree to which child welfare services branch staff
3		address worker well-being, including the effects of
4		vicarious trauma, secondary traumatic stress, and
5		burnout of all child welfare services branch staff;
6	(3)	A training curriculum that establishes a cohort of
7		trained trainers, as well as a branch-wide trauma-
8		informed care curriculum accompanied by ongoing
9		technical assistance;
10	(4)	Specialized trauma-informed supervisor training and
11		technical assistance to ensure implementation of the
12		curriculum is sustainable; and
13	(5)	A child welfare services expert to consult on the
14		implementation of the assessment findings.
15	SECT	ION 4. There is appropriated out of the general
16	revenues	of the State of Hawaii the sum of \$425,000 or so much
17	thereof as may be necessary for fiscal year 2025-2026 and the	
18	same sum	or so much thereof as may be necessary for fiscal year
19	2026-2027 for the office of wellness and resilience to design,	
20	administer, and implement a trauma-informed care training and	
21	organizational assessment program for the department of human	
22	services	child welfare branch, directly or by contract.

Trauma-informed Care; Office of Wellness and Resilience; Child Welfare Services; Department of Human Services; Assessment; Training; Appropriation

Description:

Directs the Office of Wellness and Resilience to collaborate with the Department of Human Services to, either directly or by contract, design, administer, and implement a program for trauma-informed organizational assessments and a training curriculum for the Department of Human Services child welfare services branch staff, and appropriates funds for the program.

DEPARTMENT:

TITLE:

A BILL FOR AN ACT RELATING TO TRAUMA-

INFORMED CARE.

PURPOSE:

To direct and appropriate funds to the Office of Wellness and Resilience to design, administer, and implement a trauma-informed organizational assessment and a training curriculum for the Child Welfare Services Branch, in collaboration with the Department

of Human Services.

MEANS:

Enact a session law that directs the Office of Wellness and Resilience to collaborate with the DHS to design, administer, and implement a trauma-informed organizational assessments and training curriculum for the DHS Child Welfare Services Branch staff and

appropriates general revenues.

JUSTIFICATION:

Act 86, Session Laws of Hawaii 2023, mandated the Malama Ohana Working Group to submit recommendations to improve and transform the child welfare system. the findings of the Malama Ohana Working Group was that children and families referred to the Child Welfare Services Branch of the Department of Human Services have undergone a significant amount of trauma. To address this finding, the Malama Ohana Working Group submitted a recommendation to develop a trauma-informed system for the DHS Child Welfare Services The trauma-informed care organizational assessment and training proposed in this bill aims to implement the Malama Ohana Working Group recommendation.

Impact on the public: Children and families that are referred to the Child Welfare Services Branch will be able to go through a system that is better prepared to recognize and respond to the trauma that the children

and families have experienced, resulting in minimization of re-traumatization.

Impact on the department and other agencies: The Office of Wellness and Resilience, in collaboration with DHS, will administer, directly or by contract, the development, administration, and implementation of the trauma-informed care organizational assessments and training program. By participating in the trauma-informed organizational assessments and training, not only will Child Welfare Services Branch staff be better equipped to address the trauma of children and families that are referred to the Branch but also be able to adequately address the impacts of vicarious trauma, secondary traumatic stress, and burnout that staff experience as a result of their work.
