A BILL FOR AN ACT

RELATING TO THE DEPARTMENT OF HAWAIIAN HOME LANDS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that geothermal resources 2 can provide stable power and community benefits and are a viable 3 alternative to biofuels. Act 205, Session Laws of Hawaii 2022, appropriated \$500,000 to the department of Hawaiian home lands 4 5 as start-up funding for the exploration of geothermal resources 6 on Hawaiian home lands, so that these resources could 7 potentially be used for the generation, transmission, and 8 production of electricity and renewable energy resources, 9 including but not limited to hydrogen generation.

10 The legislature recognizes that additional moneys are 11 needed for the department of Hawaiian home lands to continue its 12 efforts in collecting geothermal resources data. Appropriating 13 follow-up funding will allow the department of Hawaiian home 14 lands to drill slim holes at certain sites on Hawaiian home 15 lands, develop water wells, collect geophysical data, and hire 16 consultants to help navigate the intricacies of geothermal 17 development.

Accordingly, the purpose of this Act is to appropriate 1 funds for the continued investigation, exploration, and 2 identification of geothermal resources on Hawaiian home lands. 3 SECTION 2. There is appropriated out of the general 4 revenues of the State of Hawaii the sum of \$20,000,000 or so 5 much thereof as may be necessary for fiscal year 2025-2026 and 6 the same sum or so much thereof as may be necessary for fiscal 7 year 2026-2027 to drill slim holes, develop water wells, and 8 continue geophysical data collection, investigation, 9 exploration, and identification of geothermal resources on 10 Hawaiian home lands. 11 The sums appropriated shall be expended by the department 12 13 of Hawaiian home lands for the purposes of this Act. SECTION 3. The department of Hawaiian home lands is 14 authorized to utilize the funds appropriated in section 2 of 15 this Act to hire consultants to assist the department in its 16 geothermal development activities. 17 18 SECTION 4. This Act shall take effect on July 1, 2025.
