RELATING TO MENTAL HEALTH.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECT	ION 1	. (a) The department of health shall construct a	
2	mental he	mental health facility for inmates and detainees in custody of		
3	the depar	rtment of corrections and rehabilitation; provided that:		
4	(1)	The new facility shall provide treatment to any inmate		
5		or detainee who:		
6		(A)	Exhibits signs of mental illness, including a	
7			diagnosis of a mental illness;	
8		(B)	Poses a danger of physical harm to self or	
9			others; or	
10		(C)	Requests treatment and meets admittance criteria	
11			as established by the department of health;	
12	(2)	Trea	tment at the mental health facility is medically	
13		appr	opriate; and	
14	(3)	Cons	idering less intrusive alternatives, treatment at	
15		the	mental health facility is essential to forestall	
16		any	danger posed by the inmate or detainee.

1 The department of health may enter into a (b) 2 public-private partnership to plan, design, and construct the 3 mental health facility. 4 As part of the planning process, the department of (c) health shall host a community partnering meeting to receive 5 6 community input and comments regarding the proposed location, 7 size, programming, and other matters pertaining to the mental 8 health facility. 9 The mental health facility shall be a secure, (d) 10 minimum- to medium-security community correctional facility 11 designed to provide medical treatment to inmates and detainees 12 with mental health needs. 13 SECTION 2. The director of finance is authorized to issue 14 general obligation bonds in the sum of \$ or so much 15 thereof as may be necessary and the same sum or so much thereof 16 as may be necessary is appropriated for fiscal year 2025-2026 17 for the planning, design, and construction of a mental health 18 facility for inmates and detainees with mental health needs in 19 the custody of the department of corrections and rehabilitation. 20 The sum appropriated shall be expended by the department of 21 health for the purposes of this Act.

1 SECTION 3. The appropriation made for the capital 2 improvement project authorized by this Act shall not lapse at 3 the end of the fiscal biennium for which the appropriation is 4 made; provided that all moneys from the appropriation 5 unencumbered as of June 30, 2028, shall lapse as of that date. 6 SECTION 4. This Act shall take effect on July 1, 2025. 7
