A BILL FOR AN ACT

RELATING TO SAFE NEIGHBORHOODS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that Waikiki's safe and
- 2 sound program has been effective at reducing crime in the
- 3 Waikiki area. Since implementing the program in September 2022,
- 4 Waikiki has experienced approximately forty-eight per cent fewer
- 5 drug and alcohol-related crimes, nineteen per cent fewer
- 6 robberies, thirty per cent fewer burglaries, and twenty-two per
- 7 cent fewer incidents of criminal property damage. The
- 8 legislature recognizes that Waikiki's safe and sound program has
- 9 achieved this reduction in crime, in part, by placing geographic
- 10 restrictions on habitual criminal offenders.
- 11 Accordingly, the purpose of this Act is to authorize
- 12 similar geographic restrictions for habitual criminal offenders
- in other parts of the State.
- 14 SECTION 2. Chapter 706, Hawaii Revised Statutes, is
- 15 amended by adding a new section to part II to be appropriately
- 16 designated and to read as follows:

1	"§706- Probationary geographic restrictions; Ewa Beach;
2	Kapolei; Waianae. (1) If a person has been convicted of a
3	misdemeanor, has had two prior misdemeanor convictions, and each
4	conviction was the result of an act that occurred within a
5	covered district, that person may be sentenced to a probationary
6	term of geographic restriction not to exceed years, during
7	which the person shall be prohibited, between the hours of
8	6:00 p.m. and 6:00 a.m., from entering the covered district in
9	which the acts occurred.
10	(2) Violation of an imposed geographic restriction shall
11	be a misdemeanor, and the person shall be sentenced to
12	imprisonment for thirty days.
13	(3) For purposes of this section:
14	"Covered district" means any one of the following areas:
15	(a) Ewa Beach;
16	(b) Kapolei; or
17	(c) Waianae.
18	"Ewa Beach" means the area of the island of Oahu that is
19	designated as postal code 96706 by the United States Postal
20	Service as of the effective date of this section.

Report Title:

Probation; Geographic Restriction; Misdemeanor Conviction; Ewa Beach; Kapolei; Waianae

Description:

Allows a person who has been convicted of 3 misdemeanors committed in Ewa Beach, Kapolei, or Waianae, to be sentenced to a term of geographic restriction during which the person is prohibited during certain hours from entering the specific area where the acts occurred. Mandates a sentence of imprisonment for 30 days for a violation of the geographic restriction.
